Thank you for your letter of 3 February 2006 requesting Home Office documents relating to the reasons for disbanding the Metropolitan Police War Crimes Unit in 1999. Your request has been handled in accordance with the terms of the Freedom of Information Act 2000.

After having carefully considered your request and examined records for the period you suggested between 1 January 1998 and 31 December 1999, the information you requested is enclosed.

I should explain that the decision to disband the Unit was an operational decision for the Commissioner of the Metropolitan Police and that responsibility for this area of work was passed to another unit within the Metropolitan Police. Similarly the conclusions reached by the Unit were operational matters for the Commissioner and, where files were submitted for consideration of prosecution, the Crown Prosecution Service. Home Office Ministers have no role in these matters.

If you are dissatisfied with this response, you may request an independent internal review of our handling of your request by submitting your complaint to:

Lines to take

 Anthony Sawoniuk was recently prosecuted and convicted under the War Crimes Act. He has been sentenced to life imprisonment and there is an appeal pending.

In April 1996 Szymon Serafinowicz was committed for trial from to the Central
Criminal Court on allegations of the murder of Jewish civilians in Belarus. In January
1997 a jury at the Central Criminal Court found the defendant unfit to stand trial.
Subsequently the Attorney General entered a Nolle Prosequi due to the defendant's
failing mental health. Mr Serafinowicz has since died.
