# Chapter 4

## Making assessments better for the future



This chapter tells you our ideas to make our **assessments** and services better for the future.



**Assessments** are when you ask questions and get information about a subject so you can make a decision about it.



We worked with disabled people and people with health conditions, health workers, charities and **academics** to make our ideas.



**Academics** are people from universities who know a lot about a subject.



## Why changes need to be made

We know people want more **flexible** assessments.



**Flexible** means assessments that are not fixed and can think about what each person needs.



We know some people don't trust the decisions we make about their assessments for **Employment and Support Allowance** (called **ESA** for short) and **Personal Independence Payments** (called **PIP** for short).



We know that 20% of people in the ESA Support Group or who get the **limited capability for work and work related activity** (called **LCWRA** for short) part of **Universal Credit** (called **UC** for short) would like to work in the future.



We want to make assessments better so people trust our decisions and don't want to **appeal** them.



An **appeal** is when you officially say you don't agree with a decision.



## Our ideas

We have made a list of ideas about how we want to make our assessments better for the future.



We want


- to show people how we do our assessments so they can trust our decisions.
- to give a good service that is right for everyone.
- our services to support people to be able to work.
- our services to support people to live equal and independent lives.



## Activities and descriptors



When you have an assessment we ask you questions about some activities to find out if you can do them with or without help.



**Descriptors** are a list of actions connected to each activity.

You have told us some of the activities and descriptors we use in **WCA** and PIP assessments aren't fair to people who have some types of disability or health condition.



**WCA** is the assessment we do to find out if a person can never work, cannot work now but could in the future, or is ready to work now. This decides if they can get ESA or the LCW or LCWRA parts of UC.



We want to make sure our assessments are easy to understand but fair to everyone.



## Functional assessments

You have told us functional assessments don't let you say how your disability or health condition affects your life and your chance of finding work every day.




## Repeat assessments

We know the way a disability or a health condition affects you can change over time.



You have told us repeat assessments make you feel worried. We want to think about a new way to check if people are getting the right benefits.



## Health information

We want to make sure we have the right health information about you when we make our decisions.



We want to make sure we get the right health information from the right people at the right time for each decision we make.



## Assessors

**Assessors** are people who do assessments.



You have told us you want our assessors to have special training about your health conditions.



Our assessors can't know about all health conditions.



We want to find ways to give our assessors extra support when they make decisions, like asking health workers to help them.



## Work and health experts

An **expert** is a person who has very good knowledge about a subject.



We want to have **work and health experts** who help people get ready to be able to work.



Our work and health experts would be health workers who have good knowledge about employment.



Our work and health experts would help people find good ways to manage their health conditions.



When you answer the questions about this chapter think about these things




- What is the best way to give benefits to people who have a health condition that changes a lot.
