

Designs form DF2B – Fee guidance notes

Before you complete this form, check what you need to pay.

You must choose which design you want to keep on your original application. Any remaining designs will need to be separated into individual applications. You will need to pay £60 for the first new design application and £40 for any additional new applications.

For example, if you applied for four designs on your original application, and you want all four to proceed, this will be divided into three new design applications. The remaining design will continue as part of the original application. You will therefore pay £140. The below is an example of the fee structure.
