#### PROVISION OF REQUESTED INFORMATION

Thank you for your request for information regarding culling and disposal of infected birds which we received on 2 March 2021. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"I seek the below information as held by APHA relating to the culling / disposal of birds infected with avian flu from December 2020 to now.

how many birds were culled, what types and how were they culled was the culling humane in all cases?:

What types of humane killing was carried out."

Animal and Plant Health Agency (APHA) can confirm the following in response to each of your questions:-

# How many birds were culled from December 2020 to now as part of the avian influenza response?

 165,048 birds were culled from December 1st 2020 to date as part of the response to the avian influenza outbreak.

### What types of birds were culled?

- Birds of prey
- Chickens
- Ducks
- Geese
- Partridges
- Pheasants
- Swans
- Turkeys

## How were they culled?

- Non penetrative percussive blow (via a Cash Poultry Killer)
- Cervical dislocation
- Containerised Gassing Units (CGU)
- Free bullet
- Lethal injection

## Was the culling humane?

- Yes. All of the culling methods used are compliant with the requirements set out in the Welfare at Time of Killing regulations. APHA appoint an APHA Welfare Vet to monitor APHA staff and contractors undertaking the culling activity. Legislation requires that a secondary culling method is available should there be any issues/problems with the first chosen method.
