RA 1026 – Amendments made to the Rationale to avoid ambiguity and therefore confusion within the RC when it comes to determining when an Aerodrome Operator is required. Rationale

also amended to reflect the importance of the effective management of a DAM and DAAF in order to provide assurance of a SOE. Amendments to 'Tier 3' classification throughout RA to ensure it aligns better with RA 1010. These amendments address a number of RFCs.
