HS2 INDEPENDENT DESIGN PANEL



Lower Thorpe Viaduct

Lower Thorpe Viaduct will be located within the hamlet of Lower Thorpe, Northamptonshire, in a narrow valley close to several properties and heritage assets, and a series of historic ponds.

In previous discussions with HS2 Ltd, the Design Panel has highlighted its support for the low key design approach, driven by the landscape context, and drawn attention to the potential to create more visual and ecological connections by opening up the area under the structure.

In April 2021, the panel met with HS2 Ltd to understand the progress made since the previous meeting (2018) and to comment on the Schedule 17 stage designs, which will be submitted to West Northamptonshire Council in Summer 2021. The panel congratulated the team on the progress made and commented that the proposals are an exemplar of simple, recessive but confident design, supported by a clear and compelling landscape design narrative.

It stressed that the landscape proposals will play a crucial role in the overall success of the viaduct. It is important that they incorporate a compelling design narrative both in relation to water management, and the viaduct's response to its historical setting. Detailed design will also prove crucial in ensuring the high quality of the proposals is maintained throughout construction and delivery.

The panel noted areas for further development, including refinements to the noise barriers and piers, defining the impact on adjacent properties, and finding opportunities to engage with the local community in a meaningful way.

Landscape Design Approach

The HS2 Landscape Design Approach (LDA) was first published in 2016. Since then, the HS2 programme has moved on considerably, and lessons have been learned from the project to date. Phase 2a also received Royal Assent in early 2021, and new government policies and guidelines have been released.

HS2 Ltd is now revisiting the LDA to capture these changes and to ensure it can guide future design work. In April and May, the panel held a series of workshop and mentoring sessions with the team. The panel welcomed the update, and stressed the importance of embracing the opportunity to increase levels of ambition in the document. It encouraged the team to move beyond current and emerging legislation to set exemplar standards, including embracing a net biodiversity gain approach.

The panel also supported the use of the LDA to reinforce expectations that design will be landscape-led, including the role landscape should play in future procurement processes and in the onboarding of the HS2 supply chain.

The panel highlighted the need for a comprehensive and powerful communications strategy to ensure the LDA messages become part of HS2 Ltd culture, understood at all levels of the organisation. The document provides an important opportunity to celebrate HS2's positive impact.
