HS2 INDEPENDENT **DESIGN PANEL**



Old Oak Common Station: public realm

The Old Oak Common Station Design Panel met in late July to discuss the public realm designs for Old Oak Common Station, and were impressed with what they saw. The meeting took place before a Schedule 17 submission is made to Old Oak and Park Royal Development Corporation (OPDC), expected to be in autumn 2021.

The Balfour Beatty, Vinci and Systra design team presented designs that have been in development since summer 2019, when the panel gave its support to the Schedule 17 designs for Old Oak Common Station. The public realm at this station will be perhaps the most significant space on the entire HS2 Phase One route, the size of three Trafalgar Squares. As well as forming a station

approach for passengers, expected to be among the busiest in the country, it will also provide a valuable new facility for local people.

The Panel congratulated the design team on ambitious, detailed and exciting response to a complex site. It particularly enjoyed the Wetland Common landscape concept, which gives the landscaping both character and environmental value. The panel was also pleased the design approach is flexible, to allow it to respond when the adjacent site development comes forward.

Work will continue with OPDC to develop designs for aspects such as headhouses in the public realm, and the panel emphasised the importance of a long-term management and maintenance strategy. The quality of the public realm designs show the value of taking the time to design exceptional public spaces, that can deliver the ambition of the HS2 Design Vision.

Integrating Rail Systems

HS2 Ltd will begin procuring railway systems contractors over the course of the coming year. In anticipation of this, it is producing a 'Rail Systems Design Approach' document to help brief contractor teams and HS2 Ltd staff. The intention is that it will help guide the design approach that contractors are required to adopt.

At a meeting in July, the panel welcomed the work completed to date. The document presents an opportunity to drive a forward-thinking, high quality, and potentially even celebratory, approach to rail systems. To achieve this, the HS2 Design Vision should be at the heart of decision making, embracing the message that "everything we create is designed" (HS2 Design Vision, 2017). This will be essential to ensuring HS2 can go beyond standard practice and drive a step change in the industry, becoming an exemplar.

The panel suggested that the document should prescribe an approach to contractors, including showing how to define design priorities, reinforcing the need for a multi-disciplinary approach, and setting expectations for collaboration and integration with other parts of HS2. This will be essential to delivering the design quality expectations for HS2.

Learning from other HS2 documents and processes, for example procurement strategies, could also help provide valuable insights to address current challenges, and ensure the Rail Systems Design Approach can influence decision making.
