UK Timber Regulations Monitoring Organisations

The Regulation provides for 'Monitoring Organisations' to be recognised by the Competent Authority. These organisations, which are private entities, provide GB operators with operational due diligence systems. Operators can thus develop their own system or use one developed by a monitoring organisation.

To become a Monitoring Organisation, candidates must send their application to the following e-mail address: monitoring.organisations@defra.gov.uk
