



Enforcement Action taken in the period: 1 April 2021 to 30 September 2021

The Office for Product Safety and Standards (OPSS) is part of the Department for Business, Energy & Industrial Strategy and exercises the powers of the Secretary of State in relation to a range of regulations. Our approach to dealing with non-compliance by those we regulate and resolving potential product safety issues is set out in our [Enforcement Policy](#), which also sets out our approach to publishing details of our enforcement actions. Where enforcement action is taken in relation to an individual, details of the individual are anonymised.

The enforcement actions listed below were taken by OPSS in 2021. Actions are grouped under the following headings: Heat Networks, Product Safety, and Timber.

The local authority, as a heat supplier, notified OPSS in 2015 of 80 heat networks operated by the local authority. An updated notification of the networks was due in 2019 and was not submitted.

Action taken:

Forfeiture and destruction order sought by OPSS and made by Uxbridge Magistrates Court on 4 May 2021, under Section 16 of the Consumer Protection Act 1987.

Product:

Hair straighteners, manufactured by Guangzhou Zhongpai Electronics Co Ltd, China

Breached regulation details:

Failed to meet safety provisions of the Electrical Equipment (Safety) Regulations 2016.

Detail:

A consignment of hair straighteners entering the UK through London Heathrow Airport was detained in relation to breaches of the Electrical Equipment (Safety) Regulations 2016. Attempts to contact an importer or exporter of the goods were unsuccessful.

Evidence was given in court that the importer did not take responsibility for the safety of the products, did not undertake necessary safety checks, and failed to provide consumers with appropriate contact details.

The product poses a serious risk of choking to young children as the supplied coin batteries are freely accessible, and the zip pull was easily detached during testing. The electrical wires are considered to pose a risk of strangulation. The product and packaging are missing required labelling and safety instructions.
