Thank you for your letter dated 18<sup>th</sup> January 2022 inviting the Authority to respond to the proposed intervention. I also thank you for the formal recognition of the hard work of the council to date to move our organisation forward.

We are passionate about improving Sandwell Council so that we can continue to deliver positive outcomes for our communities. Whilst we are disappointed with the direction that DLUHC is considering regarding intervention, we welcome the support from your department to aid us on our improvement journey.

The council has already developed an Improvement Plan in response to the Grant Thornton Governance Review, and we are making progress on these actions that build on the 'green shoots' identified by that review. Both the recently received CIPFA Financial Management Review Report and the LGA Corporate Peer Challenge conducted in early February 2022 have recognised that the steps we have recently taken are already demonstrating our ability to move forward, and both have also set out further recommendations to guide our improvement journey.

The next stage of our improvement journey is to bring together the actions to address the findings of these three reviews into one overarching Improvement Plan for the council. This single, comprehensive Improvement Plan will clearly set out our aims aligned to the priorities in our Corporate Plan and enable us to measure our direction of travel.
