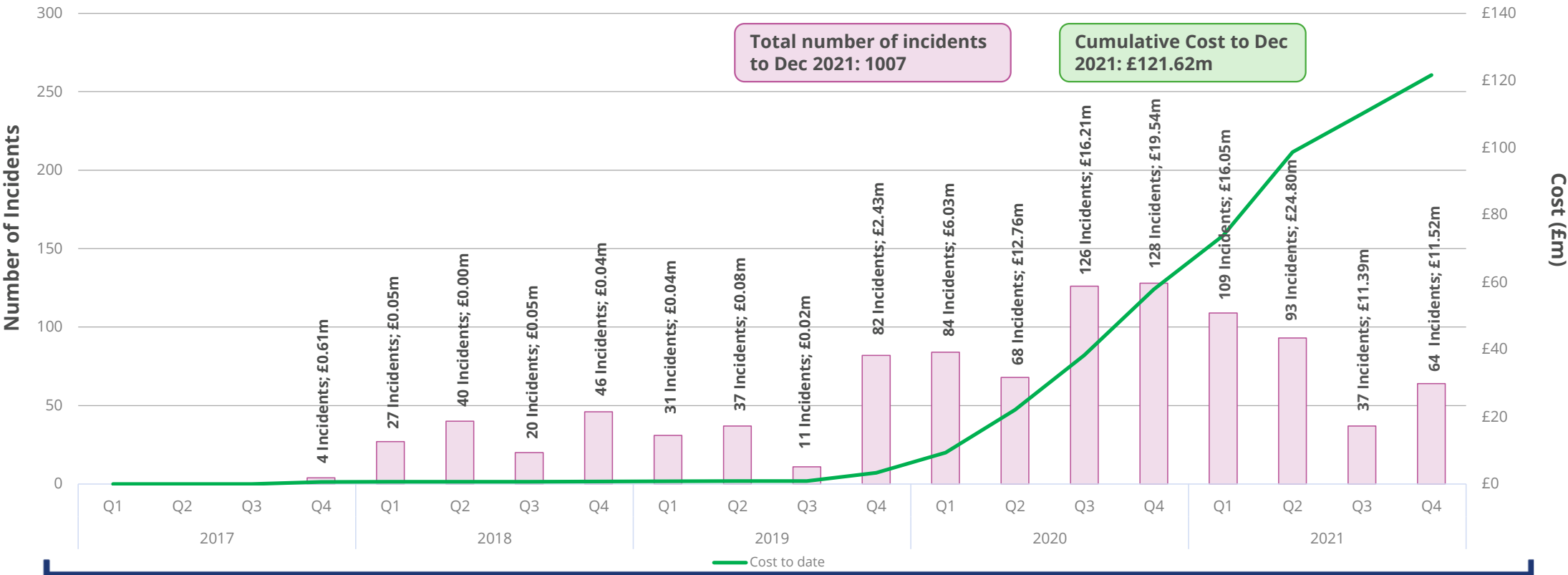


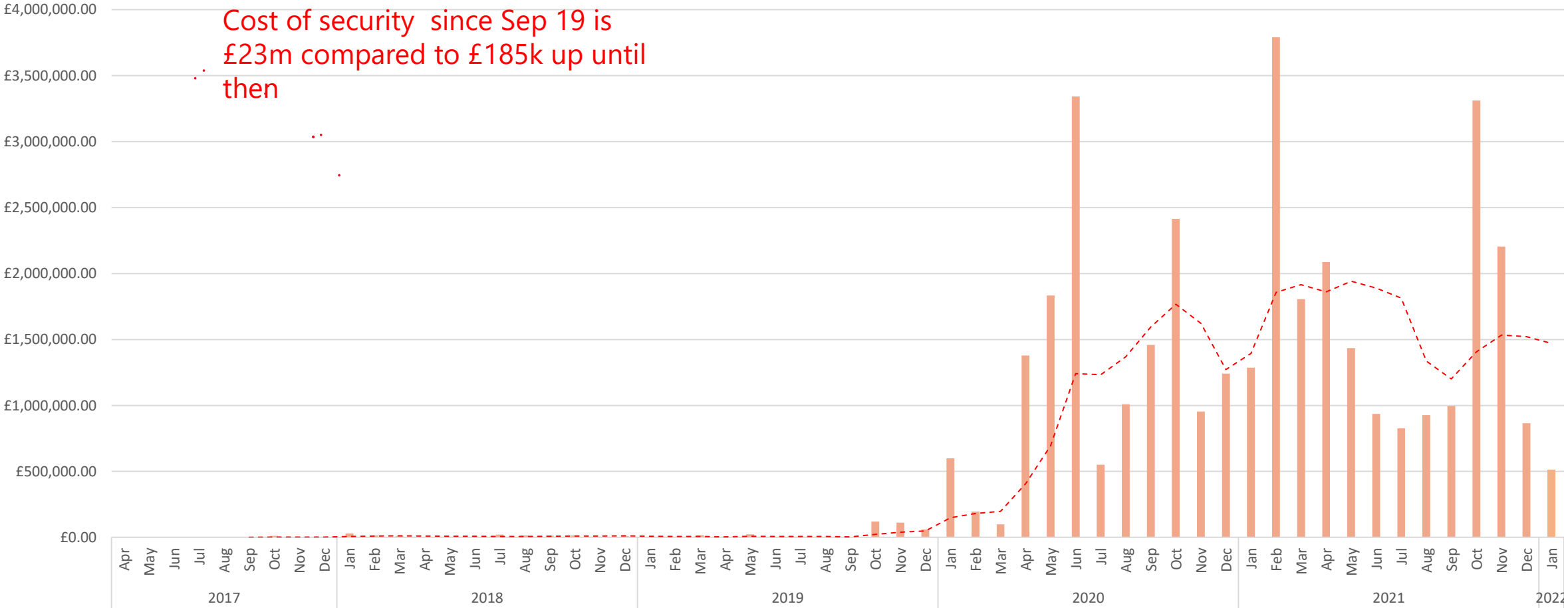
# HS2 Phase One Protestor Activity

**Note:** All costs are current prices at time of impact. Within the Costs to Dec 2021, 72% are actuals and 28% are forecast.

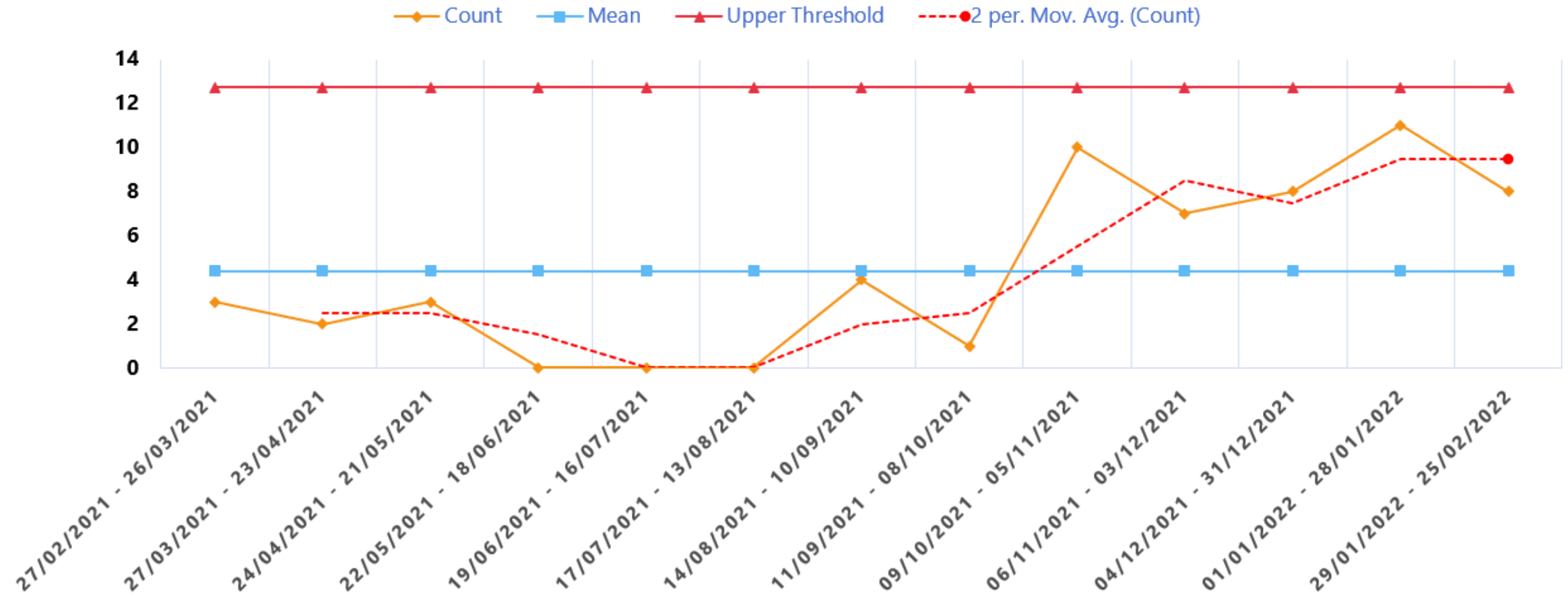

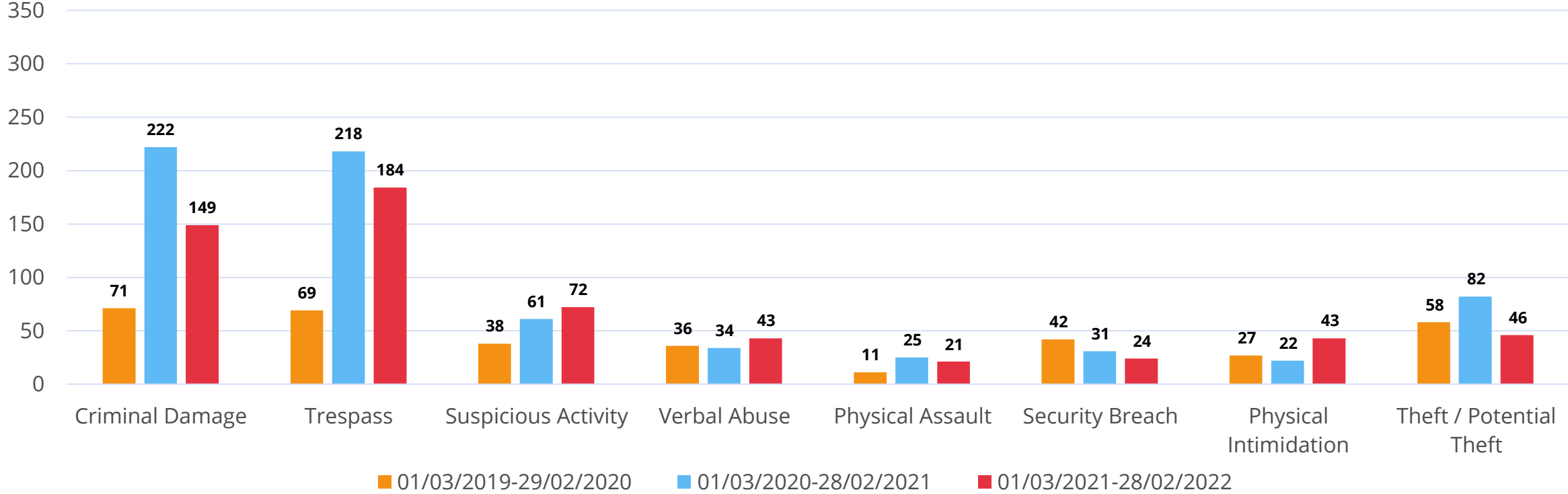
Threshold Chart Showing Incidents in the Current 28-Day Period Compared to the Previous 12 Periods



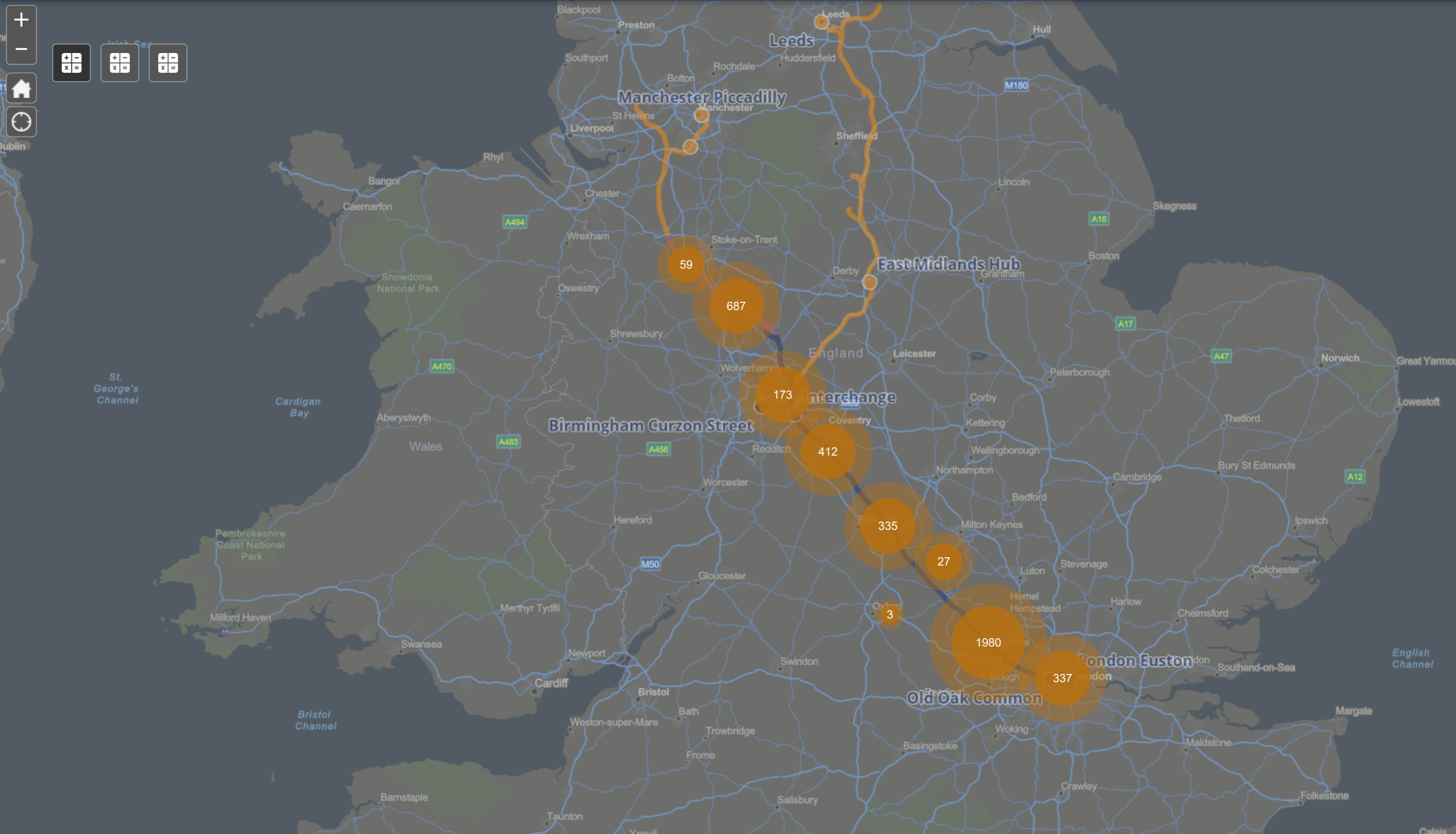
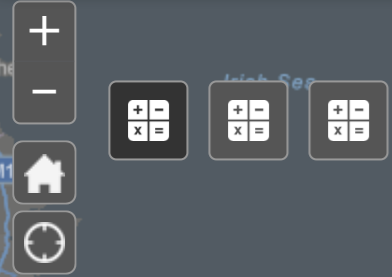
# Escalation of Violence and Crime

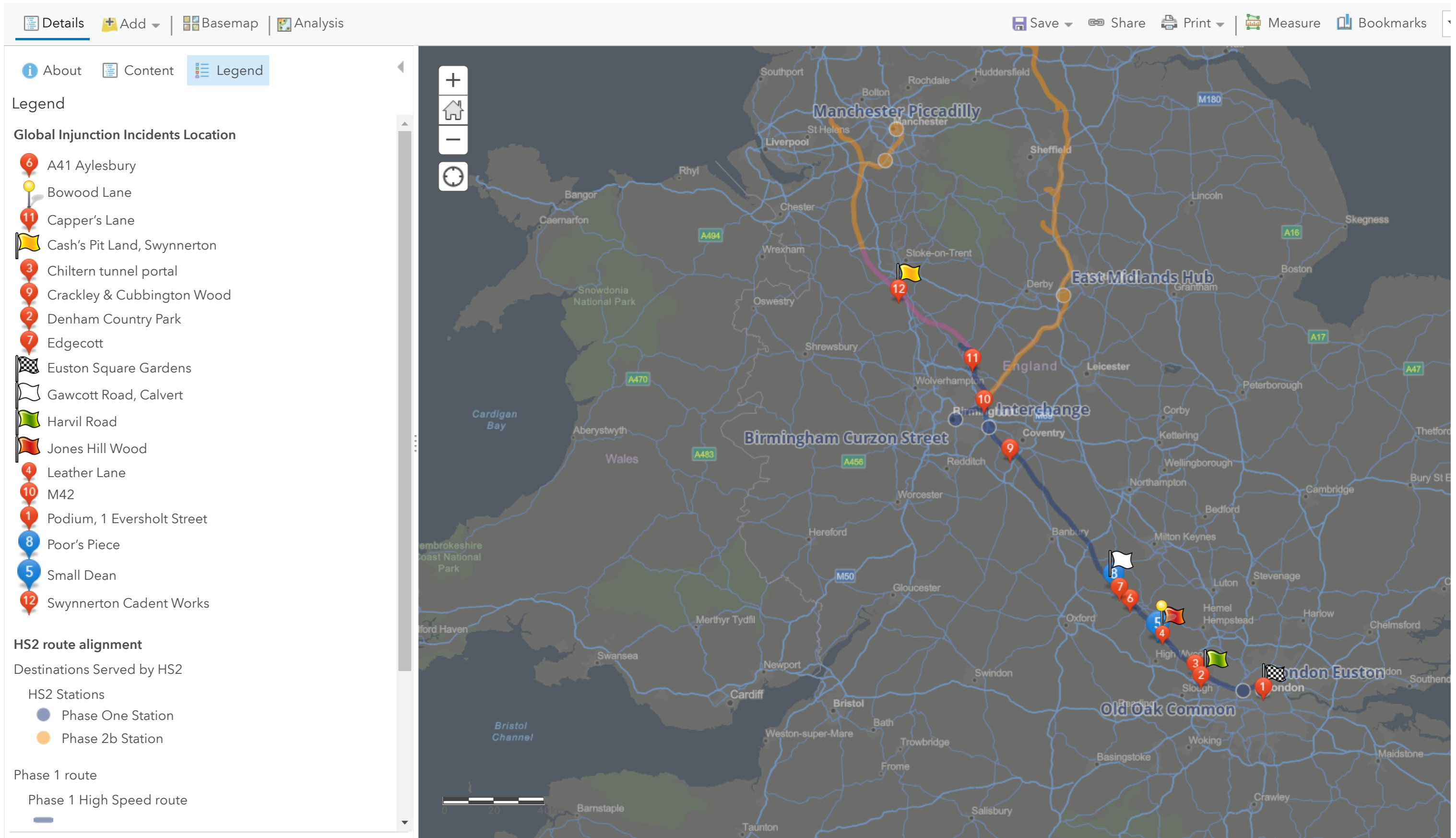

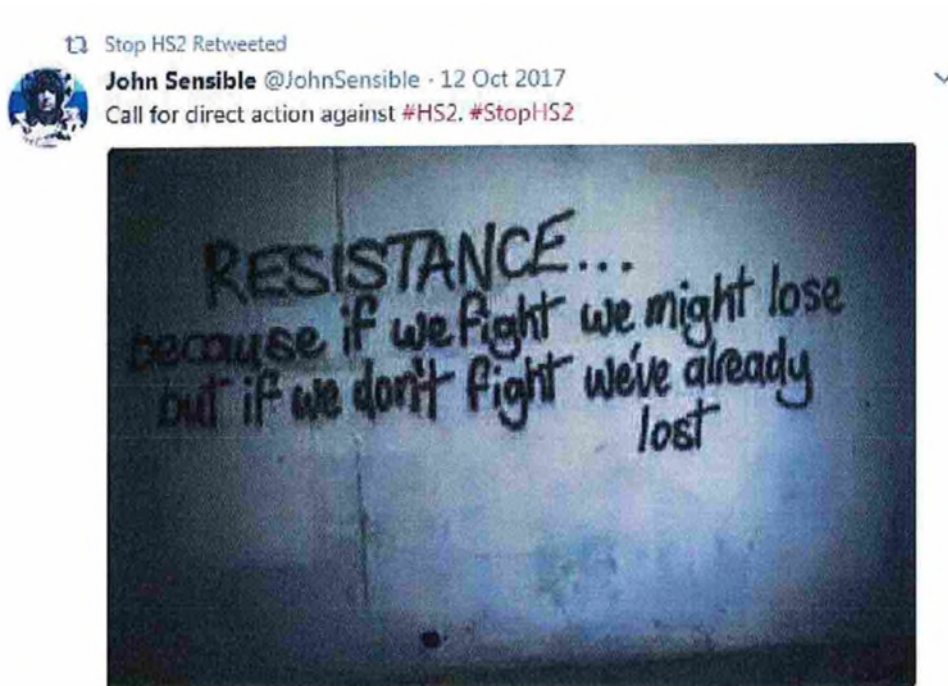



## HS2 tunnel protest will be first of many, says activist

**Lazer Sandford says subterranean tactics are likely to feature in new wave of climate emergency protests**

An environmental activist who spent 12 days in a tunnel network underneath Euston Square Gardens in central **London** says the protest is likely to be the first of a new wave against the climate emergency using subterranean tactics.

Speaking exclusively to the Guardian in his first interview since leaving the tunnel network on 6 February, Lachlan Sandford, 20, known as Lazer, said the protest to raise awareness about the environmental destruction that activists believe the high-speed rail link **HS2** will cause would not be a one-off.

He highlighted the construction of a second, smaller **tunnel** at Highbury Corner, also in central London, from where protesters were evicted after a few hours.



Phase 2a of HS2 connecting the West Midlands and Crewe received **royal assent** in parliament on 11 February.

Sandford's actions in the tunnel hit the headlines after he was locked to a complex steel and concrete device, which activists underground referred to as "a concrete cake". It consisted of a metal safe encased in concrete, with more concrete inside, and Sandford locked to an "arm tube". He also had a lock on his ankle.

"It was an incredibly uncomfortable and painful thing to endure," he said. "But nothing like the pain and discomfort that the climate and ecological emergency is bringing and other people around the world are already feeling."

There are seven of the original nine activists left in the tunnel, including Sandford's sister Blue Sandford, 18, Dan Hooper, known as Swampy, 47, and Swampy's 16-year-old son, Rory.

The plan was for Sandford to be the first to leave, but a 17-year-old activist left the tunnel the evening before because she was feeling unwell.

"That was my job from the start, to be the person holding the down shaft and protecting the entrance to the tunnels at the bottom. We were thinking it would only take them three days to get to me but actually it took them 11," he said.

As supporters followed news updates on the lengthy process of removing Sandford from the "lock on" - he was locked on for 30 hours and it took the bailiffs 25 hours to extract him from it - they expected the bailiffs to bring him up from the tunnel.

However, he **grabbed the lock-on** after he was released and ran back into the tunnel, evading capture by the bailiffs.

He said the decision to do that was not premeditated. "That was spur of the moment," he said. "I escaped back into the tunnels for a rest. I was pleased I got a chance to say goodbye to Blue and the others properly."

He said he negotiated lights and other essentials for the tunnellers before leaving the tunnel voluntarily. HS2 says it provided lights but not other essentials.

The time Sandford spent in the tunnel is far from his first brush with activism. His father, Roc Sandford, is a Scottish laird who lives off grid on the small Hebridean island of Gometra, pursuing a carbon-neutral way of life. He has also been active in XR Youth.

“With my sister Blue and others, we **chained ourselves** across the entrance to a fracking conference a couple of years ago,” said Sandford. “I think it was hard for Blue to lose me from the tunnel community. I love them all dearly and I’m looking forward to when I see them again.

“The HS2 bailiffs are hardcore. They are being fairly heavy with us and it’s pretty extreme, but nothing like what is coming if we don’t get our voices heard. People of my age are not being given a choice because the government isn’t doing what’s needed and that’s when I started protesting more. We need to figure out how to get more MPs to back the climate and ecological emergency bill, there’s about 100 so far, so get on to your MP, and get them to scrap HS2 as well.”

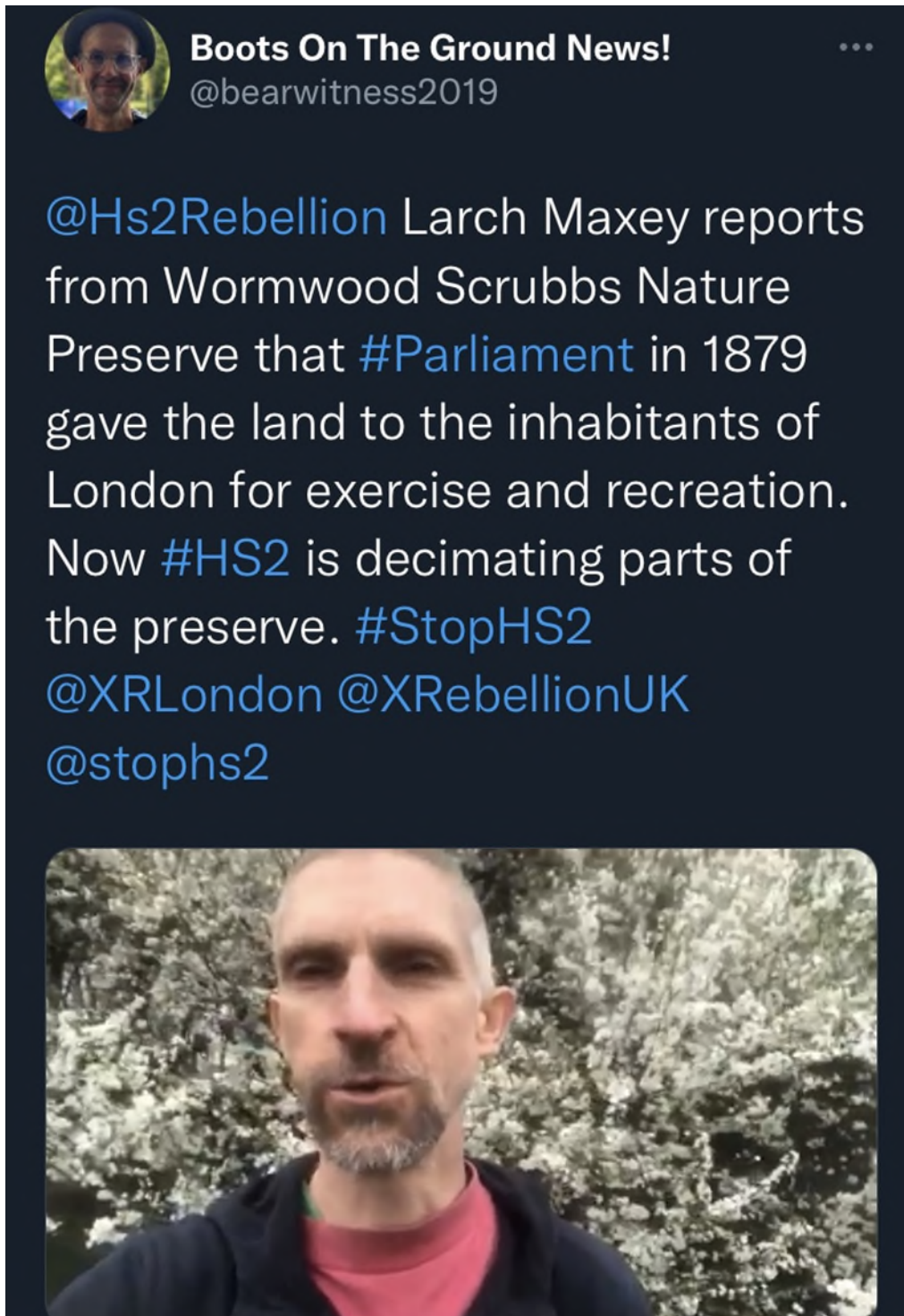
Roc Sandford said of his two children involved in the tunnel protest: “I’m so proud of them, they are standing up for what they believe in. But they shouldn’t have to, it’s too much for young shoulders like theirs to carry. We all need to help them.”

One of the first things Sandford did after leaving the tunnel was get some falafel from his favourite place in west London. But the rigours of life underground have not deterred him from environmental activism.

“I can’t divulge any of my future plans for tactical reasons, but I’m nowhere near finished with protesting,” he said.

HS2 line and safeguarded area for phase 1 and 2a drawn over OS maps.

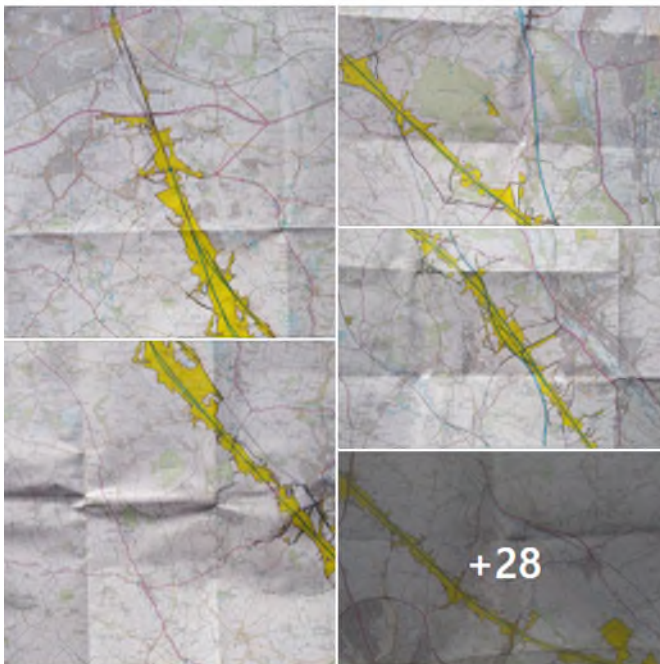
This gives you a good idea of where HS2 are working (and how much land they are taking) whether that be for the actual track, tunnels, gas, electric, water and other utility works as well as for 'mitigation'.

Some maps overlap but I have explained which OS map each photo is of and where tunnels and major depots/stations are as well as locations of camps so that people can get their bearings. I have numbered the maps from London going north up the line (OS 192 1, 2, 3 etc)

Sometimes the blue line goes a bit wobbly (I may have had a drink while doing some of them) so trust the outlined yellow. This does not include all the areas HS2 are working or have compounds but gives a good starting point. Red line means tunnel.

Translated from HS2's safeguarding maps pages that are annoyingly chopped up and monotone so have these.

# HS2: Swampy says protesters' tunnelling can halt project

**Veteran eco-protester Swampy has said activists' tunnelling tactics can halt the HS2 high-speed railway project.**

Swampy, whose real name is Dan Hooper, was one of the **last two protesters to be evicted** on Saturday from the Wendover Active Resistance (WAR) camp.

After 28 days underground, he said "we can stop it with this tactic" and halt the multi-billion pound scheme.

HS2 Ltd urged "anyone who cares about the environment to support [its] project".

The rail line is due to run between London, Birmingham, Manchester and Leeds and **work has started on phase one** from London to Birmingham.

The **current estimated cost of completing** the entire project is between £72bn and £98bn.

Swampy was among protesters who had charges against them dropped recently after they **occupied tunnels near Euston Station in London**.

He had joined protesters digging a tunnel at the WAR camp in Buckinghamshire - between the A413 and the local Chiltern railway line south of Wendover - where eviction began five weeks ago.

The activist told the BBC: "If we look back to the 90s, we stopped the road-building programme [using] tactics like tunnelling, in fact that probably was the [thing] that broke the camel's back.

"So we can stop it with this tactic which will save the country billions of pounds... they just have to reverse it.

"It's hugely unpopular with deforestation on a massive scale.

"This project is pumping millions of tonnes of carbon into the atmosphere so this is a greenwash and it needs to be stopped."

## HS2 'cleaner, greener'

HS2 Ltd, which was set up by the government to build the line, has said it will be one of the most environmentally responsible infrastructure projects ever delivered in the UK.

A spokeswoman said: "By providing a cleaner, greener way to travel, HS2 will help cut the number of cars and lorries on our roads, cut demand for domestic flights, and help the country's push to reduce carbon emissions.

"Instead of wasting their time and public money on often violent and disruptive protest, we would urge anyone who cares about the environment to support this project."

Swampy said he "hopes more tunnels will happen on the route" and has not yet ruled out taking part in future protests.

"It's too soon after this one to be able to say whether I will be there," he said.

A year ago today, at 4:30am, the NATIONAL EVICTION TEAM moved in on the stop HS2 Euston camp. A year ago today the eviction of many peoples home began. While many occupied the beautiful trees of the park and others occupied the structure we called "Buckingham palettes", 9 of us occupied a network of hand dug tunnels below the gardens.

The eviction lasted 31 days, everyday with those supporting us just a few meters away outside of the fence. It became even more clear just how loved and necessary Euston Square gardens really was to the community. The green space had acted as a safe haven for so many, particularly through the pandemic. The gardens allowed for many homeless and no fixed abode people to be safe and secure within the walls of the park. It meant that vulnerable people in the area always had a space to go to.

Now, one year on, although the camp dismantled and the gardens fenced off from the public, HS2 are yet to make use of this land. They seized one of the only green spaces in the area and they disregarded local, working class voices that screamed against HS2. Instead of listening to the people, they chose to rob a community for their hellish vanity project.

Throughout the eviction, the police harassed, arrested and fined so many outside of the gates. Yet failed to acknowledge that they had chose to evict a home during a global pandemic. The very notion of seizing community land and evicting one from their home is violent.

HS2 is a classist project that is only upheld because of minimum wage workers. HS2 is a classist project that has thieved far more from working class people than many could even comprehend.

Resist HS2, smash classism in the face.

# Birmingham factory protest: Pair held after premises damaged

15 June



The pair were arrested after a 34-hour rooftop protest

**Two people have been arrested after protesters scaled an aluminium products factory in a demonstration lasting more than 30 hours.**

Police said damage totalling thousands of pounds had been done to the Arconic factory in Birmingham.

Protest group Palestine Action claims the firm's products are used in the manufacture of Israeli military jets, but Arconic has not commented.

A man and woman were arrested by specialist officers at about 15:30 BST.

The West Midlands force said a sledgehammer and golf clubs were used to smash windows and skylights and paint was thrown across offices.

Arconic produces aluminium sheet for the aerospace and automotive industries, and **also made the Grenfell Tower cladding.**

The BBC has approached it for comment.

A 26-year-old woman, from Burton-upon-Trent, and a man, who has not provided police with any personal details, were arrested on suspicion of criminal damage, aggravated trespass and a public order offence.

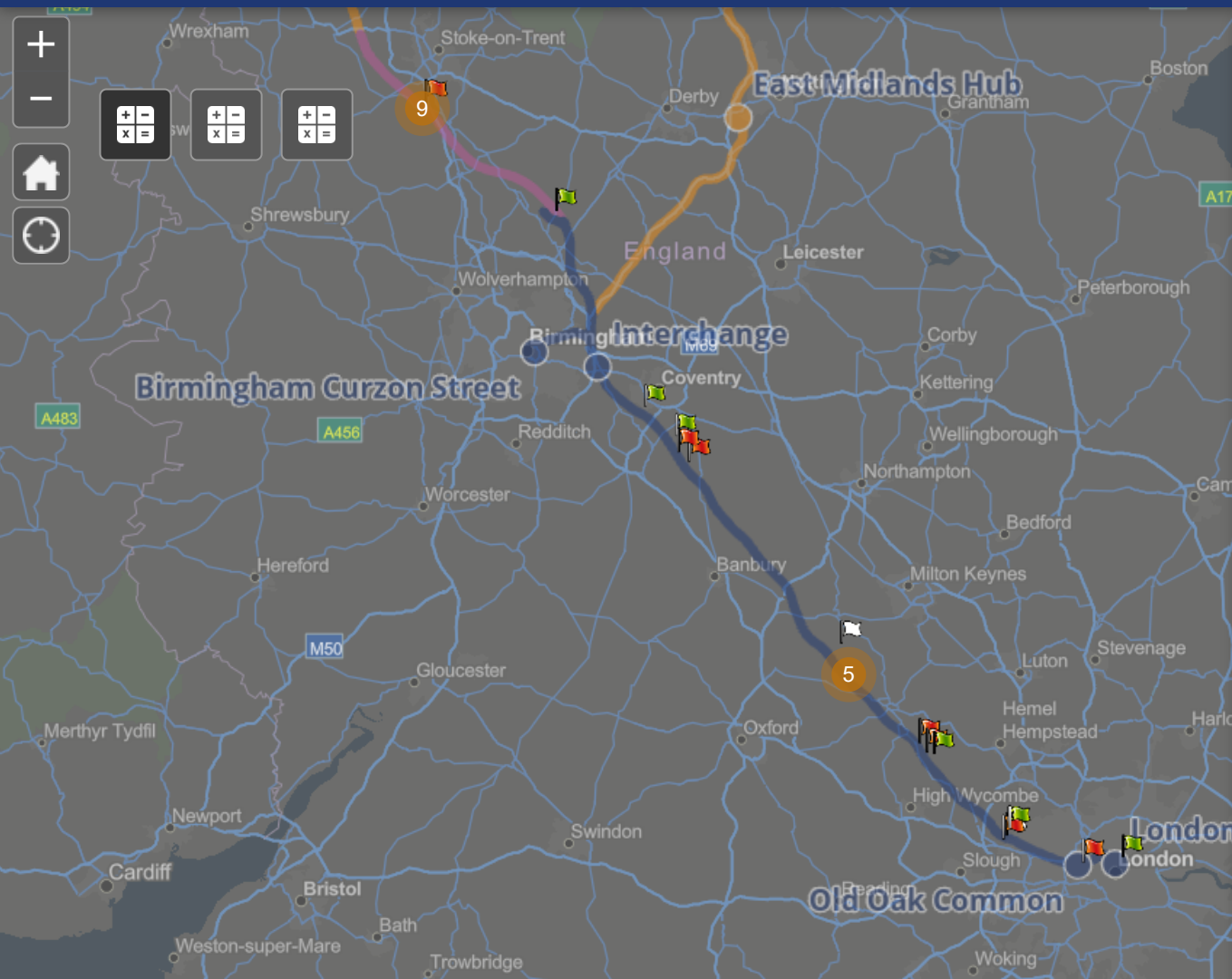
Protesters are thought to have gained access to the Kitts Green Road factory at 05:00 BST on Monday.

The force deployed a specialist police protest removal team, which is specially trained to work at heights, to detain them.

Earlier, police charged a 22-year-old woman from Bury, Greater Manchester, with aggravated trespass.

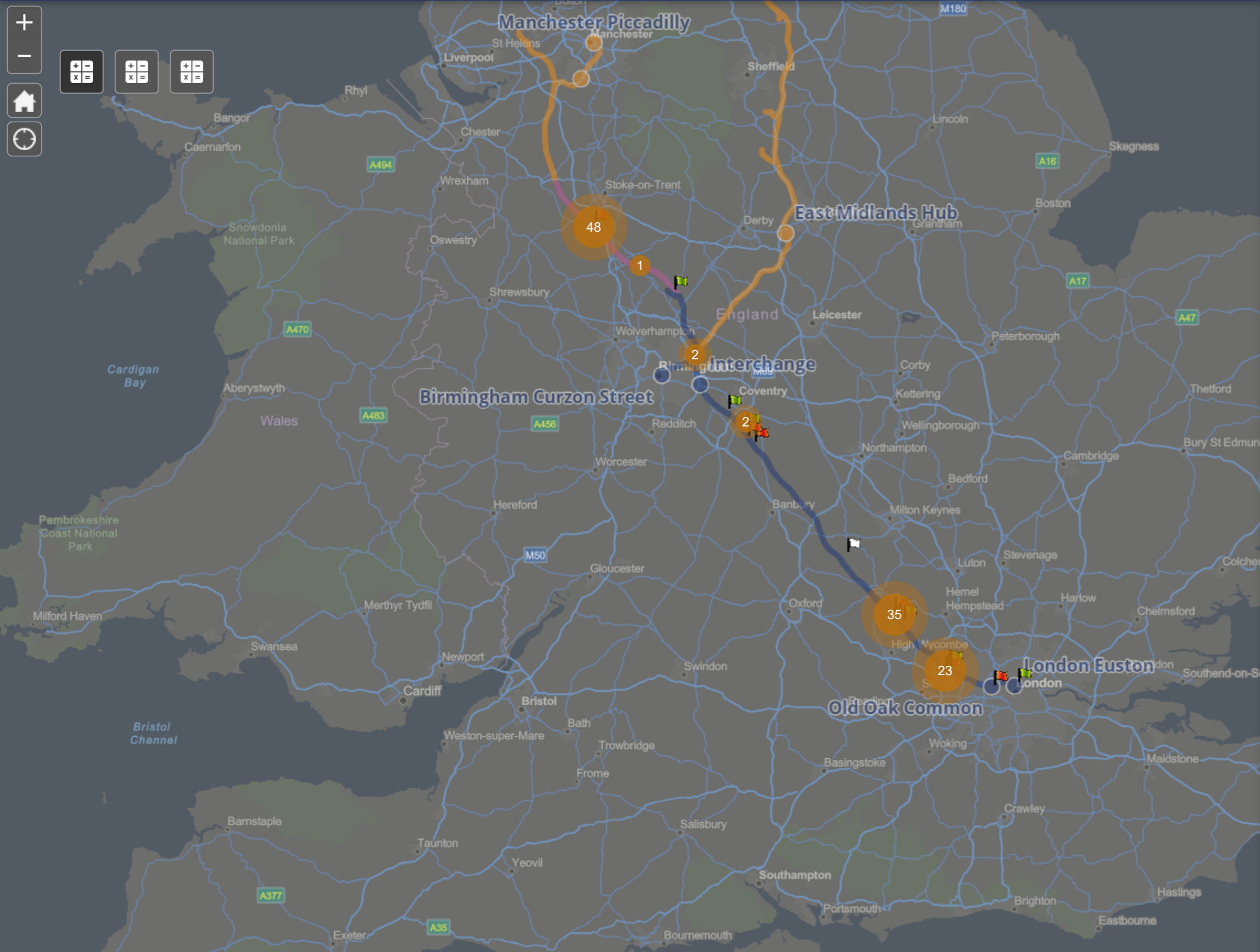

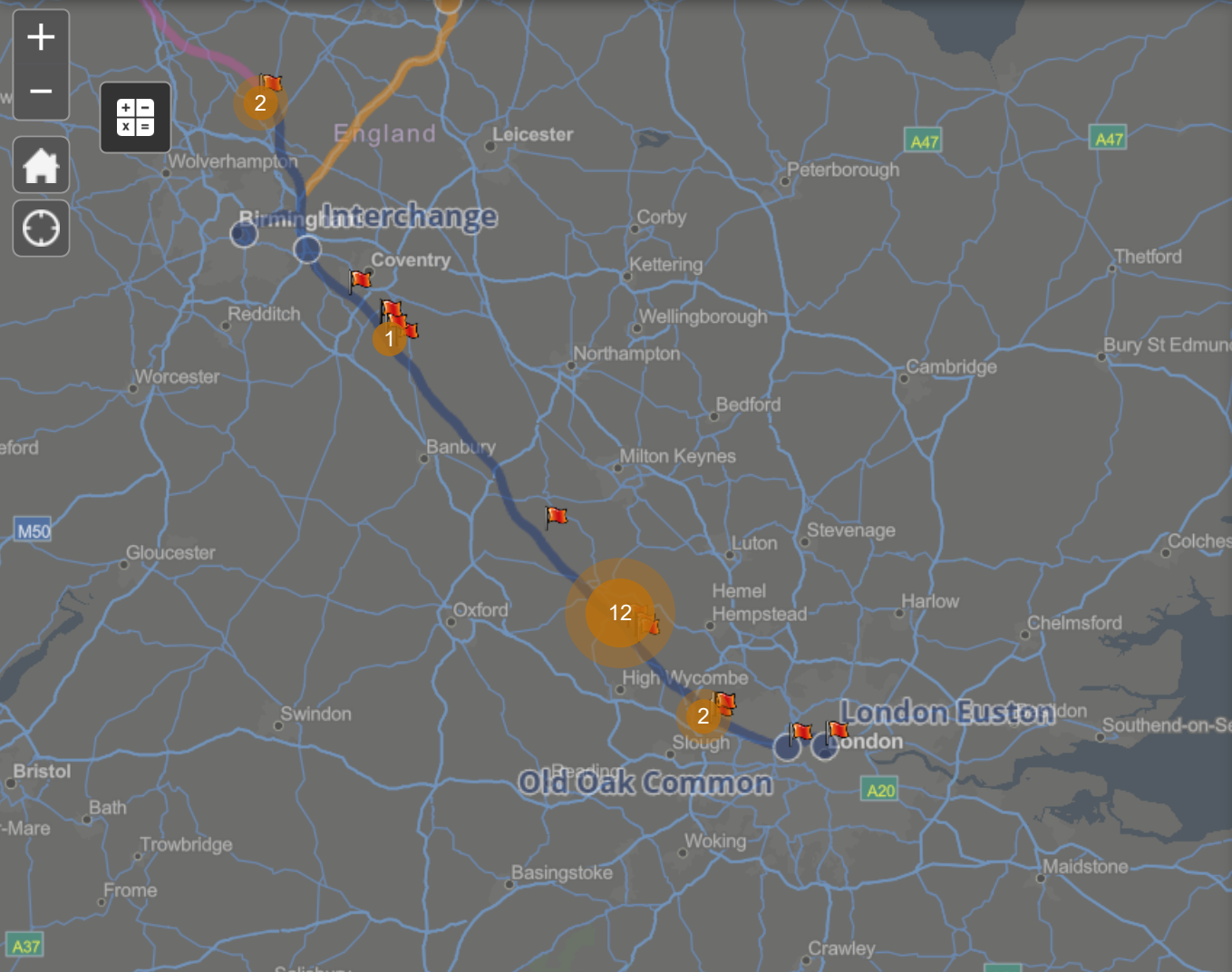

Plant machinery, Heras fencing and HS2 property were all vandalised. Photographs showing some of the damage are below.







Police and bailiffs have been attempting to evict protesters at an anti-HS2 camp in a Buckinghamshire woodland.

Bailiffs arrived at the camp, in Poors Piece Wood near Steeple Claydon in [Aylesbury](#) Vale, at around 6am on Tuesday morning - according to HS2 Rebellion, a group opposed to the high speed railway scheme.

Protesters were in tree houses in the ancient woodland - which they are trying to protect - with police officers using cherry pickers and workers erecting a fence.

HS2 Rebellion said [Lachlan "Lazer" Sandford](#), who recently spent 11 days underground protesting against HS2 at [Euston Square Garden](#) in London, was at the site.

In a statement from the tree tops, he said: "I was in the down-shaft of the Euston tunnel HS2 protest for 11 days before [HS2 bailiffs removed me from a lock-on](#). I'm now in a treehouse at Poors Piece because of the devastation being caused to this planet and the breakdown of its climate and nature." 

"Bailiffs and police are surrounding the tree I'm in but I'll stay up here until the Climate and Ecological Emergency Bill is passed by parliament, HS2 is scrapped or they forcibly remove me.

"This is the only thing I can do to protect the people I love and give them a future to grow up into. I will go on until we win. Will you help me?"

In a previous statement following accusations from [Sian Berry](#) of the Green Party that HS2 had 'got out of hand' HS2 defended the project's impact.

Responding to that, the company said: "43 of Britain's 52,000 ancient woodlands will be affected by the HS2 route between London and Crewe, with 80 per cent of the total area of these woodlands remaining intact and untouched by HS2.

"HS2 journey will emit 17 times less carbon than the equivalent domestic flight and 7 times less than a car journey. HS2's Phase One construction and operation carbon footprint, over 120 years, will emit less carbon than the road network does in one month."

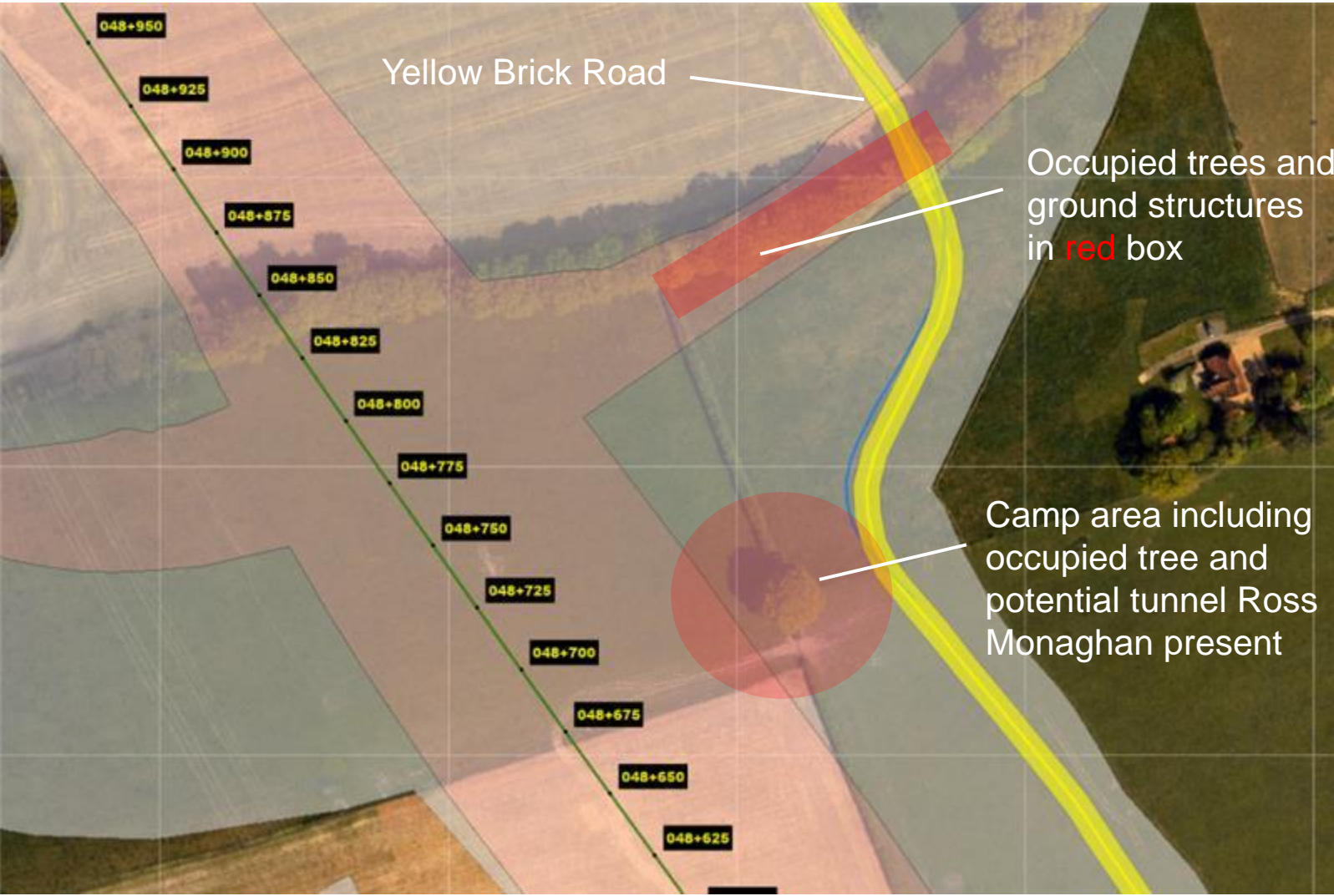

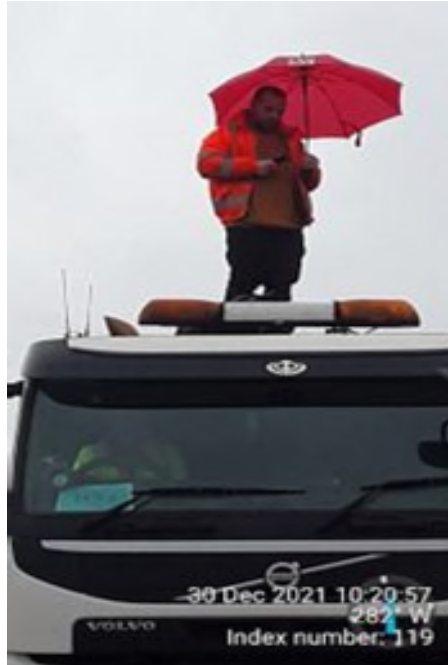

## HS2 protester spends night under digger in effort to stop demolition

Occupation by Sarah Green, 62, later joined by other protesters, is intended to be part of rolling campaign along rail link's route

A 62-year-old environmental protester has spent more than 20 hours underneath a large digger as part of a new campaign to block the construction of the controversial [HS2](#) high speed rail link.

Sarah Green, a member of the Green party and a businesswoman in Hillingdon, started her protest under the digger, which is to be used for preparatory demolition work, in part of the Colne valley nature reserve at around lunchtime on Monday. Several other activists later joined her under the digger.

As well as wider objections about the ballooning cost of the project, protesters say the work will damage local wildlife. Speaking from underneath the digger on Tuesday morning, Green said she had spent "a beautiful night" there looking up at the stars.

The occupation is the first of a rolling programme of direct action set to take place along the route of the controversial HS2 development, environmental campaigners say.

Green said she and other protesters hoped they would be able to stop it taking place. While parliament has already approved an act for HS2 to go ahead, they hope to capitalise on opposition across the political spectrum.

Activists have circulated callouts on social media for tents, tarpaulins, climbing gear, warm clothes, bedding and food.

Advocates of the scheme say that when it is completed it will be the fastest rail network in Europe with trains able to carry 1,100 passengers travelling at 250mph. However, the cost of the development is escalating and it has been billed as the most expensive railway development in the world. The first phase alone is costing £24bn, which is forecast to rise to £56bn for the whole scheme.

One of the environmental protesters, Pete Phoenix, said: "This development is going to take out a lot of ancient woodland and pollute the water in the lakes in this area. Nobody wants HS2. It's a Tory white elephant."

Green said she had complained to HS2 representatives on the site that they had not obtained planning permission to chop down the trees.

However, a spokesman for HS2 Limited said the parliamentary act authorising the development stated that local planning permission was not required for this development.

"There is so much wildlife here," said Green. "An osprey was seen recently and I saw wonderful bats here last night. I don't know if they have a licence to demolish this area given that we have so many bats here. We have reported the bat issue to the police because we believe a wildlife crime may have been committed."

It is understood that HS2 Ltd undertook survey work which did not indicate the presence of bats.


Bailiffs have now surrounded the protesters with a tarpaulin, meaning they are unable to see what is happening. But Green said she could hear cars beeping in support and added that she was determined to go on for as long as possible.

"At the age of 62 this is the first time I've been involved in any direct action protest," she said. "This is the start of the direct action protests against HS2 but there is much more to come."

An HS2 spokesperson said: "There is an ongoing incident at an HS2 site at Harvil Road. The safety of everyone involved is our top priority."

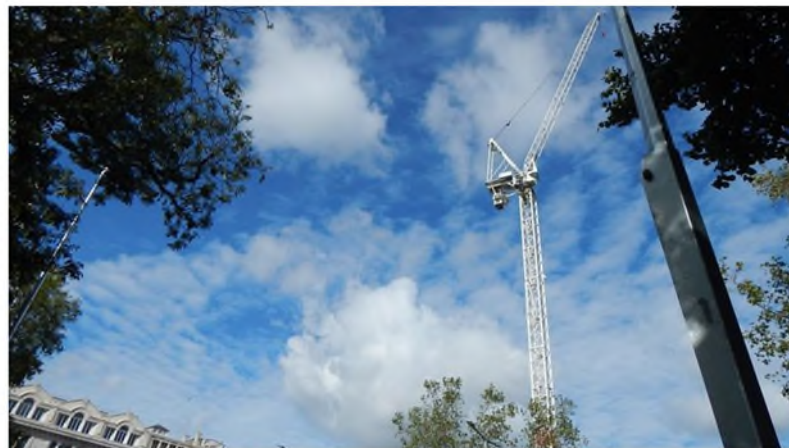

A HS2 protester climbed a "150ft" crane at Euston Station in hunger strike against the multi-billion pound rail project.

The HS2 Rebellion activist climbed the crane in the early hours of Saturday morning using a harness and unfurled a banner that read: "HS2 is corrupt".

The protester was arrested as she came down in the early hours of Monday, it is understood.

HS2 said the Euston protest and ongoing climate demonstrations across London “endangered” the public and put “unnecessary strain” on the emergency services.

But Leayn, when perched in the crane cabin, told the Ham&High: “A lot of people don’t seem to understand the ramifications of what’s happening with HS2.

“A lot of people in neighbourhoods don’t want it, they’re dead against it, but when it comes to actually doing something about it, it’s a very different thing.

“They don’t want to rock the boat and bring anything on themselves and a crane is a massive thing that can be used for promotional materials, the same as anything else. It just makes sense.”

HS2, which will depart to and from Euston Station, could cost more than £100bn and has been subject of strong opposition from Camden residents, campaigners and politicians.

Crane protester Leayn, who is a writer, said it was important HS2 Rebellion’s message “got out in a big way”.

She said her skyline vantage point over London was “humbling” but that the number of buildings too heavily outweighed the number of trees.

Leayn said she wasn’t an environmentalist but someone who cared about the landscape.

"I'm here to try and create awareness," the protester said. "HS2 is not something we need or ever needed, and we really could be improving on something else."

A HS2 spokesperson said: "These protests are a danger to the safety of the protestors, our staff and the general public, and put unnecessary strain on the emergency services."

"All leading wildlife organisations agree that climate change is the biggest future threat to wildlife and habitats in the UK."

"By providing a cleaner, greener way to travel, HS2 will help cut the number of cars and lorries on our roads, cut demand for domestic flights, and help the country's fight against climate change."

"We'd urge environmental groups to help us in getting people out of their cars, off planes and onto low-carbon, high speed rail."

Cllr Oliver Cooper, the leader of Camden Council's opposition, said HS2 was "monstrous waste" of taxpayers' money and that the fight against it was "not lost".

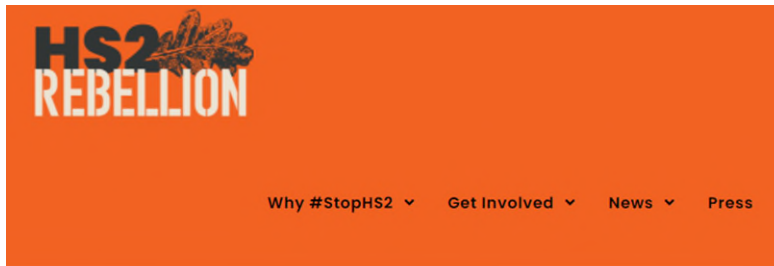
He told this newspaper: "I welcome keeping up the profile of the campaign against HS2, but direct action always risks alienating the very people you're trying to win over."

On Friday, construction work on HS2, a 20-year project that will connect London, Birmingham, Manchester and Leeds, officially started.

This is the latest HS2 Rebellion action in a week that has seen hundreds of people take dozens of actions against HS2, including dousing the Department of Transport with fake blood and locking on to a bleeding tree carcass at the Home Office and DEFRA.

Three environmental protectors are now on their fourth day occupying trees in Parliament Square, to stop HS2 and promote the CEE Bill as part of ongoing protests held by Extinction Rebellion, Animal Rebellion, Global Justice Rebellion and others.

Athena, 22, **also available for phone and video interview from her treetop in Parliament Square**, comments: "We ask the government to pass the Climate and Ecological Emergency Bill to address the greatest challenge of our time. This Bill will create 1000's more jobs than HS2 for far less money. But don't take my word for it, ask the people! Let's have a Citizen's Assembly on the Emergency response."

## Vandalism to EKFB Plant Equipment

Issued 16<sup>th</sup> September 2021

*Deliberate damage has been caused to EKFB plant equipment located in the NCA Area. Hydraulic hoses and pressure lines have been cut within a locked compartment. We believe this to have been carried out by individuals wishing to cause disruption and delay to the HS2 project.*

### What we know

- While carrying out pre work equipment checks, an excavator operator identified that hydraulic hoses within a locked compartment had been cut on the machine







## Climate activists scale HS2 headquarters and vandalise building

**HS2 Rebellion** protesters are in a 'stand off' with police after climbing to the top of the controversial rail line's headquarters and painting it pink.

Xavier Gonzalez Trimmer, 20, and Dr Larch Maxey, 48, mounted the canopy of building's lobby in Euston, central **London**, at 10am this morning clutching industrial spray paint machines.

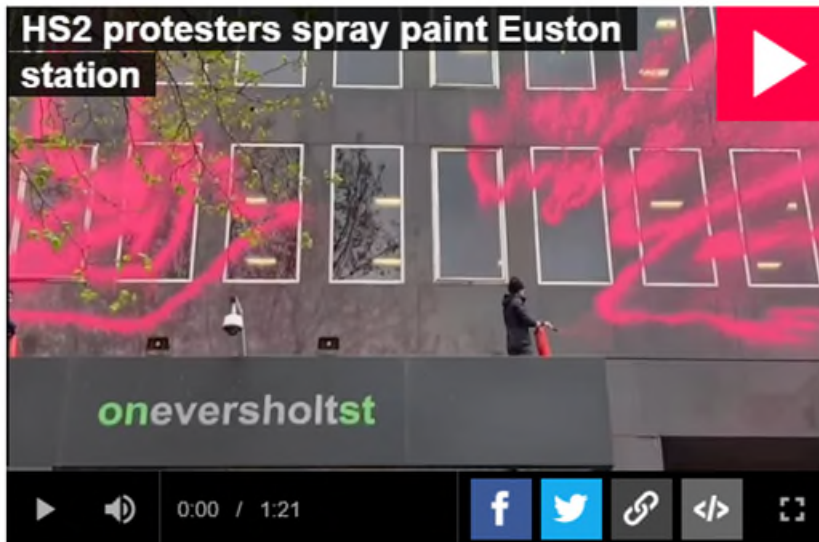
Footage shows the pair spraying the building in neon pink paint to show their support of the Burning Pink Party, which is calling for citizens' assemblies to tackle the climate crisis and other political issues.

Police brought in scaffolding to climb on the canopy in an attempt to coax the protesters down, but the pair are refusing to leave.



Dr Larch, who recently spent 27 days **in a hand built tunnel under Euston Square Gardens**, said he is prepared to stake out all night and risk going to prison because of his vandalism as long as he raises awareness for the cause.

He and Xavier have three demands, including that whoever wins the London Mayoral election tomorrow commits to running a citizens' assembly on the capital's infrastructure.

A citizens' assembly – sometimes known as a people's jury – is a body formed from citizens to deliberate on issues of local, national or international importance.

Dr Larch told Metro.co.uk: 'We need ordinary people to be making the decisions about our future, our future is at stake. Risks have been taken with our future by governments and by corporations. So we cannot trust them anymore, we have to have people power now for the citizens assemblies.

'We are risking being sent to prison for this action. We're taking that risk and making that sacrifice because the science says we're heading towards societal collapse.

'The last time there was this much carbon dioxide in the atmosphere London was 25 meters underwater.

'The science is very clear on that, but the media hasn't been covering it enough. The politicians haven't been telling the truth about it. We certainly haven't taken appropriate action.'

Dr Larch also criticised the media for 'ignoring' the mayoral campaign of Valerie Brown, The Burning Pink Party candidate for Mayor of London who opposes HS2.

He attacked Sadiq Khan, the current Mayor of London, for supporting the scheme on the day voters went to the polls to decide if he deserves another term.

Climate activists say HS2 – a high speed railway project set to link London, Birmingham, Manchester and Leeds – will accelerate the current crisis by emitting 14 million tons of Co2.

Protesters also claim the line will destroy or irreparably damage 108 ancient woodlands and 693 wildlife sites, and that Euston Square Gardens will be built over with a temporary taxi rank before being sold off to developers.

HS2 want politicians to establish a citizens' assembly on the project, as well as wider UK infrastructure.

Dr Larch said he knew his demands would not be met overnight but that he hoped his protest would get more people talking about citizens' assemblies.

'Once we get the media talking about citizens' assemblies and the importance of that in the future, we will come down voluntarily,' he said.

A spokesperson for HS2 said windows have been smashed as well as graffiti sprayed in the protest at the office in Euston, which is shared with Network Rail.

A statement said: 'We utterly condemn this senseless criminal damage.'

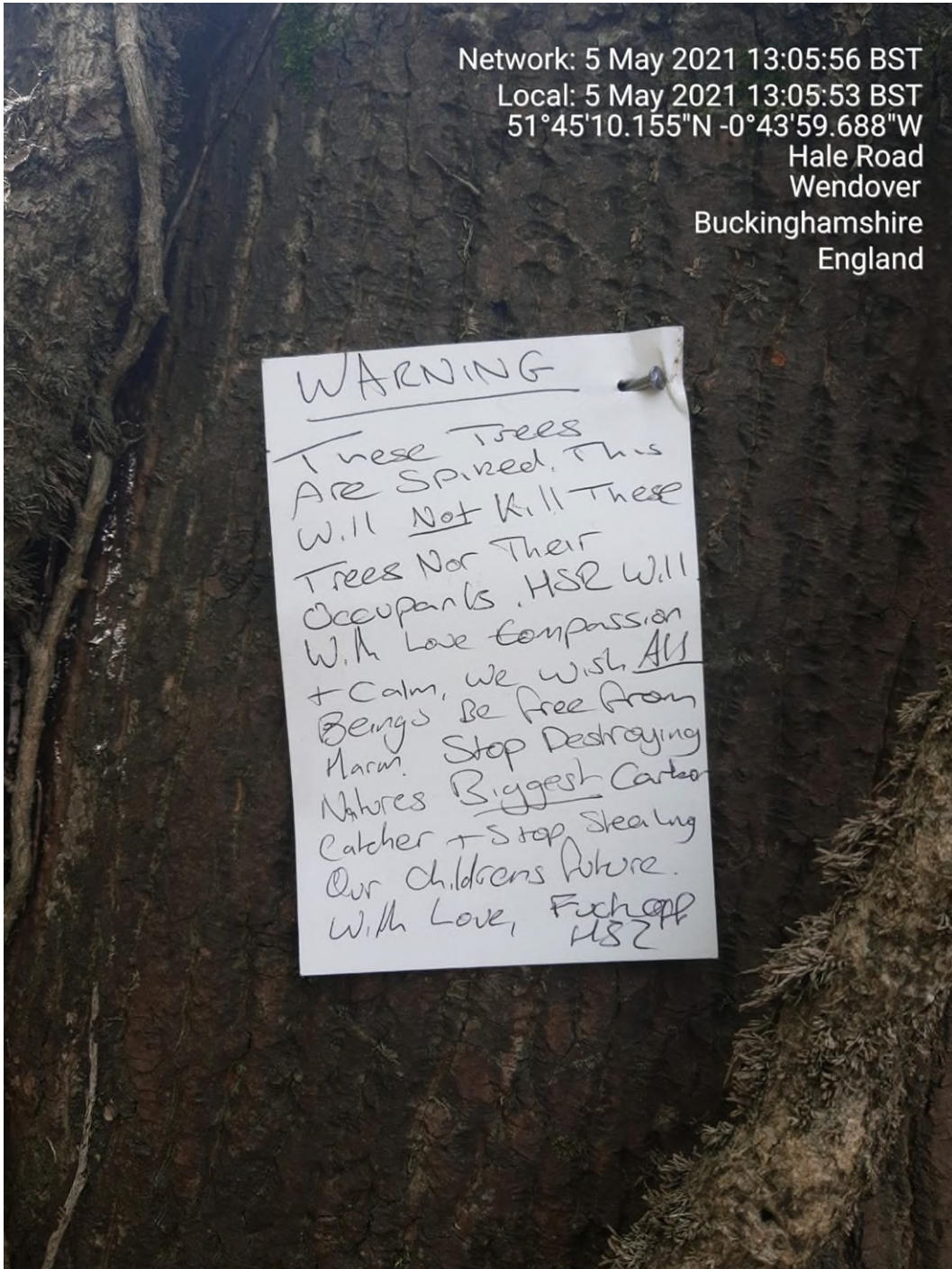
'HS2 has been repeatedly and excessively targeted by this sort of criminal activity during the pandemic, threatening the safety of the public and our workers, and placing unnecessary strain on the emergency services.'

'HS2 will provide green public transport, take cars and lorries off Britain's roads, reduce the need for domestic flights, and help the country's fight against climate change.'

On 03/07/2021, it was discovered that a number of felled trees stacked up and awaiting disposal has been tampered with by having nails hammered into the ends

The intention is to either damage wood chipping equipment or cause an injury to the person feeding the trees into the chipper

It is believed this is the first time the tactic has been used in the UK and graffiti at the scene made it abundantly clear this act was targeted at HS2

**Spiking**, as it is known, has previously been used on trees marked for felling but never felled trees

Although this happened in Cheshire, the person suspected of doing this has operated along the entire line of route, and the tactic is easily replicated so this must be considered a Phase One & P2A issue

Please pass this message to any individuals or companies that you know to be involved in tree felling or disposal on the project, and also to people who manage the procurement of such services so measures such as using handheld metal detectors can be used to keep people and machinery safe

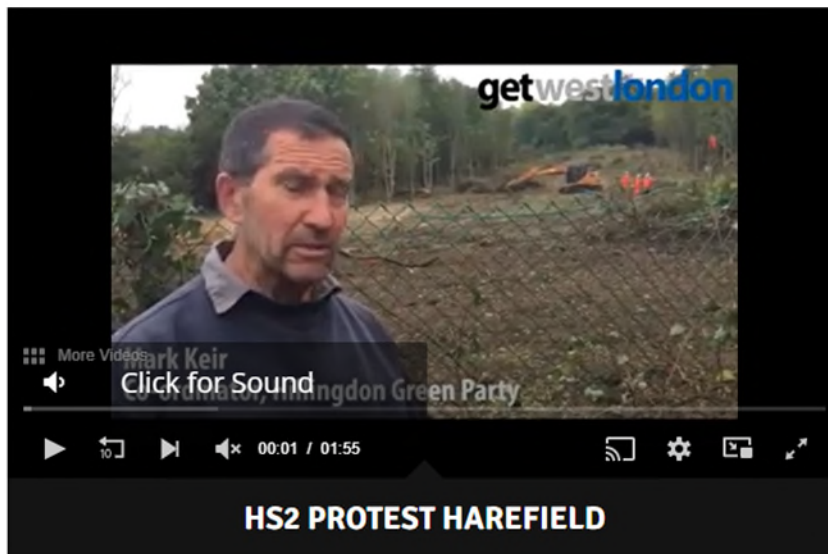
## HS2 activists evicted from field after chaining themselves to trees in protest at 'illegal' works

The protesters believe HS2 Ltd doesn't have permission to uproot trees on the land

A small group of activists have been evicted from HS2 land after **chaining themselves to trees** to prevent them being chopped down.

The STOP HS2 activists tied themselves up on land owned by **HS2** Limited in Harvil Road, **Harefield**, on Tuesday (October 10).

The protest followed a three-day occupation of a digger on the same site the week before.

Activists and the company are locked in a dispute over the felling of trees of the land, which is being cleared to make way for a high-speed rail link between London and the West Midlands.

Sarah Green, who led both protests, told *getwestlondon* that she was evicted from the land at around 10.30pm by bailiffs who forcibly carried her off the land.

"There are protected species including bats and badgers living in the trees here and they are uprooting them illegally without a licence or any planning permission," she said.

"HS2 limited think that the hybrid bill means they can do whatever they like on all the land they now own but this makes a mockery of all the planning permission laws.

"We were reassured in the House of Lords that HS2 Ltd would need to ask for individual planning permission at each individual site they worked on."



A spokesman for HS2 Ltd argued that all necessary planning permissions were in place and told *getwestlondon*: "HS2 will rebalance the economy by connecting eight out of our 10 biggest cities, increase rail capacity on the current system and reduce journey times, while also creating thousands of jobs across the UK."

"We understand that people feel strongly about the impact the project will have on their community.

"Reducing these impacts are at the heart of our designs, and we'll continue to work with communities to try and address their concerns.

"A small number of people have been escorted, under police supervision, from HS2 land in [Hillingdon](#) .

"They were not in an active working area. The safety of all involved remained our top priority throughout and no-one was injured."

## Hambach Forest evictions resume following journalist death

Clashes broke out earlier this month when police tried to force out activists who have been occupying the forest as part of a protest against coal mining. Activists say there's more at stake than just the Hambach Forest.

German police on Monday continued evicting environmental demonstrators from the disputed Hambach Forest between the cities of Cologne and Aachen.

Authorities last week began clearing makeshift camps from the site where German energy giant RWE plans to expand its coal mining activities. All actions were suspended last Wednesday, however, after a 27-year-old [journalist fell to his death from a rope bridge](#) connecting two trees in the forest.

The Interior Ministry for North Rhine-Westphalia said that activists had put up [new barriers over the weekend](#) that needed to be cleared. The state government also urged all protesters holed up in tree houses to evacuate the site immediately.

Authorities maintain that the demonstrators have for several years been illegally occupying the Hambach Forest, which is owned by RWE. The energy giant intends to clear some 100 hectares (247 acres) of woodland to mine for lignite — a brown, low-grade coal considered to be one of the most polluting fossil fuels.

### Meeting Germany's energy needs?

While authorities quietly tolerated the activists' occupation of the Hambach Forest since 2012, protests have come to head in recent weeks after authorities ordered the woods to be cleared immediately, citing fire hazards. RWE has also said it intends to begin cutting down trees as soon as next month.

The protests over the centuries-old forest have come to symbolize [Germany's uneasy transition away from fossil fuels](#). Protesters have been arguing that Germany should stop extracting fossil fuels and commit to its clean energy goals.

RWE, meanwhile, maintains that clearing the forest is necessary to meet Germany's immediate energy needs. Germany continues to remain heavily reliant on coal, partly to offset Chancellor Angela Merkel's decision in 2011 to phase out nuclear power by 2022.

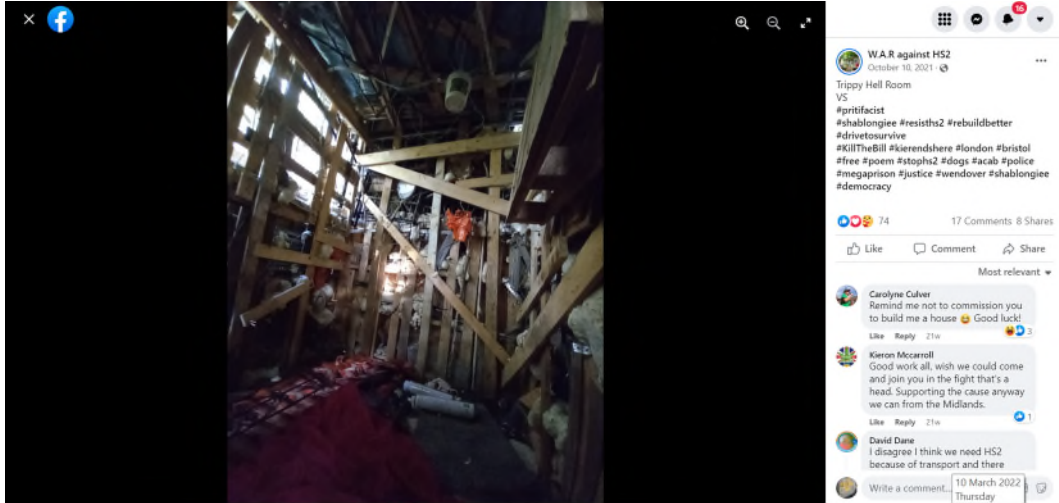

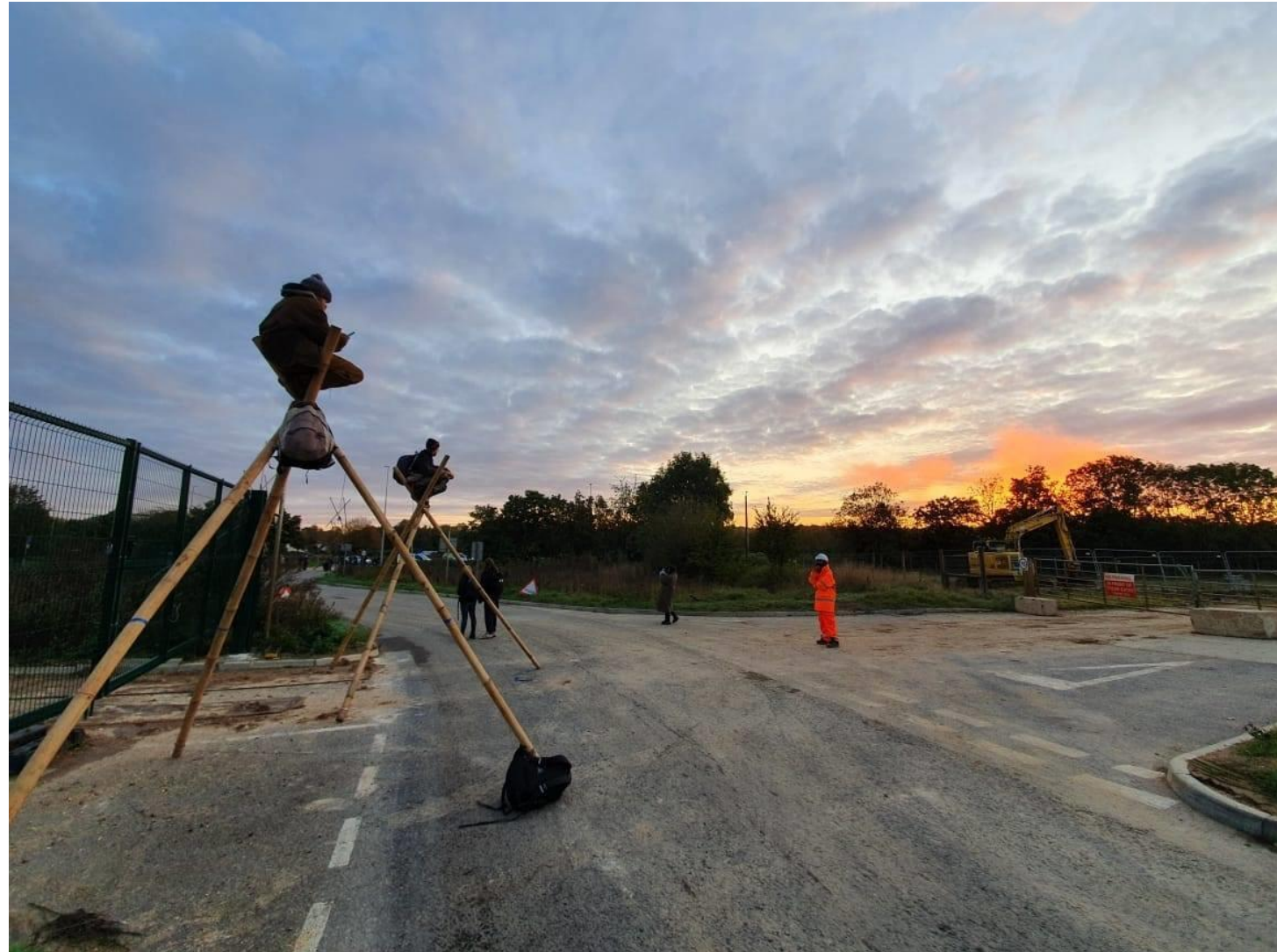

## Veteran activist Swampy among protesters in HS2 site standoff with police

Police and eviction squads have gathered in a standoff with HS2 protesters including veteran activist **Swampy**, who is sitting in a 30ft bamboo structure over a river in an attempt to stop HS2 building a works bridge through the Colne Valley nature reserve.

Activists put up the makeshift tower in the River Colne at the weekend to stop workers erecting the bridge and cutting a temporary road through the Denham Country Park woodland.

However, on Tuesday morning, construction crews had set the first half of the steel bridge into place, within a few metres of reaching Swampy's nest in the river, while security personnel lined the water.



Thames Valley police said two men had been arrested on suspicion of attempted assault in connection with the protest

Swampy - as Daniel Hooper, 47, is best known - said that attempting to complete the bridge with protesters in the way would be “shockingly dangerous”. Speaking to the Guardian before the standoff, he said: “Normally they’d get a cherry picker and a few police climbers to get me down but in a river it’s quite dangerous.”

He said that the Denham protest camp, which has occupied parts of the country park for the last six months, was saving dozens of ancient oaks and other trees from destruction. Swampy said he hoped that the action was “at least slowing **HS2** down until the government decides to scrap it”.

Contractors have been attempting to build an access road to relocate electrical pylons for the planned high-speed railway, and had put in place the concrete foundations of the bridge.

Sam Smithson, an environmental protector, said HS2 had declined proposals to take cut through a nearby golf course rather than the woodland. She said: “Every single day we are witnessing the landscape drastically changing, HS2 is felling trees and **irreparably destroying nature** before our eyes.

“This is a non-violent peaceful protest and we will continue to do this until the government takes its own advice by acting now to stop biodiversity loss which means stopping HS2.”

HS2 said the work was not impacting ancient woodland, and that alternative access routes - needed to divert power lines crossing the path of a new viaduct - would have been more environmentally damaging.

An HS2 spokesperson said: “HS2 has been repeatedly and excessively targeted by political activists. This criminal activity, including illegally trespassing on our construction sites, is a threat to the safety of the public and our workers, and places unnecessary strain on the emergency services during the pandemic.”

Work on the first phase of the £100bn high-speed rail line is accelerating at the major works site three miles away at South Heath in Buckinghamshire. Two 170 metre-long tunnel-boring machines are being assembled to start drilling the 10-mile Chiltern tunnels in spring 2021.

The two 2,000-tonne machines were manufactured in Germany before being shipped in parts to the UK. The construction site beside the M25 is the size of 80 football pitches, with the tunnel’s south portals already created ready for the machines.

HS2 Ltd’s chief executive, Mark Thurston, said: “The launch of our first tunnelling machines will be a defining moment in the history of HS2 - and our work to deliver a high speed railway that will offer a low-carbon alternative for journeys across the UK.”

Major civil engineering work **started this year**, after the government **decided in February** to press ahead with the high-speed rail network.

  - b. prohibits (however phrased) entry upon any land by the Defendant (whether named as a defendant or as a "person unknown").

- c. go within 100 metres of any HS2 Scheme land, site, building or office;

- e. pursue any course of conduct that amounts to criminal damage pursuant to section 1 of the Criminal Damage Act 1971;
- f. obstruct free passage along a public highway, or the access to or from a public highway, by:
  - i. blocking the highway or access thereto with persons or things when done with a view to slowing down or stopping vehicular or pedestrian traffic, and with the intention of causing inconvenience and/or delay; and/or
  - ii. slow walking in front of vehicles with the object of slowing them down, and with the intention of causing inconvenience and/or delay; and
- g. climb onto or attach himself to vehicles or plant or machinery used by either Claimant;

**Veteran eco warrior Swampy has been charged with trespassing after he and eight other protesters were removed from a tree on the HS2 route.**

They had set up camp in a tree house in Jones' Hill Wood, between Wendover and Great Missenden, in Buckinghamshire.

Specially trained climbing officers scaled the tree to remove the group on Thursday.

Charges ranged from aggravated trespassing to breaching bail conditions.

The wood was the inspiration for Roald Dahl's children story *Fantastic Mr Fox*.

Swampy, 47, charged under the name Dan Hooper, was charged with aggravated trespass, along with four others.

- Veronica Tombolan, 23, of Kings Lane, The Lee, Buckinghamshire
- Anne Kahn, 22, of Kings Lane, The Lee, Buckinghamshire

All five have been released on bail, to appear in High Wycombe Magistrates' Court on 16 November.

Richard Fox, 29, of Fore Street, Yealmpton, Plymouth, was charged with obstructing/resisting a constable in execution of duty and was bailed to appear at the same court on 16 November.

A 38-year-old man from Wendover, Buckinghamshire, was arrested on suspicion of two counts of assault, criminal damage and possession of class B drugs and has been released under investigation.

Two others appeared at High Wycombe magistrates' court today accused of breaching bail.

Dana Patel, prosecuting, said that at previous hearing the two men had been bailed not to interfere with the workings on an HS2 site.

Newbury Green Party councillor Steve Masters of West Mills, Newbury was found not to have breached his bail from a previous protest.

He is also charged with aggravated trespass.

William Harewood 30, of Jones Hill Wood, Wendover, was charged with breach of bail.

His lawyer said he had been bailed on the condition of his address being the tree house, where he had been living for three months. He was found not to have breached the conditions.

He is also accused of aggravated trespass, criminal damage, assault, obstructing police and interfere/ misuse something provided to meet statutory health safety or welfare provision.

Both men are back in court on November 20.

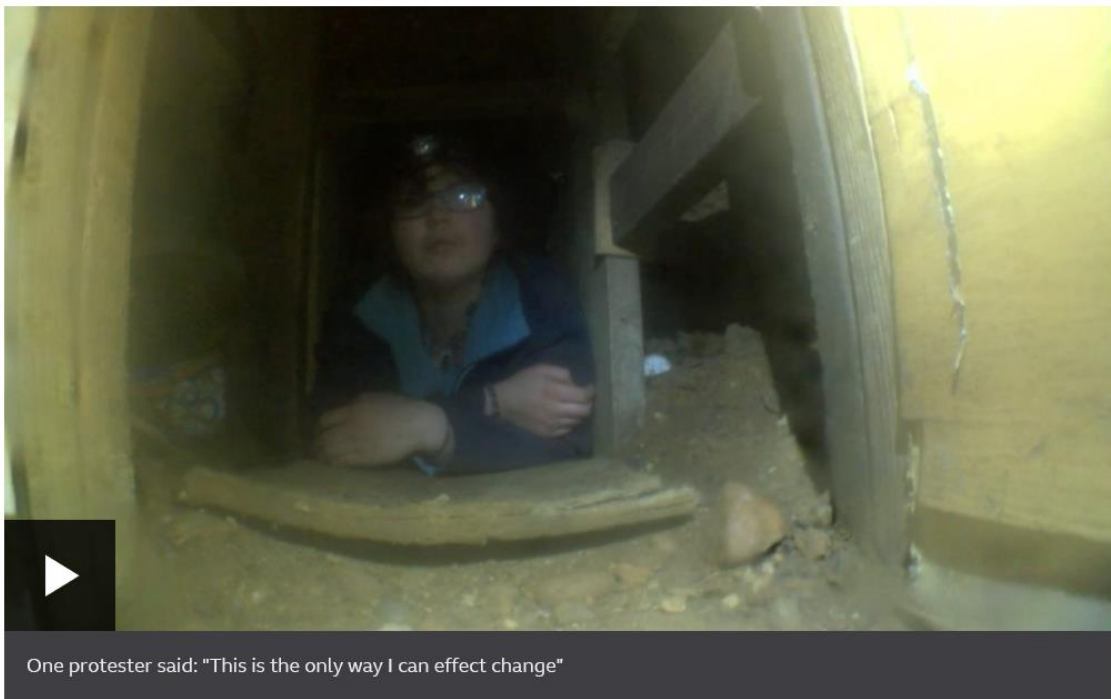

# HS2 protesters dig tunnel to thwart Euston eviction

One protester said: "This is the only way I can effect change"

**People campaigning against the HS2 rail project have dug a tunnel near Euston station, in a bid to prevent their eviction from a protest camp.**

In September, members of HS2 Rebellion set up a Tree Protection Camp in Euston Square Gardens in central London to protest against the £106bn scheme.

They claim the tunnel is 100ft (30m) long and has taken two months to dig.

Activists say the tunnel - codenamed "Kelvin" - is their "best defence" against being evicted.

One protester, identified only as Blue, told the BBC: "It is all very dangerous and life-threatening but it is all worth it. This is the only way I can effect

change, I would sacrifice everything for the climate ecological emergency to not be happening."

The 18-year-old added: "We want to be as safe as possible. It is not about us martyring ourselves, it is about delaying and stopping HS2."

A spokeswoman for HS2 said tunnel protests were "costly to the taxpayer".

She added: "These are a danger to the safety of the protesters, HS2 staff, High Court enforcement officers and the general public, as well as putting unnecessary strain on the emergency services during the pandemic.

"Safety is our first priority when taking possession of land and removing illegal encampments."

British Transport Police said it was aware of the tunnel but it was a matter for the Met Police, which said no complaint yet had been made.

HS2 is set to link London, Birmingham, Manchester and Leeds. It is hoped the 20-year project will reduce rail passenger overcrowding and help to rebalance the UK's economy.

The campaign group alleges HS2 is the "most expensive, wasteful and destructive project in UK history" and that it is "set to destroy or irreparably damage 108 ancient woodlands and 693 wildlife sites".

However, HS2 bosses have said seven million trees will be planted during phase one of the project and that much ancient woodland will "remain intact".

Transport Secretary Grant Shapps told MPs in September that the first phase of the high-speed rail link between London and Birmingham **would not open until 2028 at the earliest.**

The second phase, to Manchester and Leeds, was due to open in 2032-33 but that has been pushed back to 2035-40.

Network Rail, which owns the land, has been approached for a comment about the tunnel.

# Analysis

Tunnelling as a form of environmental protest has a long history in the UK.

In the 1990s it was one of the ways that pushed environmental concerns into the headlines and changed perceptions.

In one of the environmental protesters' tunnelling guides, written by "Disco Dave", it says:

"In the world of NVDA (non-violent direct action) there are few defence tactics that can compare with the protest tunnel. Dangerous, laborious and time consuming, tunnelling is the ultimate and desperate tactic of desperate people in desperate times."

The first protest tunnel goes back to the M11 and 1993 but they only really developed during the Newbury Bypass protests in 1996.

Protest tunnels against the A30 in Devon and Manchester Airport's second runway then followed.

Not only did they make household names of environmental campaigners like "Swampy" but they arguably changed transport policy - road-building reduced massively.

We have seen tunnels more recently in 2017 in Coldharbour in Surrey in a protest against fracking so it's not a massive surprise we are seeing tunnels again.

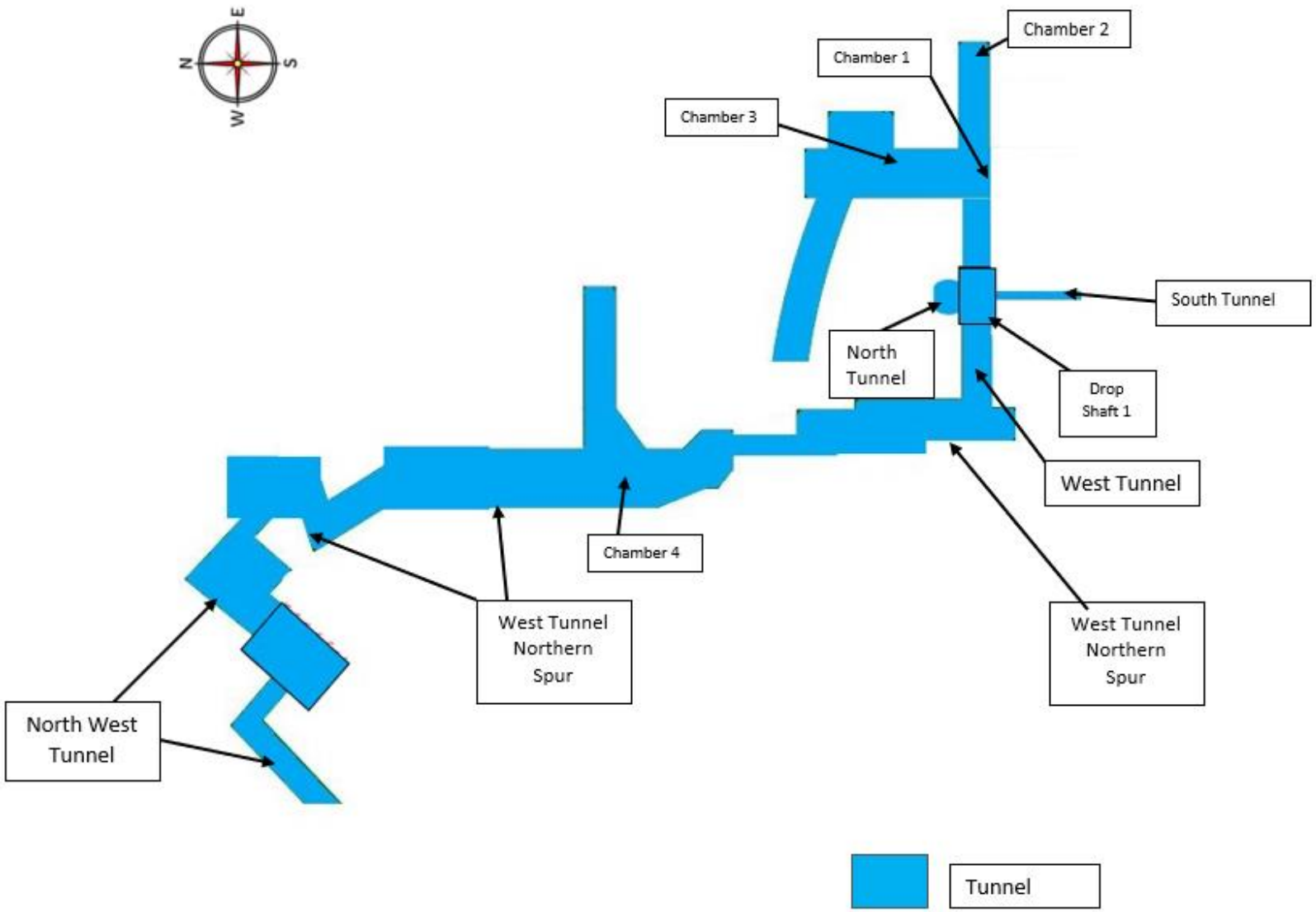
Tunnelling in particular as a direct action slows down developers and it is expensive to dig out protesters safely.

Disco Dave wrote: "That ultimately is the purpose of tunnels and tree houses. To act as a deterrent warning the authorities that should they decide to evict, then it will hurt them where for them it hurts most - in the pocket."

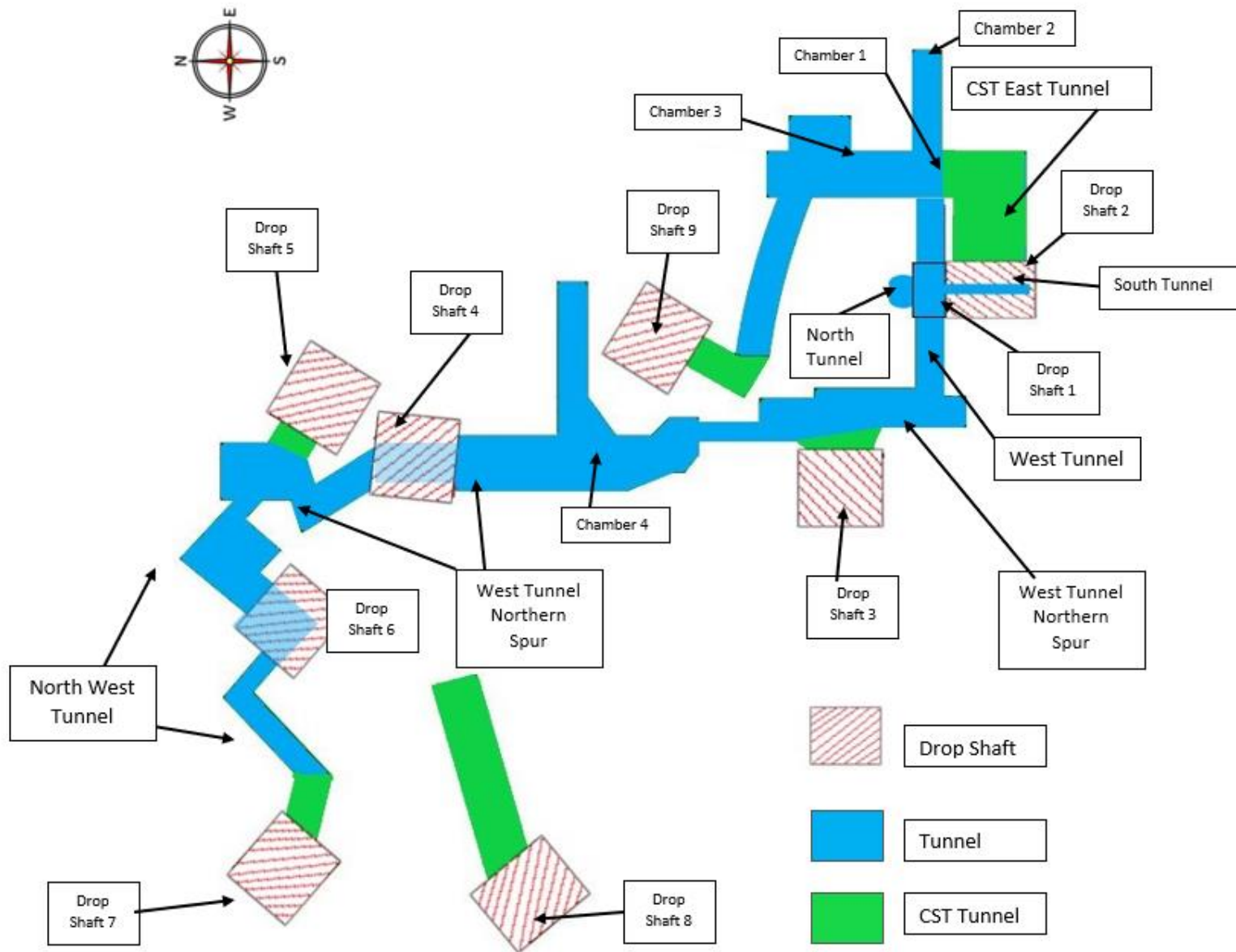
What will be interesting is if these tunnels have the same impact on HS2 as they did on the road-building programme of the late 1990s.

Will it reframe HS2 so it will be seen in the same way as fracking or road building? Or can the argument still be made that it is a low-carbon form of travel even though it does cause some destruction of habitat?





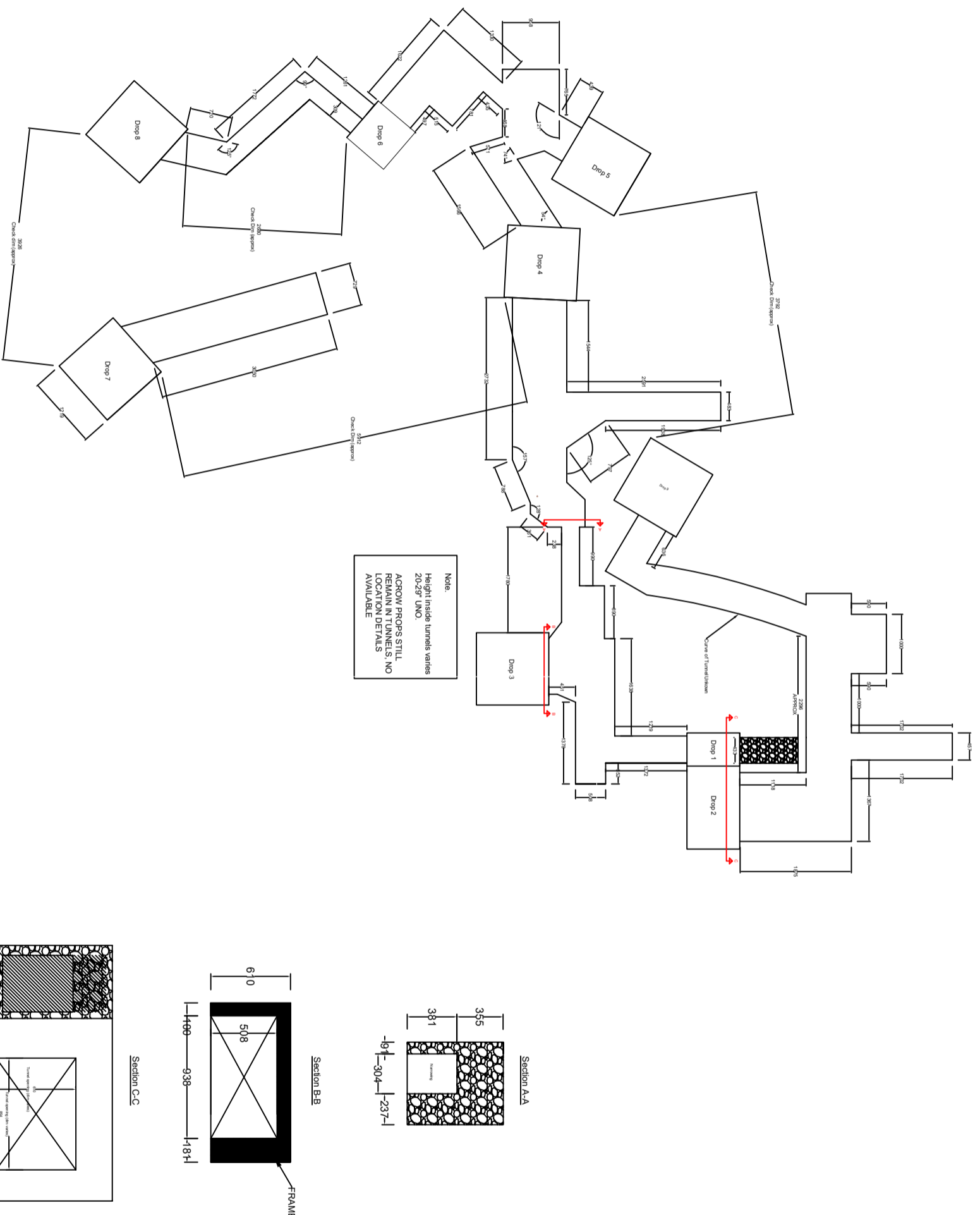
