BETWEEN :-

- (1) **THE COAL AUTHORITY** whose principal office is at 200 Lichfield Lane, Mansfield, Nottinghamshire, NG18 4RG ("the Authority").
- (2) WEST CUMBRIA MINING LIMITED, (formerly known as RIVERSIDE ENERGY (WEST CUMBRIA) LIMITED) of 4th Floor Oakfield House, 35 Perrymount Road, Haywards Heath, West Sussex ("the Licensee").

WHEREBY IT IS AGREED as follows:-

1. **DEFINITIONS**

In this Agreement :-

"Coal-Mining Operations" has the meaning ascribed to it in the Licence.

"Licence" means the Conditional Underground Mining Licence

granted by the Authority to the Licensee on 24 January 2013, then varied by a Supplemental Agreement dated 8 March 2018 and includes any instrument which is

supplemental to that Licence;

"Licensed Area" means the land described in Part 3 of Schedule 2 of

the Licence;

"Term" means the period of 40 years as described in the Licence

Authorisation in the Licence;

The Clause headings do not form part of this Agreement and shall not be taken into account in its construction or interpretation.

2. RECITALS

- 2.1 This Agreement is supplemental to the Licence by which the Licensee was permitted to carry out Coal-Mining Operations within the Licensed Area during the Term subject to and upon the restrictions and conditions contained in the Licence.
- 2.2 The benefit of the Licence remains in the Licensee and the Authority, at the request of the Licensee, has agreed to modify the Licence as set out below.

3. VARIATION

- 3.1 The Authority and the Licensee in accordance with Condition 18.1 of the Licence agree:-
 - 3.1.1 Paragraph 1 of Part 1 of Schedule 5 to the Licence, shall be substituted by the following form of words:-

The Conditions Precedent are to be satisfied no later than 14 October 2022.

3.2 The Licence shall continue in full force and effect, save as modified by Clause 3.1 above.
