



Enforcement Action taken in the period: 24 September 2021 to 31 March 2022

The Office for Product Safety and Standards (OPSS) is part of the Department for Business, Energy & Industrial Strategy and exercises the powers of the Secretary of State in relation to a range of regulations. Our approach to dealing with non-compliance by those we regulate and resolving potential product safety issues is set out in our [Enforcement Policy](#), which also sets out our approach to publishing details of our enforcement actions. Where enforcement action is taken in relation to an individual, details of the individual are anonymised.

The enforcement actions listed below were taken by OPSS, or the Secretary of State (for the Department for Levelling Up, Housing and Communities) acting through OPSS, in the 6-month period between 24 September 2021 and 31 March 2022. Actions are grouped under the following headings: Construction Products, Product Safety, and Timber.

Details:

The Notices prohibit the UK supply of Kooltherm K15 insulation board products manufactured after 1 August 2021 and covered by the Declaration of Performance (DoP) dated 2 August 2021 (Reference Number 1002.CPR.2013.K15.007) (affected product). The Notices required Kingspan to cease supply of affected product, and to contact its customers and those in the supply chain to organise and implement the return of affected product from the market, where it has not been incorporated into buildings in a permanent manner.

OPSS has determined that the requirements of the Prohibition Notices have been met.

On 9 March 2022, Kingspan issued a new DoP (Reference Number 1002.CPR.2013.K15.008) for a new K15 product. This DoP applies only to K15 produced and placed on the market from that date onward. Product produced under this DoP, since 9 March 2022, is not affected by the Prohibition Notices issued on 23 December 2021.
