1. Chair Welcome & Introductions

Follow up on actions from previous meeting:

Additional Quota for capped license holders came out of the 7d meeting. This has been welcomed by industry but came rather late in the year. Next year DEFRA will be carrying out a review of capped license as part of a wider licencing review.

Question regarding why the additional quota needed to go through the PO.

Response from Katie James explained that there is no current policy in place for the MMO to lease directly to the capped licence holders. In order to offer the additional quota as soon as Defra had approved the request, MMO approached CFPO who agreed to act as a third party to save any delays in making the quota available.

Question about Bass and changes to legislation to allow accidental bass bycatch to be kept. Response, there is no plan to change this.

3. Evidence Team Introduction - Chris Sweeting, MMO

The Evidence Team find the scientific information that the MMO needs to support decision making, working with industry, academia, CEFAS and IFCAS. They may be able to develop ideas and deliver the science required on issues raised in RFG meetings for 7d or the inshore fishery more generally.

Question about the reduction in lobster fishery and relationship between this and the MMO licensed project to pump sand onto shore at Bournemouth. No report yet from MMO on impact of this.

Question about the relationship between water temperature and a reduction in lobster fishery in Isle of White.

ACTION - Chris Sweeting to investigate these issues further and meet with Paul Johnson.

Two example projects:

Traceability – Evidence Team will be working with independent facilitators to go to industry, the MMO and hold discussions to see what traceability technology is out there and what would be suitable for the fleet. There is funding available to carrying out trials next year which the RFG's may want to be a part of.

Seal deterrents – MMO trailed prototype of a device which emits sound to startle seals in 2018 which was very effective, but the technology is new and developing. The Evidence Team are looking to trial new versions of the device with the inshore fleet early next year.

The Team are looking for a fishery and collaborators in which to conduct the trials. Trials will be most effective where seal issues are greatest. Please contact Chris with questions and for more information: <u>Christopher.Sweeting@marinemanagement.org.uk</u>
