1. Welcome, Introductions and Apologies

Members of the Taskforce and the Chair, Neil McIvor, introduced themselves to each other, their roles and organisations.

2. Chair's address

The chair explained that Minister Donelan has asked him to set up this Taskforce, which looks to bring together a range of stakeholders involved in the reporting and collecting of data across higher education and identify where these processes can be rationalised with the aim of reducing bureaucracy across the sector.

The intention is to create a formal structure to allow the sharing of knowledge across the sector and encourage both data collectors and reporters to work together to improve the efficiency of data collections, with bureaucracy rationalised and reduced.

The Chair wanted to ensure that there are concrete actions and recommendations based on Taskforce discussions.

The Taskforce will run every 6 weeks for 6 months.

3. Terms of Reference

Terms of Reference were agreed with several small changes. To be recirculed and published.

4. What are the challenges and opportunities?

All members of the Taskforce were invited to share challenges and opportunities within the terms of reference. The taskforce recognised the importance of the initiative and the opportunity it created to be forward thinking.

As part of a wide-ranging discussion, a number of themes were discussed by a number of members:

- Definition and purpose of data collection can we agree more common definitions across the data collecting organisations.
- Recognise that there does need to be an element of data burden on providers, but that there could be opportunities for better compromise from the centre, e.g. accepting what exists already.
- Burden is relative to the "yield" from the data; wider access would increase the value returned to providers in relation to the costs they bear supplying data.
- To understand the cost of data collection to the sector would be useful and give perspective.
- We need to think with the best interests of the students when determining what we collect.
- Need to reduce red tape on data sharing as this can be the reason why duplicate information is collected.
- How to ensure governance of data bodies is effective and up to date, given the current data landscape.

Other themes were also identified and discussed.

5. Developing a work programme

Following the discussion about priorities and other challenges, and a further discussion on challenges, the Chair proposed the following workstreams and owners were identified:

- Definitions understanding those areas where similar definitions or coverage are causing additional work – identification of the issues. David Hayes agreed to coordinate this.
- Sharing and release of information, value chain what sort of information would help complete the circle – better or different ways of disseminating information so that providers get value from the data they supply. Sally Turnbull agreed to coordinate this 'provider' strand.
- Data sharing blockages Data collecting organisations can impose additional burden if there is red tape in obtaining what they need. Is there a common 'minimum' data-set that could be held across organisations? Don Campbell agreed to coordinate this 'data collectors' strand.
- Better common governance how can we get better at governing what is collected and to what definitions so as to minimise burden? Alison Berry and Richard Puttock agreed to coordinated this 'data collectors' strand.
