### General Conditions and Guidance Notes Relating to the Certification of Consignments of Grain for Export

#### **Guidance Notes**

(a) A copy of this application form with Sections I, II and III completed should be sent, preferably by email, as soon as possible and at least 5 clear days before the proposed date of loading to ship to APHA PHSI or your local SGRPID Agricultural Officer. Contact details for APHA are:

- (b) It is essential that APHA/SGRPID be informed of any special conditions of entry relating to the certification of the consignment. Where an import permit has been received this should be forwarded with this application.
- (C) Following examination of the consignment for grain insect pests, a further copy of this form with Section IVa & IVb also completed should be sent to APHA/SGRPID to request the issue of a Phytosanitary Certificate.
- (d) In some cases a Phytosanitary Certificate can only be issued following inspection of a representative sample by an official laboratory. Where this is necessary a satisfactory lab report must be submitted with the completed HH93 when requesting a Phytosanitary certificate. Annex I of the GSOP1 contains details of the countries which are believed to require a Phytosanitary Certificate and/or further testing. Import permits may specify additional requirements and where no information is currently held APHA/SGRPID should be contacted for further information.
- (e) Samples should be submitted along with a copy of this form with Sections I, II, III and IVa completed to the appropriate laboratory listed below. Where APHA/SGRPID have supplied details of additional testing requirements not listed in the GSOP1 these should also be submitted to the laboratory with the sample. Where a sample has been submitted to Fera this must also be accompanied by a copy of their Plant Clinic sample submission form providing details of the testing required.

(f) Where chemical treatment has been applied the certificate of disinfestation issued by the professional treatment company applying the chemical treatment must be supplied at the same time as the final copy of the HH93.

#### General Conditions

- 1. The Animal and Plant Health Agency (APHA) and Scottish Government Rural Payments and Inspections Directorate (SGRPID) may on plant health grounds refuse any application for the issue of a Phytosanitary Certificate. A Phytosanitary Certificate will not be issued if APHA/ SGRPID has reason to believe that any information supplied by the applicant is incorrect or inaccurate or if any conditions prescribed relating to the treatment or movement of grain intended for export have not been complied with. APHA/SGRPID may also require an exporter to produce any information in connection with any plant product for export.
- 2. Authorised Trade Inspectors, in carrying out functions in respect of the inspection of grain for phytosanitary certification, act on behalf of the exporters of the grain inspected. Matters relating to the employment of A u t h o r i s e d Trade Inspectors are the responsibility of A u t h o r i s e d Trade Inspectors and those organisations within the grain trade by whom they are employed and APHA/SGRPID and the Welsh Assembly Government (WAG), on whose behalf APHA issues certificates for exports from Wales, shall not be liable in respect of any loss, damage, injury or death arising as a result of any act or omission, whether negligent or otherwise, of an Authorised Trade Inspector.
- 3. No liability shall attach to APHA or any of its officers for any delay in inspecting or failure to inspect or non-delivery, delayed delivery or mis-delivery of any documents. Inspections will be carried out and Phytosanitary Certificates will be issued only on the understanding that no liability shall attach to APHA or its officers in any circumstances in respect of any inspections carried out or the issue or contents of any Phytosanitary Certificates and that APHA accepts no responsibility for any resulting loss however caused.
- 4. APHA/SGRPID and its officers shall be entitled to rely upon the accuracy of all information supplied by and on behalf of an applicant for the issue of a Phytosanitary Certificate.
- 5. No Phytosanitary Certificate issued shall be used in respect of any consignments except those to which it relates.
- 6. Fees will be charged for the certification of consignments. Details of the fees in England and Wales are available at:
