Bulk vehicle data

This data set is primarily used to support the motoring industry. The data is provided under contract and includes vehicle identifying information such as the Vehicle Registration Number (VRN), Vehicle Identification Number (VIN), make and model. It does not include names or addresses of the keepers of vehicles.

There are 47 fields in each vehicle record and these fields cannot be broken down to suit individual requirements. The data is encrypted and supplied via CD and then despatched using a secure delivery service.

Customers receive:

- weekly cherished transfer and change of keeper data
- monthly first registration data
- a data refresh every six months – (a scan of the whole vehicle database which gives a snapshot of each record excluding details of vehicles that have been unlicensed or not declared off road (SORN) for over a year).

If approved, new customers can onboard to the service twice per year. Data refresh scans are run in January and July of every year and will be required to provide the foundation of the data set.

This data is released under the provision of Regulation 27 of the Road Vehicle (Registration and Licensing) Regulations 2002. In this context the agency is prepared to release data in bulk, to underpin vehicle check databases which the public and others may refer to, to improve road safety, to aid consumer protection and to deter vehicle theft. Companies who wish to apply for the data must be able to demonstrate reasonable cause for each of the 47 data fields.
