<p>The Infantry Training Centre, Catterick uses this parcel of land extensively for dry training in particular for the training of recruits and young soldiers. This includes the firing of blank ammunition and use of smoke and pyrotechnics. The area is also in use for bivouacking and overnight exercises.</p>
