Monthly Summary

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of dust monitoring undertaken in the West Northamptonshire (WNDC) during March 2023.
- 1.1.2 Figures 1 and 2 in Appendix A present the current worksites together with the dust monitoring locations for March 2023.

1.1.5 Dust monitoring locations and results are presented in Appendix B, Table 1, together with a line chart of monthly data from the dust monitor presented in Figure 3. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigation.

1.1.6 The trigger level for PM₁₀ concentrations of 190 µg/m³, over a 1-hour period, in accordance with the updated guidance document '*Guidance on Monitoring in the Vicinity of Demolition and Construction Sites - (October 2018)*' has been applied.


1.1.7 Data capture was below 90% for the Radstone monitor due to a fault with the pump. Monitor will need to be retrieved for investigation/ repair. The Hall Farm monitor also had low data capture due to a fault with the monitor.

1.1.8 There were no (0) dust alerts recorded during the monitoring period (March 2023).

1.1.9 No (0) complaints were received during the reporting period.


