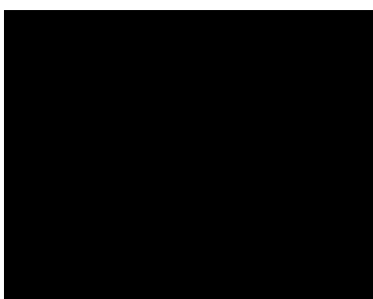
Where do I start?

- 2: No other country allows extradition without evidence like the UK does.
- 3: The treaty with the US which I have become very familiar with in it's wording says that a person being requested by the US is guilty at first appearance at court and is in breach of ECHR directive 6.
- 4: The remand that may follow on information falsely given by the US and UK police is also in breach of ECHR directive 5 as upheld in the ECHR recently in several cases of illegal imprisonment in the UK.
- 5: The foundation in UK common law has been overlooked to please the US and shows up in congress reports that I have in my wife and my extradition case, in simple terms the US are the senior partner as David Cameron said and must accept the will of the US demands like in extradition in order to keep a close but junior partnership.
