PCCs take up office

The most significant democratic reform of policing in our lifetime has now taken place, with the election of 41 police and crime commissioners last week. PCCs took up their posts on the 22nd of November. For the first time there is somebody responsible for policing who has been elected directly to the post, which will bring increased accountability and visibility to those responsible for policing.

Police and crime commissioners will work with the police to cut crime, give the public a voice at the highest level, hold forces to account, and help to increase further the trust the public have in policing.

The Home Secretary made the following statement in Parliament after the elections:

“May I take this opportunity first to welcome the 41 police and crime commissioners who were elected last Thursday. They have important responsibilities and will be an important voice for people in their force areas in policing local communities. Police and crime commissioners take up their office officially this Thursday [22nd November]. I look forward to working with them in future to do everything we can to ensure that we can continue to cut crime.”

Future of PCC bulletin

The PCC bulletin, aimed at partners, has been produced on a monthly basis since July last year. Now

that PCCs are in post it is our intention to continue with the bulletin, which can change to further reflect the needs of partners. It is proposed that from the next edition a different partner will be asked to write as a guest in the bulletin each month, and the bulletin will continue to update partners on events, and draw to their attention relevant guidance and other information they would benefit from knowing about.

PCC Welcome Event

The Home Secretary has now invited all newly elected police and crime commissioners to the Welcome Event at the Home Office on the 3rd of December 2012. This will provide the first formal occasion for the Home Secretary and her ministerial team to meet with police and crime commissioners. The event will focus on laying the foundations on which PCCs can forge and build effective working relationships with the Home Office and wider government.

APCC information events

The Association of Police and Crime Commissioners will be working with partners to deliver a monthly series of information events for PCCs and partners throughout 2013, providing an opportunity to debate and share practice across a range of key policing, community safety and justice priorities. APCC National meeting 23rd January

The first APCC event will be held on 23 January at the Guildhall in London. It will be a closed session for PCCs focusing on the police workforce, finance and funding. Other events will be open to interested parties wishing to attend and engage with PCCs.

A Community Budgets conference will take place on 29th of November.

Health and CJS links

Improving the health of a local population will require partnership working on crime, violence prevention and community safety. Local areas will need to engage with police and crime commissioners in order to achieve these outcomes and work effectively. Equally, reducing crime requires a strong health input on issues such as drug and alcohol dependence and mental health, and PCCs will need to engage with health partners.

NHS Mandate

On 13th of November, the Department of Health published the first Mandate between the Government and the NHS Commissioning Board, setting out the ambitions for the health service for the next two years. Section 7 of the mandate looks at the broader role of the NHS and includes an objective to make partnership working (including with PCCs and community safety partnerships) a success.
