### Police and Crime Commissioners: Communications update

#### Police and Crime Commissioner candidate information

From 26 October members of the public will be able to type their postcode into [www.choosemypcc.org.uk](http://www.choosemypcc.org.uk) and view details about candidates who are standing for Police and Crime Commissioner in their local area. The public can also call 0800 1 070 708 to order a free printed copy of candidate information.

Although the Home Office advertising campaign is ending due to purdah, the choosemypcc website will continue to be promoted on polling cards and in the Electoral Commission's booklet which is being delivered to every household in England and Wales. ### Elections

Nominations to be a candidate in the PCC elections closed on the 19th October.

Poll cards have been sent out and contain details of the candidate website and phonenumber for requesting paper copies.

Candidates have until midnight 24th October to withdraw their candidacy if they wish; and following that we will publish the candidate website on 26th October on [www.choosemypcc.org.uk](http://www.choosemypcc.org.uk)

The election is just three weeks away, on the 15th November. PCCs will take office on the 22nd of November.

## **Damian Green speech to PCC Conference 23 October**

Damian Green, Minister for Policing and Criminal Justice, made a keynote speech on Police and Crime Commissioners to the PCC Conference held at Policy Exchange on the 23rd of October.

In the speech the Minister for Policing and Criminal Justice explained the principles that underpin policy on Police and Crime Commissioners. The Minister also set out the Government's vision for improved support for victims and witnesses, explaining why PCCs are likely to want to prioritise victims, including details of the new proposed duty on PCCs to make sure victims have a greater say in the punishment of some offenders. The aim is for PCCs to start commissioning victims' services in 2014.

## **PCC Welcome Event**

The Home Secretary will invite all newly elected Police and Crime Commissioners to a Welcome Event at the Home Office on the 3rd December 2012. This will provide the first formal occasion for Police and Crime Commissioners to meet with the Home Secretary and her ministerial team, and discuss how they will work together in order to tackle the range of challenges that police service and our communities face in tackling and preventing crime.

The invitation will be extended to Police and Crime Commissioners. Ministers are keen to ensure that the event's agenda lays the foundation on which to forge and build effective working relationships with the Home Office, wider Government and ministers.

## **APCC National meeting 23<sup>rd</sup> January**

The APCC will invite Police and Crime Commissioners to a national meeting on 23 January in central London. The programme for this event is currently being developed by the APCC, and other stakeholders will be invited to contribute depending on key priorities and issues identified by PCCs. The event will provide an opportunity for the PCCs and their staff to hear from a broad range of partners and stakeholders focusing on what works well, and what could be done to improve the provision of policing and crime reduction services within force areas.

In addition, the APCC will host a series of national briefing events and seminars throughout 2013 to provide an opportunity for a full range of stakeholders and partners to engage with PCCs on issues of interest. The full programme for these events will be published by the end of November on the APCC website. The APCC would like to hear from any organisation willing to contribute to these events from across criminal justice, policing and community safety sectors. ## **Police and crime panels update**

We know that many police and crime panels have been meeting in recent weeks to consider panel procedures and the potential for additional co-option. As additional co-option (beyond the required two independents) requires Home Secretary approval, any PCPs that have indicated they plan to co-opt and haven't yet submitted a formal request, are urged to do so as soon as possible.

The guidance note setting out the scrutiny process for chief constable appointments has recently been added to the police and crime panel section of the Home Office website:

Regulations setting out the existing local government legislation that will be applied to PCPs in Wales are expected to be laid before Parliament in the coming weeks.

### **Grant agreements**

Grant letters and agreements for the Police and Crime Panel Grant will be issued to host authorities shortly. Payment will be made in arrears. In 2012-13 host authorities will receive a single payment in March 2013.

### **Safer Future Communities – news from partners**

The National Council for Voluntary Youth Services (NCVYS) launched their Youth Charter on 11 October. The youth charter is about encouraging PCCs to pledge their engagement with young people, and to listen to their views in a meaningful way. It provides principles which PCCs may wish to work to, all of which have come from young people. A number of organisations have already pledged their support to the charter and on the day of the launch five PCC candidates signed up. A workshop was held recently with drugs sector representatives to identify what actions Drugscope could take forward as a partner in the Safer Future Communities. The objective of the session was to help support the delivery of approaches which tackle drug-related crime; from April 2013 the Drug Interventions Programme (DIP) will effectively end as a nationally managed and delivered programme.

### **Drug strategy - reducing demand and managing drug misusing offenders update**

The second bulletin in a series issued to keep local areas informed of work related to the management of drug misusing offenders has been published. This is in line with the "Reducing Demand" chapter of the Drug Strategy, and includes information for local areas on the links between the Drug Interventions Programme (DIP) and the new legislation on drug driving; links to the Integrated Offender Management conference report; an update on payment by results; an update on public health funding in 2013/14; and the latest drug treatment statistics from the National Treatment Agency.
