### Police and crime commissioners: Communications update

#### National Home Office PCC campaign

The Home Office will run a national awareness raising campaign about PCCs launching in early October. #### Candidate online booklet and print on demand

Work to produce the candidate online booklet and print on demand facility continues to progress. The website will be available in early October providing the public with the ability to sign up for an email alert which will notify them when full details of candidate addresses are available on the website. Police Area Returning Officers (PAROs) are responsible for ensuring that candidate addresses are available on the candidate website by 26th October. Hard copy booklets will also be available to pre-order when the print on demand call centre goes live early October. The website and call centre number will be promoted via the Home Office campaign as well as by the Electoral

Commission booklet that will be delivered to all households from 22nd October onwards. PAROs will also include information about these services on poll cards.

### **Electoral Commissions PCC elections campaign**

The Electoral Commission public awareness campaign for the PCC elections will launch on 22 October and run until polling day on 15 November. Activity will focus on:

- What the PCC elections are for and what powers PCCs will have;
- How to cast a ballot under the Supplementary Vote;
- When the elections are taking place; and
- How to access further information, including information about candidates.

Campaign activity will include:

- A booklet sent to all households in the 41 areas in England and Wales where the elections are taking place;
- A TV, radio and press campaign to raise awareness of the elections, alert people to the booklet that they will be receiving and provide details of the website and helpline where people can go to get further information on the elections and the candidate website/print on demand service;
- The campaign will direct people to further information on the elections at [www.aboutmyvote.co.uk](http://www.aboutmyvote.co.uk) or via the Commission's public information telephone helpline.

Templates for local authorities will also be made available to PAROs and LROs to run their own election awareness raising activity at a local level. The templates will be issued in stages on [www.dopolitics.org.uk](http://www.dopolitics.org.uk)

### **Police and Crime Panel veto Regulations**

The Police and Crime Panel (Precepts and Chief Constable Appointments) Regulations 2012 were laid before Parliament on Thursday 6 September. Those of you who may have seen an earlier draft version of the Regulations will note that some changes have been made.

Firstly, the draft precept setting timetable has been altered to ensure that the deadlines fit, as far as possible, with local budget decision timescales. The PCC will be required to inform the PCP of their proposed precept by 1 February. This will enable PCCs to base their precept proposal on more accurate funding information, whilst ensuring that the PCP has the opportunity to scrutinise the proposal.

Secondly, the PCP has a power to veto a proposed chief constable appointment. The PCC must then propose a reserve candidate for appointment. Changes to regulations have been updated so that the process for scrutinising a reserve candidate for appointment as chief constable includes the requirements for the PCP to hold a public confirmation hearing and publish its report to the PCC. This brings the process for scrutinising a reserve candidate in line with the process set out in the Act for the first proposed candidate, thereby ensuring that all candidates for appointment as chief constable are subject to the same level of scrutiny.

Short guidance notes explaining the legislation concerning each of the vetoes will be published shortly.

### **Update on Funding for Police and Crime Panels**

The Government has committed to provide funding to cover the costs of maintaining Police and Crime Panels. The host authority for a Police and Crime Panel in a police force area can receive annually up to:

- £53,300 for costs of administering Panels;
- £5,715 for Welsh language translation costs for Welsh Panels; and
- £920 for expenses per member (maximum 20 Panel members).

### 2012-13

In 2012-13 the amounts provided to host authorities will be adjusted pro-rata as Panels will be in operation for only part of the year. To reflect the costs host authorities and members will incur in setting up Panels so that they are ready for PCC arrival in mid-November, it has been agreed to adjust funding in 2012-13 back to 10th October.

Host authorities can receive half funding in 2012-13 to cover the period October to March:

- £26,650 for costs of administering Panels;
- £2,860 for Welsh language translation costs for Welsh Panels; and
- £460 for expenses per member (maximum 20 members).

The funding will be provided via a grant agreement, and will be paid in arrears in one payment in March 2013.

In future years the payment of the grant will be at least two payments per year.

### APCC National Event - 11th September

The APCC briefing event on PCCs held 11th September was a success; with over 150 delegates attending. The conference was featured in the [Evening Standard](#) and a story by the [Press Association](#). The BBC also covered the national briefing and interviewed several PCC candidates.

## **PCCs and Youth Justice**

**Marion Sandwell, of the Youth Justice Board, writes about the work of youth offending teams and planning for the future commissioning landscape.**

Youth offending teams (YOTs) (since their inception as statutory bodies) have been at the forefront of delivering preventative programmes for young people in the youth justice system, complemented by strong partnership working arrangements resulting in successes at local levels.

To ensure funding for targeted youth crime prevention services in their local areas can continue to operate under the new commissioning landscape, YOTs will have to engage with, and influence PCCs.

Since 2006/07 the youth justice system has witnessed a continual drop in the number of young people entering the youth justice system; custody and offences committed.

Many YOTs are actively working to prepare for PCCs, including:

- Establishing a “voice” within the transition boards working towards PCCs.
- Scoping their working arrangements to seek collaborative opportunities & streamlining of services.
- Working together in police force areas, rather than as individual YOTs.
- Partnership priorities and the potential opportunities for involvement of the PCC.
- Reviewing how potential candidate priorities will affect programme and funding arrangements.
- How to assist PCCs to understand the needs of local people, using existing engagement mechanisms.

YOTs together with their partners (VCSE, Police) have been at the forefront of rehabilitating young people in the youth justice system; stopping first time entrants in; reducing re-offending; reducing the numbers of young people in custody - none of which would have been achievable without concerted efforts at working to come up with evidence based youth crime prevention programmes.

## **YOTs in Wales**

YOTs in Wales have taken a collaborative approach both regionally and nationally to ensure their strategic objectives are embedded in their local police authority plans.

The Wales Youth Justice Advisory Panel, which acts as a strategic, multi agency reference group for youth justice services across Wales and is jointly chaired by Welsh Government and Youth Justice Board, continues to support closer strategic links with the police across Wales, working in partnership with the Association of Chief Police Officers Cymru to support and widen the use of police led restorative alternatives to charging.

## **News from Safer Future Communities**

### **WCVA update**

Safer Future Communities events have taken place in all police force areas of Wales with contributions from the Home Office, police authorities, Safer Future Communities and the lead County Voluntary Council. These events have enabled diverse networks of third sector organisations involved in community safety work that are coterminous with each of Wales' 4 PCC areas to be formed. The events included a World Cafe session based on a SWOT analysis around community safety priorities looking at the sector's strengths, weaknesses, opportunities and threats in the context of the transition to Police and Crime Commissioners. The networks will be an important point of contact between the third sector and Police and Crime Commissioners.

### **National Conference on Integrated Offender Management (IOM): July 2012**

The Home Office hosted a national conference on Integrated Offender Management (IOM), which included a strong focus on the role of Police and Crime Commissioners on 3<sup>rd</sup> and 4<sup>th</sup> July 2012, at the National Policing Improvement Agency, Ryton-on-Dunsmore, near Coventry. The event attracted around 200 delegates from a range of partnership agencies, including police, probation, prisons, local authorities and the voluntary sector.

Contributions came from a range of keynote speakers including the then Minister for Policing and Criminal Justice, Nick Herbert, MP, Stephen Greenhalgh, the London Deputy Mayor for Policing and Crime, Juliet Lyon, CBE, Director of the Prison Reform Trust, and senior representatives from the Home Office, Ministry of Justice, Association of Chief Police Officers, Probation Chiefs' Association, Local Government Association and Voluntary Sector.

One of the key aims of the conference was to help areas maximise the contribution that IOM can make locally to reducing crime and re-offending, and to consider this in the context of the Government's criminal justice and health reforms, including the arrival of Police and Crime Commissioners.

The conference set out some of the opportunities that IOM offered moving forward, including expanding the partnership base by maximising voluntary sector involvement and expanding the local model to include a more definite focus on preventing onset and escalation of offending.
