1. This memo gives guidance on the Social Security (Income and Capital Disregard) (Amendment)

Regulations 2023<sup>1</sup> [SS (I&C Dis) (Amdt) Regs 2023], SI 2023/640. The changes take effect from 9.7.23.

## **Background**

2. These regulations<sup>1</sup> ensure that certain payments are disregarded for the purposes of calculating entitlement to UC.

- 3. These regulations<sup>1</sup>
  - 1. Expand the existing disregard for Grenfell Tower payments
  - 2. create a new disregard for Post Office compensation payments, and
  - 3. Ensure that partners of persons in respect of whom a payment under the relevant legislation<sup>2</sup> is made are covered by a disregard.

- 4. These amendment regulations also provide that
  - 1. Grenfell Tower payments and

## 2. Post Office compensation payments

will be exempt from the Department's compensation recovery scheme<sup>2</sup>. This means that compensation payments will not be reduced.

**Note**: Payments made under relevant legislation<sup>3</sup> to or in respect of the injured person are already exempt.

## Capital and income disregards for UC

5. These regulations<sup>1</sup> provide that any Post Office compensation payment<sup>2</sup>, Grenfell Tower payment<sup>3</sup>, or vaccine damage payment<sup>4</sup> if it is capital, is to be disregarded indefinitely in the calculation of the person's capital and, if it is income, is to be disregarded in the calculation of the person's income.

#### **Vaccine Damage Payments**

6. In relation to vaccine damage payments the disregard at paragraph 5 applies where

- a person who is severely disabled as a result of vaccination receives a payment under relevant legislation or
- 2. the partner of a person referred to in 1. receives a payment which is derived from
  - 1. that payment from that person **or**
  - 2. their estate or
- 3. the payment is made to the personal representative of a person who was
  - 1. severely disabled as a result of vaccination or
  - 2. to their partner from their estate.

Note: In these regulations: -

"Post Office compensation payment" means a payment made by the Post Office or the Secretary of

State for the purpose of providing compensation or support in respect of the failings of the Horizon

System or the detriments identified in the judgment in Bates and Others v Post Office Limited [2019]

EWHC 606 (QB)

"Grenfell Tower payment" means a payment made for the purpose of providing compensation or support

in respect of the fire on  $14^{th}$  June 2017 at Grenfell Tower

"vaccine damage payment" means a payment under the Vaccine Damage Payments Act 1979.
