I can confirm that we hold some of this information. The Registrar General records those places of worship certified to him under the provisions of the Places of Worship Act 1855. I am attaching to this response a listing of those places relating to Bedford, Essex, Hounslow and Norfolk. We list the places in registration district order, and thus the places for Feltham will be within Hounslow, and those for King's Lynn and Norwich within the listing for Norfolk. The list does not record telephone or email contacts, and any disclosure of contact name would in any case contravene data protection provisions and be exempt from disclosure under section 40 of the Freedom of Information Act - disclosure of personal information. You may however find that using the list provided with this response will enable you to find further details via an internet search facility such as Yellow Pages.

The Registrar General does not receive such certification from the Church of England.
