Thank you for your correspondence dated 19 August 2009 which has been considered to be a request for information in accordance with the Freedom of Information Act 2000. I sincerely apologise for the administrative oversight that has caused the delay in responding to your request.

You requested the following information:

- 1. the amount of positive results to Compulsory Drug Tests (CDT) in 2005, 2006, 2007, 2008 & 2009 with respect to a) Army b) Navy c) Air Force.
- 2. Figures/numbers of dishonourable discharges as a result of CDT for 2005, 2006, 2007, 2008 & 2009 with respect to a) b) & c).
- 3. A breakdown of types of substances being recorded in the event of a positive CDT in respect of a) b) & c).

The number of CDT Results and subsequent discharges from 2005 to 2009; including number tested, number of positive results, and type of drug is displayed in the tables at Annex A.

The Armed Forces drug misuse policy is that the misuse of drugs is inconsistent with Service life and our policy can be described as 'zero tolerance'. Although any Serviceman/woman found¹ to have been taking drugs can expect to be discharged, 'zero tolerance' does not bind the Forces to discharge as its only response to drug misuse. If there are 'exceptional circumstances' and the chain of command can provide a justification for the unusual response of retention then it will be considered.

The number of Service personnel who were discharged after failing drugs tests includes those who may have tested positive following tests carried out by other official bodies (such as civilian police), as well as those carried out by the CDT team. The figures include personnel who would have been administratively discharged as a result of a failed drugs test but were awaiting court-martial for another offence. Conviction at Court Martial will take precedence over an administrative discharge.
