Dear XXXXXX,

Thank you for your correspondence, dated 20 August 2010, which has been considered to be a request for information in accordance with the Freedom of Information Act 2000. Your request has been passed to my department and I have been asked to respond.

You asked the following question:

"Please could you send me details of all the service personnel who have gone AWOL in the past ten years, all those who have subsequently been prosecuted for desertion and the sentences they have been given and where they have been detained?"

Statistics on personnel categorised as absent without leave (AWOL) are recorded by the number of incidences reported. Within this total, therefore, there may be Service personnel who have been AWOL on more than one occasion. Furthermore, following the reporting of an incidence of AWOL, information may later come to light of extenuating circumstances, such as for compassionate reasons, hospitalisation or travel delays beyond the individual's control. In such cases they may not have been formally charged but the incidence is still recorded.

Please find below tables from each of the three Services detailing the figures requested with any explanations required at the bottom of each of the tables.

Periods of unauthorised absence by RAF Service personnel are recorded as AWOL (and not desertion) until the reason for their absence can be determined (i.e. if the intention was to desert). Individuals charged with desertion are dealt with by Court Martial. Between 1999 and August 2010, two RAF Personnel have appeared at Court Martial facing charges of Desertion. Of these, one RAF Service person was charged with Desertion but not convicted in 2002, and, one RAF Service person was convicted at Court Martial of Desertion in 2005. This individual was dismissed from the Service and awarded 6 months detention at the Military Corrective Training Centre Colchester.
