

# Natural Environment White Paper Implementation Update

**19 December 2012** 

The Natural Environment White Paper, *The Natural Choice: securing the value of nature*, was published on 7 June 2011. This fifth update reports activity since July 2012.

Since July, we've made progress on a number of fronts as Government Departments and agencies, business, landowners, local authorities, environmental organisations and others all work together to meet the ambitions in the White Paper.

Highlights since July include the announcement of a further 7 Local Nature Partnerships, bringing the total to 48, the Ecosystem Markets Task Force has released its interim report, Lord de Mauley gave the key-note speech at the Integrated Habitats Design Competition, and Minister Richard Benyon led the UK delegation to the 11<sup>th</sup> meeting of the Convention on Biological Diversity in Hyderabad.

### **Progress on ambitions**

The White Paper set out four ambitions. Highlights of progress since July on commitments to deliver the ambitions follow.

## Protecting and improving our natural environment

We've recognised an additional 7 Local Nature Partnerships (LNP) in September, bringing the total to 48. This key commitment in the Natural Environment White Paper, LNPs herald new ways of doing things locally and some are now beginning to establish themselves in their areas. Some have held their inaugural meetings or launches, others are putting their permanent governance arrangements in place whilst others are starting to engage seriously with other sectors about local priorities. A major advantage for LNPs will be to talk and work together.

LNPs are locally formed for the benefit of local areas. However Defra hopes to build a close mutual relationship with the network of LNPS across the country so that, by LNPs acting on local priorities, they will prove a really valuable way of helping us to deliver our national priorities. We brought all LNPs together in October with the aim of initiating not only that valuable relationship but also useful networking amongst LNPs. (Commitments 4-6). See:

The twelve government-funded **Nature** Improvement Areas (NIAs) which started work in April are making good progress. These initiatives are landscape-scale in nature, and aim to ensure that land is used sustainably to achieve multiple benefits for people, wildlife and the local economy. The £7.5m invested by Government has generated £43m in funding & in-kind support from a range of sources. For example, Birmingham & the Black Country NIA has secured funding from Carillion to re-plant on a site of ancient woodland in Park Hall Nature Reserve; and Dearne Valley Green Heart NIA has secured £1.8 million from HLF's Landscape Partnership programme (Commitments 8-11). We have been continuing with our review of the role of industry-led initiatives in meeting environmental outcomes (Recommendation 18). On 22<sup>nd</sup> November, the 2012 Review of the Greenhouse Gas Action was published (http://www.defra.gov.uk/environment/cl imate/sectors/agriculture/) which measures progress towards targets (benefiting both the environment and farming efficiency). This and other work assessing partnership approaches has contributed to some emerging conclusions that we have discussed with stakeholders. The research covering the Campaign for the Farmed Environment will be published in the New Year and a full report responding to the recommendation, indicating where voluntary approaches are most applicable and what factors help drive their success, is on track for March (Commitment 18).

Our improvements to the options for the Entry Level Stewardship scheme submitted to the European Commission in November 2011 to make **Environmental Stewardship more** effective (MESME) have been approved. IT changes are in hand for implementation from 1 January 2013, and new scheme handbooks detailing new/changed options have been available to applicants from Natural England since mid-October for agreements coming into force from January. By November, Natural England had published the first 23 profiles of England's 159 landscape character areas. Each profile identifies the

environmental potential of landscape areas, to inform national policies such as agri-environment schemes and help local communities and planners to make informed decisions about land use. (Commitment 24). See:

There has been good progress in developing the approach to **catchment level partnerships.** The findings are being evaluated form **the 66 pilot catchments** as we approach the end of our pilot phase. This will inform decisions on wider adoption from April 2013.

## Growing a green economy

In July, the Office for National Statistics and Defra launched a consultation on how we fully include **natural capital in UK national accounts.** A Stakeholder

workshop to discuss priorities for ecosystems accounts was held on 22 October (Commitment 35).

The independent Natural Capital
Committee is up and running and has
now held four meetings. It will be
advising Government on where natural
capital is being used unsustainably
through an annual state of natural
capital report – with the first to be
published in Spring 2013. The
Committee has given advice to the
Defra Secretary of State on several key
policy issues and has held its first
public event, hosted by the Royal
Society (Commitment 36). See:

The Green Infrastructure Partnership (GIP) was gold sponsor of the Integrated Habitats Design Competition conference and awards ceremony which celebrated projects demonstrating why integrating nature is good for biodiversity, neighbourhoods, business and climate change adaptation. Defra Minister Lord de Mauley has written a letter in support of Kielder Water & Forest Park's application for Dark Sky Park status and Northumberland National Park's application for Dark Sky Reserve status. Lord de Mauley's letter will form part of the Parks' application to the International Dark-Sky Association (IDA) (Commitment 70).

The consultation on simplifying and streamlining the processes for recording and making changes to public rights of way closed on 6 August. The results are being analysed (Commitment 72).

The VisitEngland destination managers resource has been launched and is currently being populated with content. This covers a variety of guidance and support information relating to destination management, including visitor gifting schemes. VisitEngland is working with Nurture Lakeland, who have recently launched a national framework for visitor gifting schemes and are developing tools and supporting materials for developing local programmes(Commitment 74). A new *My Environment* portal is due to be launched at the end of 2012 making it easier for people to find environmental information across a range of Web sites. This will be supplemented by a new environmental mapping service replacing the existing

MAGIC service in April 2013 with further developments to respond to user feedback once the services are live (commitment 78).

To encourage the **consumption of** underutilised sustainable fish **species**, the scoping phase of a project to explore how a communitysupported fishery model linking consumers up more closely with local fishermen can promote the use of these fish species, has now completed and three communities in (in Brighton, Chichester and Horsham) have been chosen to take part in the Community Supported Fishery. #### International and EU leadership

To contribute to **implementation of the** Nagoya agreement at the international level, Minister Richard Benyon led a UK delegation from across Whitehall at the 11th meeting of the Convention on Biological Diversity in Hyderabad where we secured decisions on many different biodiversity related issues, including; mobilisation of resources for implementing the Strategic Plan for Biodiversity 2011-2020; designating Protected Areas & designating Ecologically and Biologically Sensitive marine Areas; and advice on applying biodiversity safeguards to Reducing Emissions from **Deforestation and Forest Degradation** (REDD+) (Commitment 82). # Monitoring and reporting progress

Membership of the **Ecosystems Knowledge Exchange Network** has reached 560 people throughout the UK, representing a range of private, public, charity and academic sector organisations with interests in an ecosystems approach.

The Network website has been expanded with new project examples and sections and links to a wide range of tools, and guidelines to assist land and marine management projects apply an ecosystems approach in their work.
