PCC BULLETIN

This sixteenth bulletin is the latest in a series of regular updates to keep partners and the office of the PCC informed about issues of interest in the police reform landscape following the election of police and crime commissioners. These bulletins will continue now that PCCs are in post, and this edition includes:

Precept setting

The PCC will set their final precept level by 1st March. The deadline for PCCs to propose their policing precept to their police and crime panel was the 1st of February. PCCs have made a range of proposals across the 41 police force areas about their proposed levels of precept, with 29 announcing that they plan to increase the policing precept and 12 confirming that they plan to maintain the current level.

In England, none of the proposed increases are above the excessive limit that would trigger a referendum, and several proposed precepts have already been supported by their police and crime panels. The PCC will set their final precept by 1st March.

Police and crime plans

Many PCCs are now well into the process of drafting their police and crime plans. In order to develop their plans the PCC must consult the public, in particular victims. The plan must also be scrutinised by the police and crime panel before it is issued, although there is no set timetable for this.

PCCs have been taking forward this consultation in a variety of ways. The West Mercia PCC held a live webcast, including Q&A, on his draft plan and precept, with the chief executive and chief finance officer also taking part. MOPAC has held consultation events on its draft plan in each of the London boroughs.

31st March is the deadline for PCCs to issue their police and crime plans.

Community Safety Fund

In 2013-14 PCCs will receive some funding from a new and temporary Community Safety Fund (CSF). Allocations from the CSF to PCCs were communicated on 19th December in a Written Ministerial Statement made to Parliament by the Minister for Policing and Criminal Justice.

The Home Office will shortly issue a communication providing more details about the funding streams ending in March 2013. Grant letters and agreements for the Community Safety Fund will be issued to PCCs and the Mayor's Office for Policing and Crime (MOPAC) shortly.

National Crime Agency

The National Crime Agency (NCA) Programme continues to make significant headway on the build of the agency, in collaboration with precursor agencies and partners, to ensure it is fit for purpose on day one and there is a seamless transition of operations, officers, assets and resources.

The Crime and Courts Bill - which will provide the legal basis for the NCA, including its functions, powers, tasking and assistance, information sharing, governance and scrutiny arrangements - was introduced in the House of Commons on 19 December. The Bill has completed Commons Second Reading and is currently in Committee stage. Subject to the will of Parliament the Bill is on track to receive Royal Assent in spring 2013, which would enable the NCA to become operational by the end of the year.

There has been further progress on shadow functions and operations, which are testing how the NCA will operate in the run up to it becoming fully operational. There have also been further senior team appointments; Gordon Meldrum and Tim Symington are now in post as Director Designate of the Organised Crime Command and Director of Intelligence (Home Office Programme Team). We expect to announce the Director Designate of the Economic Crime Command and to advertise the position of Deputy Director General shortly, and interviews for the Head of the National Cyber Crime Unit have now taken place.

Transforming Rehabilitation: A revolution in the way we manage offenders

The Ministry of Justice published this consultation paper on 9 January. It sets out the Government's intended approach to driving down the rate of reoffending and delivering better value for the taxpayer, by opening up rehabilitation services for offenders in the community to a mix of private, voluntary and public providers, paid by results to drive down reoffending. The proposals include extending rehabilitation to those released from short custodial sentences, the great majority of whom currently receive no statutory probation support. There will be a continuing critical role for the public sector in advising the courts and assessing the risk that offenders pose to the public. The proposed reforms are intended to encourage innovation and to focus on what works in driving down reoffending rates.

These are in addition to events that are being organised for Police and Crime Commissioners collaboratively with the Association of Police and Crime Commissioners.

The consultation runs until 22 February.

Police Custody Healthcare Transfer

Currently 33 police forces in England have entered local, voluntary arrangements to transfer their custody healthcare and sexual assault referral centre (SARC) provision to the NHS. As part of this programme Greater Manchester Police (GMP), in partnership with the Regional Offender Health Team (ROHT) are currently developing a set of national commissioning templates and service specifications for custody, counter terrorism units (CTUs) and ITT documentation. These templates will be available for all police forces and partnerships to adapt and make local variations of from March 2013.

Health and Policing

As part of a series of themed events the APCC will be running a national briefing event on 21 March for PCCs on the issues of health, as it relates to policing. This event is likely to be held in Birmingham and will hopefully provide PCCs with an opportunity to hear about and discuss some of the latest developments and opportunities within the new landscape following the introduction on the 'Health and Social Care Act 2012'.
