1. PCC quarterly meeting

April saw the second scheduled meeting of PCCs and Ministers, held at the Home Office HQ in London. Several sessions also took place before, including an informative session on the current health reforms.

The meeting was attended by the Home Secretary, Minister of State for Policing and Criminal Justice, and the Minister for Crime Prevention with focussed and positive interaction between Minsters and PCCs on issues of mutual concern. Stage 2 staff transfers, how the police interact with individuals with mental health issues, complaint handling, and force inspections and investigations featured in discussions, along with other topics including transparency and accountability and Regional Organised Crime Units. The next meeting is scheduled for July.

2. Association of Police and Crime Commissioners (APCC)

All police and crime commissioners and police governance bodies in England and Wales have chosen to be members of the Association. A Chairman and Board of Directors were appointed at the AGM held in March and the APCC is now in the process of reviewing its business plan for the year ahead. In summary, the Association will deliver the following:

- Provide its members with an opportunity to come together, network and have a collective voice
- 2. Enable and coordinate the collective influence of its members
- 3. Provide support to its members, helping them to achieve economies of scale through a one-stop-shop for advice and support
- 4. Provide its members with timely, relevant information
- 5. Support local partnership working through a Strategic Partnership with the Local Government Association

The APCC will run a programme of events throughout the year, some of which will be open to partners to attend. The next of these events will be held on 20th June on 'Working with the Voluntary Sector'. Please visit the APCC website for further information. 3. Update on funding for police and crime panels

Funding levels for the police and crime panel grant are maintained in 2013-14. Host authorities can receive funding in 2013-14 to cover the period April 2013 to March 2014:

- £53,300 for costs of administering panels
- £920 for expenses per member (maximum 20 members)
- £5,715 translation costs (Welsh panels)

Grant letters and agreements will be issued to host authorities during May. Payment will be made in arrears in four quarterly payments in 2013-14.

4. Police Custody Healthcare Commissioning Template

The police custody healthcare commissioning template has been funded by the Home Office and jointly produced by Greater Manchester Police and the North West NHS Offender Health Local Area Team. The template can be used to support police forces and NHS commissioners looking to transfer their police custody healthcare and sexual assault referral centre (SARC) provision to the NHS. It can be used as a core document which can be amended and adapted by local partnerships to suit their local requirements and needs. The template and accompanying service specifications will be made available to all police forces in England and Wales and NHS offender health commissioners from May 2013.

5. Payment by results for drug and alcohol recovery

The Home Office, together with the Ministry of Justice and Department for Health have been piloting if payment by results for drug and alcohol recovery – including outcomes for reduced crime and offending - rather than activity can achieve better outcomes. Eight pilot areas have been live for a year and a full evaluation of them is due to be published in 2014. At the same time we are working closely with other local commissioners who want to use payment by results in this field. We have been sharing the lessons learnt from the development and implementation of the pilots, as well as some of the early findings. We have also held two tools workshops so that local commissioners can start to become familiar with the tools we have developed to turn their local models into payment structures.

On 20th May we will be holding a third workshop in London. This workshop will be specifically focused on those areas who are already implementing payment by results. The day will give central government and local commissioners the chance to learn from each other, and help develop more efficient payment by results models. We will also be looking at drug misusing offenders and showing how commissioners can use the data we will be making available this year to pay providers based on a reduction in proven offending by those in drug and alcohol treatment. We think the workshop would also be of use to PCCs who are interested in commissioning drug treatment services, and would like to find out more about payment by results and how they can use it. 6. Safer Future Communities

Home Office funding for Safer Future Communities came to an end on 31st March 2013. The project has worked over the last 18 months to support the development of Voluntary, Community and Social Enterprise (VCSE) networks across England and Wales to engage with and influence PCCs. A number of local Safer Future Communities networks have successfully secured funding from their PCC. The final evaluation report of the project has now been published and can be read here.

The project has also produced a film outlining the role of the VCSE in addressing the wide range of community safety needs and the role of local Safer Future Communities networks in supporting these activities. You can view the film here.

National Council for Voluntary Youth Services have collated a series of case studies highlighting good practice of PCCs engaging with young people. These can be found on the PCC <u>Youth</u> Charter website

Safer Future Communities are producing a guide to ensure commissioning and procurement procedures provide the VCSE with a level playing field to bid for and deliver community safety activities. The guide will be published on Safer Future Communities <u>webpages</u> in May 2013 and will be presented at the PCC meeting in July.

9. National Crime Agency

There are now just five months to go until the National Crime Agency goes live in October.

The Crime and Courts Bill, which will provide the legal basis for the NCA, completed its passage through the House of Commons in March and received Royal Assent on Thursday 25 April.

Jeremy Outen has been appointed Director Designate of the NCA's Economic Crime Command. He joins the NCA from KPMG, where he has been a forensic accountant for 21 years, investigating fraud and economic crime cases in the UK and overseas. We expect to appoint the Deputy Director General shortly.

We are moving further in to shadow working to test how the NCA will operate before going fully live, and shadow operations with partners continue to produce real results. We are also testing 'organisational readiness', for example legal and accountability requirements, HR, finance, IT, security and communications.

The UKBA CFI (border) team have moved in to the Home Office on their way to the NCA, and we are in the process of looking at how they will operate in the NCA after go live.

10. Spreading Whole Place Community Budgets

Momentum is building with Community Budgets. Communities and Local Government Minister Brandon Lewis MP recently wrote to Local Authority Leaders to ask for expressions of interest from areas who would like to adopt the Community Budget approach. Whilst the letter is addressed to Local Authority Leaders, the hope is that leaders from across the wider local public service landscape will step forward to express an interest.

Community Budgets are already being piloted in four areas – Cheshire West and Chester, Essex, Greater Manchester, and the London Tri-boroughs (Westminster, Hammersmith and Fulham, and Kensington and Chelsea). Before PCCs were elected, the pilot areas engaged with PCC candidates (and the London Tri-boroughs have been engaging with MOPAC). This engagement has continued. Expressions of interest are now being received by the Department for Communities and Local Government from Local Authorities, but expressions of interest would be very welcome from PCCs too. Government is keen to take the opportunity to include and involve PCCs in this process, as they are uniquely well placed to stimulate the kinds of conversations across a broad range of partnerships that could benefit – and benefit from – the Community Budget approach.

11. Integrated Offender Management survey

The Home Office has developed a short on-line survey which aims to provide a quick snapshot on the spread and reach of Integrated Offender Management (IOM) arrangements across England and Wales.

The survey has been directed through Community Safety Partnerships. Completion is entirely voluntary, and a communication has gone out to all partnerships inviting them to take part.

The survey serves two important functions: firstly, it will improve our collective knowledge of the spread of IOM arrangements across England and Wales; and secondly, it will help to inform the forward approach to support the continued development of IOM in local areas.

The survey is voluntary, but the more partnerships that do take the time to complete it, the greater the value of the findings. The Home Office will share these findings by publishing a short, anonymised summary report on the GOV.UK website.
