The Department anticipates commencing the procurement of ICT and related services with the publication of an OJEU contract notice on 1.2.2013 or earlier. This procurement shall include but not be limited to the DVLA and supports the Agency's vision "to be a modern, highly efficient organisation, which provides complete, accurate and up to date information and services that fully meet customer and stakeholder requirements". Following publication of an OJEU notice, the Department will invite expressions of interest from potential bidders for a single contract or range of work packages by submission of a pre-qualification questionnaire ("PQQ"). The PQQ shall be available following the publication of the OJEU notice and in line with the Department's procurement plan. It is anticipated that shortlisted suppliers shall engage with the Department in either competitive dialogues and/or restricted procedures from early 2013 to mid 2014. A decision on the procurement process(es) will be made following a market sounding exercise and development of the DVLA's ICT and related services procurement strategy by mid 2012. It is intended to announce the award of contract(s), expected to be for 7 years with options to extend for up to a further 3 years, in early 2014 and for different elements of the contract(s)

to start during 2014 and 2015. In 2010/11 the DVLA's ICT services had a supplier revenue of approximately 160 000 000 GBP. The estimated costs outlined in Section II.3 are subject to change in light of a market sounding exercise, procurement strategy and the scope of activity to be procured.

Before publishing an OJEU contract notice the Department wishes to undertake consultation with the market by way of a market sounding exercise with small, medium and large size enterprises in late 2011 or early 2012. The market sounding exercise will not influence the selection of bidders but aims to assess the feasibility of requirements and work package(s), capability of the market as a whole to achieve what is required, maturity of the market to ensure a competitive procurement, capacity of the market to deliver what is required and identify potential risks. The Department encourages open, fair and transparent procurement and omission from any part of the Department's market sounding exercise shall not be taken into account in any subsequent bidder selection or tender evaluation process.
