ELECTRICITY MARKET REFORM: SMOOTHING THE TRANSITION TO THE CFD

WORKING GROUP 1, SAMPLE CONTRACTS

TERMS OF REFERENCE

Objectives:

- To enable market participants to understand the likely commercial arrangements for the sale of electricity through Power Purchase Agreements compatible with the CfD.
- To reduce barriers to participation at the outset of the scheme; reduce costs for the first movers; and improve investor confidence in the PPA market under CfD.

Output:

Sample PPA contracts which are compatible with the CfD and would provide the basis for commercial negotiations.

Milestones:

May – paper on resource requirements

July/August – draft Heads of terms

December – Final sample contracts

Governance:

The Working Group will be chaired by Chris Hemsley/Phil Hicken and will report to the Smoothing the Transition Steering Board, which will have overall responsibility for the progress of the Working Group. The WG will produce papers for the Steering Board's consideration and the chair of the WG will attend SB meetings to discuss progress, accompanied by key members of the WG as appropriate.

Meetings:

We envisage that the Working Group will meet approximately every month during 2013 to discuss progress and agree the next steps. All meetings will be held at DECC's offices in central London, and are expected to last around 90 minutes.

Papers:

DECC will aim to circulate relevant material in advance of each meeting to allow for preparation where appropriate.

WG members will be required to handle any papers with discretion and are requested to not share papers widely with colleagues or outside their organisation.

Transparency:

Draft minutes of the meetings will be circulated to all WG members and DECC will publish final minutes on the internet. Members are welcome to distribute minutes of the meetings to any interested parties.

Discussion papers will also be published on the internet.
