# Background

*Pathways to Work* is an initiative aimed at improving opportunities for people on incapacity benefits<sup>1</sup>. The process involves a series of mandatory Work Focused Interviews (WFIs) together with the Choices package, which is a range of provision aimed at improving labour market readiness and opportunities. *Pathways to Work* is primarily aimed at new incapacity benefits customers but is also available to existing customers on a voluntary basis.

Following the initial Work Focussed Interview (WFI) with Jobcentre Plus (JCP), customers are referred on to the local Provider, on a mandatory basis, to attend the further five WFIs at four week intervals (as long as they remain on IB or ESA).

# Methodology

The source of this data is the Provider-Led (PL) Pathways database, which is used to produce the quarterly PL Pathways publication:

As in the PL Pathways official statistics publication, jobs are only counted where the job start occurs within 91 days of a customer's last contact with a provider, or with JCP if they find a job before being referred to a provider. Jobs occurring after this period are not counted. The mandatory activity takes on average around 10 months from Pathways start. This means that the majority of jobs recorded within this data are obtained within one year and therefore the average time it takes a Pathways customer to find work may appear lower than would otherwise be expected.

## Main Findings

For customers starting Pathways between 1<sup>st</sup> April 2008 and 30<sup>th</sup> September 2008, the mean time to starting employment for those that do find work is just over 7 months (220 days). The median is less than the mean at just under 6 months (174 days). This indicates that over two-thirds of those finding employment do so before 220 days, and that there is a long tail to the distribution with some customers still starting employment over 2 years after their Pathways start.

The average time from Pathways start to employment is longer for PL Pathways customers than it is for JCP Pathways customers (see JCP report at [http://statistics.dwp.gov.uk/asd/asd1/adhoc\\_analysis/2011/Pathways\\_Average\\_Time\\_To\\_Employment\\_Condition.pdf](http://statistics.dwp.gov.uk/asd/asd1/adhoc_analysis/2011/Pathways_Average_Time_To_Employment_Condition.pdf)). This is due to the additional process within PL Pathways of referring a customer to a provider after the initial WFI with JCP. In total this process can take on average 13 weeks from Pathways start to a customer registering with a provider.

In the most recent financial year for which data is available (2008/09), the average proportion of customers who found employment within one year of starting Pathways was 14%. There is a large variation by impairment type, ranging from highs of 18% for those whose main disabling condition is “neoplasms” or “injury, poisoning and certain other consequences of external causes”, down to a low of 5% for those whose main condition is “pregnancy, childbirth and the puerperium”.

PL Pathways rolled out in two phases, with the first phase starting in 15 JCP districts on 3<sup>rd</sup> December 2007 and the second phase starting on 28<sup>th</sup> April 2008 in the remaining 16 districts not already covered by JCP or PL Phase 1 Pathways. It is therefore not yet possible to look at the proportion of customers finding work within three years of Pathways start, as was done with the corresponding JCP report.

## Results

There is a large difference between the mean and median time difference between Pathways start and employment start. This is due to numbers of individuals with large time differences, which has skewed the value of the mean.

By medical condition, there are also large variations in the average time difference between Pathways start and employment start.

<sup>2</sup> Primary medical condition information is based on the International Classification of Diseases (ICD), 10th Revision, published by the World Health Organisation. ICD10 code is not available those claiming IS (with a disability premium) only, or if we are unable to match to a benefit claim.
