# THE MANUAL OF THE LAW OF ARMED CONFLICT (JOINT SERVICES **PUBLICATION 383) – AMENDMENT 6**

8. In paragraph 12.4.1, lines 6 to 11, delete "The following definition of aircraft in certain annexes to the Convention on International Civil Aviation 1944 (the Chicago Convention), 'Any machine that can derive support in the atmosphere from the reactions of the air other than the reactions of the air against the earth's surface' excludes hovercraft." Insert "The following definition of aircraft is adopted in certain annexes to the Convention on International Civil Aviation 1944 (the Chicago Convention): 'Any machine that can derive support in the atmosphere from the reactions of the air other than the reactions of the air against the earth's surface'. This excludes hovercraft." Retain footnote annotation 5.

- 9. In footnote 5, delete text and insert "J David McClean (ed), *Shawcross and Beaumont Air Law* (2011) IV-1."
- 10. In Table 12.1, in the third column, delete the brackets around "flying machines". In the fourth column, delete "Aeroplane (Self-launching)" and "Motor glider". Insert "Aeroplane (Self-launching motor glider)".
- 11. In paragraph 12.6, after "private service.", insert footnote annotation 6bis. Delete "(Definition adapted from the San Remo Manual)." Insert new footnote, "6bis Adapted from SRM 13(m)."

12. In paragraph 12.6.2, line 1, delete "Civil" and insert "During armed conflict, civil".
