Special Grants for 1996/97

Introduction

1. This Report is made by the Secretary of State for the Environment ('the Secretary of State') and laid before the House of Commons, under section 88B of the Local Government Finance Act 1988 ('the 1988 Act'), as substituted by paragraph 18 of Schedule 10 to the Local Government Finance Act 1992. It specifies determinations concerning special grants for two purposes which the Secretary of State proposes to pay to certain authorities in England.

2. This Report specifies the Secretary of State's determinations of the authorities to which the grants are to be paid, the purposes for which the grants are to be paid and the amounts to be paid to each of the authorities concerned. It also sets out such explanation as the Secretary of State considers desirable of the main features of these determinations.

3. Before making the determinations the Secretary of State obtained the consent of the Treasury.

The Purposes

4. Pursuant to section 88B(3)(b) of the 1988 Act, the Secretary of State hereby determines the following purpose for which special grants are to be paid:

to provide compensation ('SSA reduction grant (SSA Review)') to relevant local authorities in England whose entitlement to Revenue Support Grant for the financial year 1996/97 under the Local Government Finance Report (England) 1996/97 ('the 1996/97 Report') will be reduced by:

- (i) changes to the methodology for calculating standard spending assessments ('SSAs') (excluding the element for police) for 1996/97; or
- (ii) the incorporation of 1991 Census information and changes to the methodology for calculating SSAs for 1994/95.

5. Pursuant to section 88B(3)(b) of the 1988 Act, the Secretary of State hereby determines the following purpose for which special grants are to be paid:

to provide compensation ('SSA reduction grant (Police Funding Review)') to relevant authorities providing police services in England and the Receiver for the Metropolitan Police District whose entitlement to Revenue Support Grant for the financial year 1996/97 under the 1996/97 Report and to police grant for the financial year 1996/97 calculated for them under section 5 of the Police Grant Report (England and Wales) 1996/97 ('the 1996/97 Police Grant Report') would be reduced by:

- (i) changes to the methodology for calculating the police element of SSAs for 1996/97 and the amounts of police grant for 1996/97; or

- (ii) changes to the methodology for calculating the police element of SSAs for 1995/96 and the amounts of police grant for 1995/96.

Amounts Payable to Authorities

6. Pursuant to section 88B(3)(a) and (c) of the 1988 Act, the Secretary of State hereby determines as the authorities to which SSA reduction grants (SSA Review) are to be paid and the amount of each grant, the authorities whose areas are listed in Part I of Annex A and the amounts in respect of those authorities shown in Part I of that Annex.

7. Pursuant to section 88B(3)(a) and (c) of the 1988 Act, the Secretary of State hereby determines as the authorities to which SSA reduction grants (Police Funding Review) are to be paid and the amount of each grant, the authorities whose areas are listed in Part II of Annex A and the amounts in respect of those authorities shown in Part II of that Annex.

Main Features

8. Annexes B and C contain such explanation as the Secretary of State considers desirable of the main features of the determinations specified in this Report.

Annex B

SSA Reduction Grant (SSA Review)

1. Under the 1996/97 Report authorities' SSAs for the financial year 1996/97 would be affected by changes to the methodology for calculating SSAs. These changes would affect the amount falling to be paid to them by way of Revenue Support Grant for 1996/97.
2. Grant is to be paid to compensate any authority whose SSA for 1996/97 will be more than 2 per cent. below the amount of its SSA for that year if it had been calculated on the basis of the methodology set out in section 4 of the Local Government Finance Report (England) 1995/96 as approved by the House of Commons on 1 February 1995 ('the 1995/96 Report'), adjusted for certain factors.
3. Under the Local Government Finance Report (England) 1994/95 as approved by the House of Commons on 3 February 1994 ('the 1994/95 Report'), authorities' SSAs for the financial year 1994/95 were affected by the incorporation of 1991 Census information and by changes to the methodology for calculating SSAs resulting from the review of SSAs for 1994/95. This affected the amounts falling to be paid to them by way of Revenue Support Grant for 1994/95.
4. Grant was paid in 1994/95 to compensate any authority whose SSA for 1994/95 was more than 2 per cent. below the amount of its SSA for that year if it had been calculated on the basis of the methodology set out in section 4 of the Local Government Finance Report (England) 1993/94 as approved by the House of Commons on 3 February 1993, adjusted for certain factors.
5. For 1995/96 a grant was paid to compensate authorities whose SSAs for 1994/95 as calculated under the 1994/95 Report were affected by the incorporation of 1991 Census information and by changes to the methodology for calculating SSAs resulting from the review of SSAs for 1994/95. This grant provided further compensation to authorities who continued to receive less Revenue Support Grant as a result of these changes.
6. For 1996/97 further grant will be paid to compensate authorities whose SSAs for 1994/95 as calculated under the 1994/95 Report were affected by the incorporation of 1991 Census information and by changes to the methodology for calculating SSAs resulting from the review of SSAs for 1994/95. This grant provides further compensation to authorities who continue to receive less Revenue Support Grant as a result of these changes.

7. To determine if grant is payable in 1996/97, an amount is first calculated for each authority as follows:

$$\frac{B - A}{B}$$

where:

A is the Secretary of State's estimate of the SSA for the authority which would be calculated for it under section 4 of the 1996/97 Report;

B is the amount calculated for the authority under the following formula:

$$C + D$$

where:

C is the Secretary of State's estimate of the SSA for the authority for 1996/97 if calculated for authorities at 1 April 1996 on the basis of the methodology set out in section 4 of the 1995/96 Report, except that in the calculation -

(i) the methodology for the SSA elements for *Under 5 Education, Social Services for the Elderly, Police, Highway Maintenance, Public Transport Support for Rail Services* and *Capital Financing* for 1996/97 replaces that for 1995/96;

(ii) the relevant indicators are updated wherever possible in accordance with Annex D to the 1996/97 Report;

(iii) the value of x in paragraph 4.50 of the 1995/96 Report for the groups of authority listed in that paragraph is as follows -

for (i) $x = 0.17893$;

for (ii) $x = 0.41054$;

for (iii) $x = 0.06053$; and

for (iv) $x = 0.35$;

(iv) the control totals given in Annex E to the 1996/97 Report are used in the calculation instead of those given in Annex E to the 1995/96 Report, except that:

(a) those for *Rent Allowance Payments, Rent Allowance Administration* and *National Parks* are excluded; and

(b) the control total for *Services provided predominantly by non-metropolitan district councils* is £5,720.8 million;

(v) the scaling factors described in paragraph 4.3 of, and set out in Annex F to, the 1995/96 Report are recalculated to take account of:

- (a) the methodology changes referred to in (i) above;
- (b) the updating of the SSA indicators referred to in (ii) above;
- (c) changes to the value of x referred to in (iii) above; and
- (d) the control totals referred to in (iv) above; and

(vi) the boundary change adjustment referred to in paragraph 4.51 of the 1995/96 Report is applied to the boundary changes set out in Annex J to the 1996/97 Report, except that for the SSA elements for *Highway Maintenance*, *Secondary Education* and *Post-16 Education* the adjustment is made only in respect of the boundary change for 1 April 1996 set out in Annex J to the 1996/97 Report;

D is the amount of any SSA reduction grant (SSA Review) payable to the authority for 1995/96 in accordance with the Special Grant Report (No.12) made on 26 January 1995. For this purpose an authority which is a reorganised receiving authority, as defined in Annex D to the 1996/97 Report, has been assigned an amount of any SSA reduction grant (SSA Review) payable during the financial year 1995/96 to the authority or authorities whose area on 31 March 1996 is wholly or partly contained within the area of the reorganised authority on 1 April 1996, as the Secretary of State considers appropriate.

8. Grant is payable where the amount calculated under paragraph 7 is greater than **0.02**. The amount of grant is calculated in accordance with the following formula:

$$B \times \left[\left(\frac{B - A}{B} \right) - 0.02 \right]$$

where:

A and **B** have the same meaning as in paragraph 7.

Annex C

SSA Reduction Grant (Police Funding Review)

1. Under the 1996/97 Report and the 1996/97 Police Grant Report, the SSA element for Police and the entitlement to police grant for the financial year 1996/97 for police authorities in England and for the Receiver for the Metropolitan Police District would be affected by the changes to the methodology for calculating the SSA element for Police and the police grant. These changes would affect the amounts falling to be paid by way of Revenue Support Grant and police grant for 1996/97. Grant is to be paid to compensate any police authority, which for this purpose includes the Receiver for the Metropolitan Police District, for whom the sum of its SSA and police grant entitlement for 1996/97 will be reduced by more than 2 per cent. as a result of the changes outlined above. This grant will also provide further compensation to certain police authorities in England and to the Receiver for the Metropolitan Police District as a result of changes to the methodology for calculating the SSA element for Police and the police grant for 1995/96.

2. To determine if grant is payable, an amount is first calculated for each police authority as follows:

$$\frac{B - A}{B}$$

where:

A is the sum of:

- (i) the Secretary of State's estimate of the SSA element for Police for the authority which would be calculated for it under section 4 of the 1996/97 Report, adjusted for boundary changes in accordance with paragraph 4.57 of that Report; and
- (ii) the estimate of the Secretary of State for the Home Department ('the Home Secretary') of the police grant entitlement for 1996/97 for the authority which would be calculated for it under section 5 of the 1996/97 Police Grant Report; and
- (iii) in the case of the Receiver for the Metropolitan Police District, the special payment referred to in section 4 of the 1996/97 Police Grant Report.

B is the amount calculated for the police authority under the following formula:

$$\mathbf{C + D + E}$$

where:

C is the Home Secretary's estimate of the amount of police grant for the police authority for 1996/97 if calculated on the basis of the methodology set out in the Police Grant Report (England and Wales) 1995/96 ('the 1995/96 Police Grant Report'), except that in the calculation -

- (i) the relevant indicators for police areas are updated wherever possible in accordance with Annex A to the 1996/97 Police Grant Report;
- (ii) the coefficients in the formula given in paragraph 5.5 of the 1995/96 Police Grant Report have been recalculated to take account of:
 - (a) the aggregate amount of grants to be allocated under sections 5 and 6 of the 1996/97 Police Grant Report; and
 - (b) the updating of the indicators for **PENSIONS EXPENDITURE** and **SECURITY EXPENDITURE** referred to in (i) above.
- (iii) the scaling factor described in paragraph 5.4 of, and set out in Annex B to, the 1995/96 Police Grant Report is recalculated to take account of:
 - (a) the updating of the indicators referred to in (i) above;
 - (b) the recalculation of the coefficients referred to in (ii) above; and
 - (c) changing the aggregate amount of grants allocated by means of the formula in section 5 of the 1995/96 Police Grant Report to the aggregate amount of grants to be allocated under sections 5 and 6 of the 1996/97 Police Grant Report.

The amount **C** is adjusted for boundary changes in accordance with Annex C to the 1996/97 Police Grant Report.

D is the Secretary of State's estimate of the SSA element for Police for the police authority for 1996/97 if calculated on the basis of the methodology set out in section 4 of the 1995/96 Report, except that in the calculation -

- (i) the relevant indicators for police areas are updated wherever possible in accordance with Annex D to the 1996/97 Report;

- (ii) the coefficients in the formula given in paragraph 4.26 of the 1995/96 report have been recalculated to take account of:
 - (a) the control total for Police given in Annex E to the 1996/97 Report; and
 - (b) the updating of the indicators for **PENSIONS EXPENDITURE** and **SECURITY EXPENDITURE** referred to in (i) above.
- (iii) the scaling factor described in paragraph 4.3 of, and set out in Annex F to, the 1995/96 Report is recalculated to take account of:
 - (a) the updating of the indicators referred to in (i) above;
 - (b) the recalculation of the coefficients referred to in (ii) above; and
 - (c) changing the control total for the Police set out in Annex E to the 1995/96 Report to that given in Annex E to the 1996/97 Report.

The amount **D** is adjusted for boundary changes in accordance with paragraph 4.57 of the 1996/97 Report.

E The amount of any SSA Reduction Grant (Police Funding Review) payable to the police authority or to the Receiver for the Metropolitan Police District for 1995/96 in accordance with the Special Grant Report (No.12) made under section 88B of the 1988 Act by the Secretary of State on 26 January 1995.

3. Grant is payable where the amount calculated under paragraph 2 is greater than **0.02**. The amount of grant is calculated in accordance with the following formula:

$$B \times \left[\left(\frac{B - A}{B} \right) - 0.02 \right]$$

where:

A and **B** have the same meaning as in paragraph 2.
