Foreword

Revision of the Regulatory Impact Assessment Process

In April 2007, the Government announced a new Impact Assessment improving on the previous Regulatory Impact Assessment with a simpler, more transparent process that will be embedded in the earliest stage of policy making.

Due to the timing of this Command Paper it will contain a combination of Regulatory Impact Assessments and revised Impact Assessments.

This Command Paper lists the full and final (Regulatory) Impact Assessments completed by departments during the period 1st July 2007 to 31st March 2008. Electronic copies are available at the weblinks listed below unless otherwise indicated.

An addendum has also been published in Annex A providing details of Impact Assessment published between 1st January and 30th June 2007 that were missed or the weblinks have changed in the previous Command Paper.

Introduction of the Impact Assessment Library

Following the introduction on the revised process, government also committed to “set up an on-line database that would provide single point of access to Impact Assessments”.

The Impact Assessment Library was launched in April 2008 and has been designed to increase transparency and accessibility to the analysis underpinning the Government’s decision to regulate.

The Impact Assessment Library publishes information extracted from the summary sheets within Impact Assessments to increase accessibility to what the problem was, why government needed to intervene and what options were considered to resolve it.

In addition to this summary information, copies of the Impact Assessments and any Specific Impact Tests that are completed when assessing the potential impact upon race, disability, equality, small business, the environment etc are also available.

As a result of the launch of the Impact Assessment Library, this will be the last Command Paper published providing information on final Impact Assessments.
