**2013/14 Summary Fees Table**

**These fees are effective for all visa applications made from 2-Oct-2013 for entry to the UK mainland.**

**Fees for dependants:** Dependents are charged the same fee as the main applicant apart from where exceptions are shown. All dependants who are travelling must pay the fee whether or not they are included in the main applicant's passport.

**Refunds:** Your visa application fee will only be refunded if you withdraw your application in writing prior to any processing taking place or if your biometric information has not been taken. Refunds will not be given if your application is refused or if a long term visit visa is granted for less than the period applied for.

**These fees are effective for all visa applications made from 2-Oct-2013. The consular rate of exchange is 3.2 Fiji Dollars [FJD] to £1.**
