Relinquishment Report

It has also been agreed within PILOT that DECC would request Relinquishment reports for older Licences where a whole licence relinquishment or relinquishment of non-contiguous blocks in multiblock licences are submitted.

The Secretary of State hereby acknowledges the surrender of part of the Licensed Area covered by the Licence. With effect from the Effective Date above, the Licensed Area as defined at Schedule 1 to the Licence shall be replaced by the new Licensed Area as defined below. For information, the extent of the new Licensed Area in square kilometres is also shown below.

Perpetual Retention

In accordance with the model clause attached to the Licence and headed Areas Surrendered there is an obligation under the model clauses to retain any data relating to this licence in perpetuity, and to deliver such data to the Minister as and when required.

Relief from this obligation will only be granted for data that has been placed in the National Hydrocarbons Data Archive (NHDA). All obligations under the licence are held joint and severally by all licensees.
