### **REQUEST FOR INFORMATION**

1. Thank you for your correspondence dated 13<sup>th</sup> June 2012, which has been considered to be requests for information under the Freedom of Information Act (FOIA) 2000. We have combined all five of your requests (FOI References: 13-06-2012-171527-016, 13-06-2012-171229-015, 13-06-2012-170926-014, 13-06-2012-170353-013, 13-06-2012-171527-016) into one response contained herein.

**1. How many individual private security contractors (i.e. workers) have been/are employed by the UK Government overseas. Please provide an annual breakdown from 2002 until 2012.**

**2. With the proposed military spending review in mind, how much does the UK Government anticipate spending on private security companies for overseas contracts in the next 10 years? If possible, please provide an annual breakdown from 2012.**

**3. How many private security contractors does the Government believe will be employed on UK Government contracts overseas in the next 10 years? Please provide a breakdown for each year.**

**4. How many deaths of private security contractors have there been while carrying out contracts on behalf of the UK Government overseas? Please give an annual figure for each year.**

**5. How many serious injuries of private security contractors have there been while carrying out contracts on behalf of the UK Government overseas? Please give an annual figure for each year. (By serious injury, we mean a contractor unable to continue operationally on the contract)**

**6. How many times have supply convoys involving private security contractors come under attack since 2002 in both Iraq and Afghanistan? Please provide a breakdown for each year.**

**7. How much has the UK Government spent as a total on Private Security Companies (PSCs) overseas? (Please include all spending, including MOD, DFID, FCO etc.)**

**8. Please provide details of UK Government overseas contracts awarded to all PSCs for each year since 2002. Please include a breakdown of the company; dates awarded, contract value, location of where contract is to be carried out.**

**9. Please provide details on all current overseas contracts involving the following companies:**

- a. G4S**
  - b. Aegis**
  - c. Control Risks Group**
  - d. Edinburgh International**
- (This would include the value of the contract, location of operation, how many private contractors employed, nature of work)**

## **Response**

We can confirm that the Ministry of Defence holds some of the information related to your request.

Q1, Q7 and Q8. We can confirm that we hold information in scope of your request.

The attached detail and table is summarised from the contracts concerned.

Armor Group	2007	Basrah	£1,113,000
Armor Group	2006/07	Kabul	£21,000

In Iraq, one PSC (Armor Group) was awarded a contract by the MOD for approximately 2 months in 2007, to guard 2 vacant compounds within Basra Palace. This contract was worth approximately £1,113,000. The number of PSC personnel employed is not held by the Ministry of Defence.

One PSC (Armor Group) was awarded a contract by the MOD to provide security for the UK Defence Advisers' accommodation in Kabul, Afghanistan for 3 months in 2006/07. This contract was worth approximately £21,000. The information on the number of PSC personnel employed is not held by the Ministry of Defence

Q2-6 and Q9. We can confirm that we hold no information relating to your request.

However, for your information, there were no reported casualties to either contract awarded to the Armor Group (i.e. in 2007 to guard 2 vacant compounds within Basra Palace, and in 2006/07 to provide security for the UK Defence Advisers' accommodation in Kabul, Afghanistan).

We have no overseas contracts with G4S, Aegis Control Risks Group or Edinburgh International.
