MILITARY OVERVIEW

In late 2010, the Slovak defence ministry commenced a Strategic Defence Review, which is due to be implemented by 2014. This process was partly driven by financial factors likely to lead to decreasing defence resources, but also by the desire to map out a path for Slovak military development. The army has seen reductions in its inventory, notably in tanks, armoured personnel carriers and artillery. Nonetheless, Slovak forces still retain a focus on contributions to international operations, and maintain forces in Afghanistan. With funding difficulties, the NATO Secretary-General on a visit to Bratislava focused on his concept of 'smart defence', which is intended to help countries facing fiscal difficulties to make better use of resources.

Priorities and budgets of the Slovak armed and security forces according to the 2012 State Budget:

Total budget: €798.3 million

Ministry of Interior

Total budget: €902.2 million out of which: Rescue services and fire brigades: €86.2 million Public order and safety: €752.9 million

Rescue services and fire brigades

Opportunities include: Fire protection, training of fire-fighters and rescuers, Geographic Information System and mountain rescue.

Public Order and Safety

Priorities include:

Fight against organized crime, anti-corruption drive, fight against human trafficking, protection of state border, development of SITNO radio network (TETRAPOL) for government forces, ICT support, logistical support, integrated rescue system, and public order and safety.

Civil Emergency Planning

Aspirations include further development of population protection against chemical weapons, and critical infrastructure protection.

Ministry of Justice

Total budget: €302.8 million out of which: Prisons: €146.8 million

Priorities include: security equipment for prisons, refurbishment of existing prisons, and increasing prison capacities.

SIS (Slovak Intelligence Service)

Total budget: €41.6 million

The budget is earmarked for technology and infrastructure development.

HMG Support

Slovak Export Controls

UK defence manufacturers must first obtain a F680 licence, in order to be able to export, but should also ensure that none of the items are controlled, or appear on the Military List. This also applies to UK security companies.

SECURITY ISSUES

The Slovak government has identified, as key priorities, the following: combating corruption and organised crime, improved equipment for police and fire brigade, plus training. However, because of budgetary restrictions, various projects are on hold. Flooding is another serious issue.


