This guidance gives information on the police registration requirement of part 10 of the Immigration Rules paragraphs 325 and 326.

#### When to impose the requirement to register

The requirement to register with the police is imposed on an applicant who is a:

- national or citizen of a country or territory listed in Appendix 2 to the rules
- stateless person, or
- person holding a non-national travel document.

And who is given limited leave to:

- enter the UK for longer than six months
- remain allowing them to remain in the UK for longer than six months, starting from the date of their arrival.

There are certain exceptions to the above. For more information on the rules and exemptions from registration, see link on left: Who needs to register with the police.

#### The requirement to register can be imposed by:

- an entry clearance officer (ECO)
- a Home Office officer
- a Border Force officer, or
- a caseworker on behalf of the Secretary of State.

- obtaining the leave (in the UK)
- arriving in the country if imposed by an ECO or Border Force officer
- receiving their biometric residence permits.

Once registered, the police will give the applicant a police registration certificate (PRC) which shows they have complied with the requirement to register.

The applicant must inform the police of any changes to the information they have provided whilst they are still in the UK and subject to the requirement to register with the police.

<p><a href="#">About this guidance</a></p> <p><a href="#">Imposing police registration</a></p> <p><a href="#">Required to register in error</a></p> <p><a href="#">Disposal of police registration certificates</a></p> <p><a href="#">Transfer of police registration requirement to a new passport</a></p>	<p>This section tells you who needs to register with the police and who is exempt from registering.</p> <p><b>Applicants</b></p> <p>Under part 10 paragraphs 325 and 326 of the Immigration Rules, you impose the need to register with the police on a person who is:</p> <ul style="list-style-type: none"><li>• Being given limited leave to enter the UK for longer than six months. Or</li><li>• Being given limited leave to remain allowing them to remain in the UK for longer than six months from the date of their arrival in the UK:<ul style="list-style-type: none"><li>○ This applies in all cases regardless of whether the condition was imposed when they arrived.</li></ul></li><li>• Aged 16 or over, and is:<ul style="list-style-type: none"><li>○ a national or citizen of a country or territory listed in Appendix 2 to the rules, for more information, see related link: Immigration Rules Appendix 2</li><li>○ a stateless person, or</li><li>○ a person holding a non-national travel document.</li></ul></li></ul> <p>See related links for guidance on:</p> <ul style="list-style-type: none"><li>• exemption from registration</li><li>• dependants</li><li>• dual nationals and other travel documents.</li></ul> <p><b>Imposing the requirement in other cases</b></p> <p>If you believe it is necessary you can impose a condition to register with the police, to make sure the person complies with the terms of their leave to enter. <p><a href="#">About this guidance</a></p> <p><a href="#">Who needs to register with the police</a></p> <p><a href="#">Imposing police registration</a></p> <p><a href="#">Required to register in error</a></p> <p><a href="#">Disposal of police registration certificates</a></p> <p><a href="#">Transfer of police registration requirement to a new passport</a></p>	<p>This page tells you about exemptions from the requirement to register with the police.</p> <p>The following are exempt from the requirement to register:</p> <ul style="list-style-type: none"><li>• Those granted indefinite leave to enter or remain.</li><li>• Spouses, civil partners, unmarried partners, and same-sex partners of people settled here who are granted leave to enter or remain in the UK on that basis.</li><li>• A recognized refugee.</li><li>• Family members of European Economic Area (EEA) and Swiss nationals.</li><li>• Seasonal agricultural workers.</li><li>• Tier 5 temporary workers sponsored as an overseas government employee, or private servant in a diplomatic household.</li><li>• Tier 2 ministers of religion.</li><li>• Those exercising access rights to a child resident in the UK.</li><li>• Parents of a child at school in the UK granted leave to enter or remain on that basis.</li><li>• Dependants of a person who is not required to register (except dependants of off-shore workers).</li><li>• Members of non-NATO (North Atlantic Treaty Organisation) forces admitted for courses at British military establishments or with private companies (Course F). <p><a href="#">About this guidance</a></p> <p><a href="#">Who needs to register with the police</a></p> <p><a href="#">Imposing police registration</a></p> <p><a href="#">Required to register in error</a></p> <p><a href="#">Disposal of police registration certificates</a></p> <p><a href="#">Transfer of police registration requirement to a new passport</a></p>	<p>This page tells you when to impose the condition to register with the police on dual nationals, and people holding Turkish Republic of Northern Cyprus travel documents and passports issued by Special Administrative Region of Hong Kong or Macao.</p> <p><b>Dual nationals</b> A person with dual nationality only needs to register with the police if both nationalities they hold are listed in Appendix 2 of the Immigration Rules.</p> <p>If one of their nationalities is not in Appendix 2 they do not need to register.</p> <p>For the list in Appendix 2, see related link.</p> <p><b>Travel documents issued by the Turkish Republic of Northern Cyprus</b> Turkish nationals who hold travel documents issued by the Turkish Republic of Northern Cyprus need to register with the police.</p> <p>Citizens of the Republic of Cyprus who hold these documents do not need to register with the police.</p> <p><b>Passports issued by Special Administrative Region of Hong Kong or Macao</b> A person who holds a passport issued by the Special Administrative Region of either Hong Kong or Macao is classed as a Chinese national and needs to register.</p>	<p><b>In this section</b></p> <p><a href="#">Exemption from registration</a></p> <p><a href="#">Dependants</a></p> <p><b>External links</b></p> <p><a href="#">Immigration Rules Appendix 2</a></p>

The endorsement must read – ‘Police registration within 7 days of arrival’.</p> <p><b>Border Force officers</b> If you impose the requirement to register at a port of entry, you must:</p> <ul style="list-style-type: none"><li>• show the requirement on the vignette or endorse it clearly in the passport</li><li>• note the requirement on the landing card, and</li><li>• record the person’s address on the landing card.</li></ul> <p>If a person presents an incorrect vignette or the requirement to register has not been endorsed in the passport, it is still possible for you to impose the condition to register.</p> <p><b>Police registration</b> In London, police registration takes place at the:</p> <p>Overseas Visitors Records Office (OVRO) Brandon House 180 Borough High Street London SE1 1LH Telephone: 020 7230 1208</p>	<p><b>In this section</b></p> <p><a href="#">Caseworkers (after entry to the UK)</a></p> <p><a href="#">People who have failed to register</a></p> <p><a href="#">People who become exempt from registering</a></p> <p><b>External links</b></p> <p><a href="#">Immigration Rules: Paragraphs 325 and 326</a></p> <p><a href="#">Immigration Rules Appendix 2</a></p>

Elsewhere the person registers at the nearest police registration office. They can obtain the location from their local police station.

Once registered, the police will give the applicant a police registration certificate (PRC) which shows they have complied with the requirement to register.

**The information and documents the applicant must provide to the police**

They must pay a fee and provide the following:

- name and gender
- a current photograph
- date of birth and country of birth
- marital status
- nationality
- address in UK
- last place of residence outside the UK
- date, place and mode of arrival in the UK
- passport details
- details of employment and/or place of study
- duration of leave and any conditions, including details of their biometric residence permit.

<p><a href="#">About this guidance</a></p> <p><a href="#">Who needs to register with the police</a></p> <p><a href="#">Imposing police registration</a></p> <p><a href="#">Required to register in error</a></p> <p><a href="#">Disposal of police registration certificates</a></p> <p><a href="#">Transfer of police registration requirement to a new passport</a></p>	<p>This page tells you how to impose or re-impose the police registration requirement when granting an extension of stay (leave to remain).</p> <p><b>People not previously required to register</b></p> <p>If a grant of leave to remain means a person needs to register with the police, you must use the correct vignette, which includes the requirement to register.</p> <p>For information on who needs to register with the police, see link on left.</p> <p><b>CID actions</b></p> <p>You must:</p> <ul style="list-style-type: none"><li>• Note on CID that police registration code 1 applies by selecting the appropriate police code in the case maintenance screen.</li><li>• Issue an ICD.0005 from CID to tell the person they need to register with the police. Select option:<ul style="list-style-type: none"><li>○ six for those who need to register at the Overseas Visitors Records Office (OVRO), or</li><li>○ seven in all other cases.</li></ul></li></ul> <p>For information on where a person must register with the police, see the related link: <a href="#">Entry clearance officers and Border Force officers (before entry and on entry to the UK)</a>.</p> <p><b>People already required to register</b></p> <p>If a person who already needs to register with the police applies for further leave, they must produce a police registration certificate (PRC) to show they have registered.</p> <p>If they still need to register, you must endorse the requirement on the new vignette and stamp the police registration certificate with the PRC stamp two.</p>	<p><b>In this section</b></p> <p><a href="#">Entry clearance officers and Border Force officers (before entry and on entry to the UK)</a></p> <p><a href="#">People who have failed to register</a></p> <p><a href="#">People who become exempt from registering</a></p> <p><b>External links</b></p> <p><a href="#">Immigration Rules: Paragraphs 325 and 326</a></p> <p><a href="#">Immigration Rules Appendix 2</a></p>

	<p><b>CID actions</b> You must:</p> <ul style="list-style-type: none"><li>• Note on CID that PRC code 2 applies.</li><li>• Select the correct police code on the case maintenance screen.</li><li>• Issue an ICD.0005, to tell the person they need to inform the police of an extension of stay. Select option:<ul style="list-style-type: none"><li>○ eight if they need to tell OVRO they have an extension of stay, or</li><li>○ nine in all other cases.</li></ul></li></ul>

<p><a href="#">About this guidance</a></p> <p><a href="#">Who needs to register with the police</a></p> <p><a href="#">Imposing police registration</a></p> <p><a href="#">Required to register in error</a></p> <p><a href="#">Disposal of police registration certificates</a></p> <p><a href="#">Transfer of police registration requirement to a new passport</a></p>	<p>This page tells you what to do when a person has failed to register with the police.</p> <p>Failure to register within the time specified, without reasonable excuse, is an offence under section 26(1) (f) of the Immigration Act 1971. For more information on the act, see related link.</p> <p>You must inform the police as soon as you find out an applicant who needs to register:</p> <ul style="list-style-type: none"><li>• fails to register with the police</li><li>• is known to have moved from or into their area</li><li>• has had changes in the conditions attached to their leave, or</li><li>• becomes exempt from the requirement.</li></ul> <p>You must clearly and correctly record on CID and landing cards:</p> <ul style="list-style-type: none"><li>• addresses, and</li><li>• any need to register.</li></ul> <p>If an applicant has failed to register, you must not decide the case. You must:</p> <ul style="list-style-type: none"><li>• Return the passport and/or other relevant documentation.</li><li>• Inform them that before you can consider their application they must:<ul style="list-style-type: none"><li>○ register with the police, and</li><li>○ produce a police registration certificate (PRC), demonstrating they have registered.</li></ul></li><li>• Instruct them to re-submit their passport, the PRC and any other relevant documents as required once they have registered.</li></ul> <p>You must make the covering letter to the individual detailed enough for it to be used as evidence to the police that an application is with the Home Office pending registration and endorsement of the PRC.</p>	<p><b>In this section</b></p> <p><a href="#">Entry clearance officers and Border Force officers (before entry and on entry to the UK)</a></p> <p><a href="#">Caseworkers (after entry to the UK)</a></p> <p><a href="#">People who become exempt from registering</a></p> <p><b>External links</b></p> <p><a href="#">Immigration Rules: Paragraphs 325 and 326</a></p> <p><a href="#">Immigration Rules Appendix 2</a></p> <p><a href="#">Immigration Rules Paragraph 322(3)</a></p> <p><a href="#">Immigration Act 1971: Section 26(1)(f)</a></p>

<p><a href="#">About this guidance</a></p> <p><a href="#">Who needs to register with the police</a></p> <p><a href="#">Imposing police registration</a></p> <p><a href="#">Required to register in error</a></p> <p><a href="#">Disposal of police registration certificates</a></p> <p><a href="#">Transfer of police registration requirement to a new passport</a></p>	<p>This page tells you what to do when a person becomes exempt from the requirement to register with the police.</p> <p>A person can become exempt from the need to register by:</p> <ul style="list-style-type: none"><li>• being granted leave in a category which is exempt from the requirement to register, or</li><li>• obtaining a nationality that is not specified in Appendix 2 of the Immigration Rules, see related link.</li></ul> <p>As the requirement was correctly imposed at the time, you must not delete the requirement from the passport. Any fee paid on registration is not refundable.</p> <p>You must:</p> <ul style="list-style-type: none"><li>• Endorse the registration certificate as 'exempt from registration' and return it to the applicant.</li><li>• Issue letter ICD.0005 to tell the person they are no longer required to notify the police of an extension of stay, include the paragraph in option 11.</li><li>• Notify the police of the change in status, by making a note on CID that police registration certificate (PRC) code three applies and then select the appropriate police code in the case maintenance screen.</li></ul>	<p><b>In this section</b></p> <p><a href="#">Entry clearance officers and Border Force officers (before entry and on entry to the UK)</a></p> <p><a href="#">Caseworkers (after entry to the UK)</a></p> <p><a href="#">People who have failed to register</a></p> <p><b>External links</b></p> <p><a href="#">Immigration Rules: Paragraphs 325 and 326</a></p> <p><a href="#">Appendix 2 of the Immigration Rules</a></p>

<p><a href="#">About this guidance</a></p> <p><a href="#">Who needs to register with the police</a></p> <p><a href="#">Imposing police registration</a></p> <p><a href="#">Disposal of police registration certificates</a></p> <p><a href="#">Transfer of police registration requirement to a new passport</a></p>	<p>This page tells you what to do if an applicant claims they have been required to register with the police in error.</p> <p>If an applicant claims they have been required to register with the police in error, you must first find out whether the requirement was imposed before entry, on entry or after entry. You must:</p> <ul style="list-style-type: none"><li>• Send before entry cases to the referred casework unit.</li><li>• Send on entry cases to Border Force operational advice and support (BF OAS).</li><li>• Return after entry cases to the case working unit which imposed the requirement for action.</li></ul> <p>You must always:</p> <ul style="list-style-type: none"><li>• Establish the applicant's category, nationality and conditions set at the time the requirement was imposed.</li><li>• For on-entry cases, and unless you are forwarding the case to BF OAS, you must obtain the visa application form (VAF) or landing card.</li></ul> <p>You must be satisfied the requirement to register with the police was imposed in error at the time it was imposed. For example the following would not have had the original requirement imposed in error:</p> <ul style="list-style-type: none"><li>• an applicant who becomes exempt later by obtaining a different category of leave, or</li><li>• by obtaining dual nationality.</li></ul> <p><b>Removing the requirement - person has not yet registered</b></p> <p>If the applicant has not yet registered, you must:</p> <ul style="list-style-type: none"><li>• delete the registration endorsement in the person's passport</li></ul>	<p><b>Related links</b></p> <p>Links to staff intranet removed</p> <p><b>External links</b></p> <p><a href="#">Immigration Rules: Paragraphs 325 and 326</a></p> <p><a href="#">Immigration Rules Appendix 2</a></p>

This guidance is based on the Immigration Rules

- return the passport to them, enclosing ICD.1100 to explain the endorsement was imposed in error, and
- amend CID, if appropriate to make sure the police are notified of the error.

**Removing the requirement - person has registered**

If the applicant has registered, you must:

- obtain the police registration certificate and endorse the back page with 'exempt from registration'
- return the certificate and passport to the person, with an ICD.1100 to explain the original endorsement was imposed in error
- write to the Overseas Visitor Records Office (OVRO), if the person lives in London, or the Chief Constable of the relevant police force if they live outside of London, to explain the requirement was imposed in error and request they consider refunding the fee, and
- amend CID to reflect the correct status.

You must consider the requirement to have been imposed in error if a dual national had another nationality not listed in Appendix 2 when they were admitted to the UK. This also makes sure the applicant has reported their original extension of stay to the police as required.</p> <p>If an applicant fails to provide their PRC within a reasonable time, refer the case to a senior caseworker or line manager to consider curtailing leave under paragraph 323(i) and 322(3) of the Immigration Rules.
