- 1. The licence is subject to the provisions for any enactment for the time being applicable to the canal (including towpath).
- 2. The canal is vested in and used by the Environment Agency for land drainage purposes and we do not guarantee any depth of water in the canal, or its suitability in any other respect for navigation.
- 3. Anyone using the canal by virtue of this licence does so at his own risk and we accept no responsibility for any injury to persons or loss or damage to property arising directly or indirectly from the exercise of any of the rights conferred by the licence.
- 4. The holder of the licence shall be responsible for any damage to the canal, and any land, property, appliances or works of the Environment Agency caused in or by the exercise of any rights conferred by the licence.
- 5. Anyone using the canal by virtue of this licence shall refrain from causing any avoidable annoyance to or interference with anglers and others lawfully using the Canal, or owners and occupiers of adjacent lands and properties, and shall in particular refrain from obstructing the canal or the towpath by placing any mooring rope or chain across either.
- 6. No litter, refuse or waste of any kind shall be thrown or deposited in the canal or on any adjacent land.
- 7. The licence does not confer any right :-
- (1) to use any form of engine for propelling the boat on the canal; or
- (2) to camp on adjacent lands; or
- (3) to erect any landing stage or other structure in, on, or over the canal or its banks, or the towpath; or
- (4) to use in any way the Northern Bank Canal (which is in private ownership).

- 8. Anyone using the canal by virtue of the licence shall produce this licence document on request to any officer or other employee, relative to the use of the canal or towpath, shall be complied with.
- 9. We reserve the right at any time to revoke or suspend the licence without assigning any cause or reason.
