

Introduction

This document provides potential participants in the Contracts for Difference (CfD) scheme with details of the key implementation activities and milestones.

The Implementation Plan is one of the outputs of the EMR Collaborative Development Programme which finished in December 2013.

Scope and Status

The CfD Implementation Plan identifies the key milestones and activities that are required to successfully implement the CfD. The dates set out in this implementation plan reflect the agreed position between the Government and EMR Delivery Partners on the planned dates that support delivery of the CfD in 2014. The Implementation Plan reflects the policy for EMR that Government set out for consultation in October¹, a further consultation was published in March on the Operational Costs Levy for the CfD. The draft Allocation Framework will be published shortly. The dates in the plan are based on the Government's and Delivery Partners' assessment of deliverability against that policy.

The plan may need to be revised and so the timeline for the implementation of CfD remains subject to change, and is particularly dependent on time taken for the legislation to pass through Parliament and on the process for securing state aid clearance.

The plan brings together milestones from the Government and each of the EMR delivery partners. It is intended to provide a high level overview of the steps involved in the implementation of the CfD scheme and the running of the first application and contract award process, this should ensure that industry participants have the clarity required to plan and manage their own implementation work.

The implementation plan is a summary and does not replace or replicate the detailed implementation plans that Government, delivery partners and individual industry participants may need to produce to manage their respective implementation activities.

Implementation Approach

The process for awarding a CfD progresses in stages. The first CfD application round opens in October 2014 and the eligibility of applicants will be assessed and the value of eligible bids determined. If the eligible bids can be met within the budget available then the Delivery Body will propose that the Counterparty Body offer CfDs to participants. If the eligible bids exceed the budget available then, in December, eligible generators may be required to submit a sealed bid for the CfD auction. Assuming that there are no appeals CfD contracts will be offered to developers later that month and come into effect from January 2015.

The details of this timetable, and the key implementation milestones required to deliver this, are set out in the table of <u>Key Activities and Milestones</u> and in the accompanying Implementation Plan at <u>Annex A.</u>

Roles and Responsibilities:

A number of organisations are working together to implement the CfD programme. This section focuses on these organisations' roles in relation to the 'implementation phase' covering the first application and contract award process.

Government

- Finalising the policy design and implementing legislation
- Reporting to Ministers and communication of Ministers' decisions
- Establishing of the CFD Counterparty Company
- Working with the European Commission to secure State Aid clearance
- Appoint and work with the EMR Panel of Technical Experts
- Producing the EMR Delivery Plan and annual updates
- Managing any changes to Regulations after the first allocation round
- Assessing supply chain plans

CfD Implementation Coordinator

In its role as CfD Implementation Coordinator, the CFD Counterparty is responsible for:

- Overall monitoring of progress against the CfD Implementation Plan
- Maintenance of the CfD Implementation Plan
- Industry engagement including readiness monitoring

CFD Counterparty Company

- Activities transitioned from DECC, including the management of Investment Contracts entered into through the Final Investment Decision enabling for Renewables (FIDeR) process
- Signing CfD contracts with projects deemed eligible by Delivery Body and Government
- Managing those contracts in line with terms set out in the contracts*
- Forecasting Supplier Obligation levy rate and reserve
- Ensuring that payments flow from/to generators and suppliers, collecting collateral (through its Settlement Services Provider)
- Co-ordination of CfD implementation
 - * including, where relevant, provisions on Fuel Measurement, Sampling and Sustainability

National Grid (Delivery Body)

- Publish CfD application/allocation guidelines
- Designing, implementing and operating processes and systems to:
 - Receive and assess the eligibility of applications for CfD contracts
 - Run the CfD allocation process
 - Provide the CFD Counterparty with the information necessary to offer a contract
- Delivering analysis to support Government's setting of strike prices having received and processed information from industry
- Delivering on-going reporting

Elexon

- Create a subsidiary to act as Settlement Services Provider, which will manage the outsourcing of settlement activity
- Advising of changes to Balancing and Settlement documentation
- Run process and systems for Settlement Service Provider functions

• Work with Suppliers and Generators to ensure alignment of systems for payment and settlement

Elexon Subsidiary (Settlement Services Provider)

- Manage the Settlement Services Sub Contractor
- Work with Suppliers and Generators to ensure integration of systems for payment and settlement

Ofgem

- Regulating National Grid Electricity Transmission (NGET) in its role as the Delivery Body for the CfD.
- Dispute resolution following the Delivery Body tier 1 dispute resolution process. (Note: Ofgem's role in tier 2 disputes is subject to discussion and agreement)

Key Activities and Milestones

The table below details the anticipated dates for milestones for the EMR CfD GB Implementation Plan. The Reference numbering (Ref. Num) refers to the location of the milestones on the Implementation Plan schedule provided at Annex A.

Please note that these timings are indicative and are subject to Parliamentary and State Aid approval. DECC will endeavour to provide any updates to milestones in a timely manner.

Next Steps

In April, the CFD Counterparty will be holding an "Implementation Co-ordinator Launch Event" as the starting point for a series of monthly forums with CfD participants. These forums will cover implementation preparation activities in detail, develop the process maps to the next level, and seek to resolve implementation issues, review progress and assist with industry preparation for application submission in October 2014.

In addition, Government will be holding an EMR Industry Implementation Forum every two months, chaired by the Director of EMR, to provide overall programme oversight and provide CfD participants with the opportunity to get updates on progress across the EMR programme.

Government is aiming to publish further detail on the CfD policy design on 2 June as part of a full Government response to the October EMR consultation on proposals for implementation, alongside updated secondary legislation being introduced to Parliament.
