REQUEST FOR INFORMATION: POWERS OF ENTRY AVAILABLE TO, AND USED BY, DEFRA

Thank you for your request for information on the powers of entry available to, and used by, Defra, which we received on 31 March 2014. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA).

The information that you have requested is already publically available from www.gov.uk.

As the information is reasonably accessible to you by other means, it is exempt from disclosure under section 21 FOIA. Your request has therefore been refused.

However, to ensure you locate the information correctly I have provided hyperlinks below in relation to the first and third part of your request:
