**Notice to Traders 14/14**

## **IMPORT TARIFF QUOTA FOR BEEF FROM UKRAINE**

### **Introduction**

1. This notice is to tell you about an Import Tariff Quota which will be opened to import frozen beef and veal products from Ukraine.

The Quota will be open until 31 October 2014.

The products and quantities available are detailed in Annex 1 attached.

The quota will be managed using rights applications and licence applications.

### **Import Rights Applications**

2. Applications for rights must be lodged by 12 noon on 9<sup>th</sup> May 2014.

Your application must be supported by a security of 6€/100 KGs

Import rights will be valid until 31 October 2014 and are not transferable.

### **Proof of Trade**

3. You must provide evidence to show that you have imported products falling within the CN heading 0201 or 0202 during the 12 month period immediately prior to the time of your application.

You must supply the original import document (C88) form or a copy certified as a 'true copy' of the original stamped by Customs. We will not accept photocopies of the Customs stamp or scanned versions of these documents.

We do not require endorsed C88 documents for electronic licence attributions. Instead you need to provide:

- a schedule detailing the licence number
- the date of import
- weight of attribution; and
- the import entry number for each electronic attribution

To request endorsement of a declaration at the time of entry, you should enter the code 'CAP11' in box 44 of your declaration. You do not need to enter any additional text with this code.

You should only ask HMRC to endorse the number of copy entries necessary for the relevant regulation. If you send more than is necessary it may delay the return of endorsed copy entries.

You must indicate your VAT registration number on your application. If you are registered as part of a group you must provide a valid VAT certificate that lists each company within the group.

**Note: We will reject any applications (including supporting documents), securities or proof of trade received after 12 noon on 09 May 2014.**

### **Licence applications**

4. Your application can only be lodged in the Member State where you have applied for and obtained import rights.

Your application cannot exceed your rights allocation quantity.

You may apply for several products covered by different CN codes. In this case, all CN codes and their descriptions shall be entered in boxes 15 and 16 of the licence application. You must enter the quantity for each CN code.

In box 8, the country of origin, you must indicate “Ukraine” and put a cross in the ‘Yes’ box. This means your licence is only valid to import beef which originates in Ukraine.

In box 20, special particulars, you need to include the following statement:

### **Licence Security**

5. Your application must be accompanied by 12€/100 KGs

In box 11, you should state:

- the amount of security expressed in the same unit of currency that your guarantee is lodged;
- the type of security, for example ‘block guarantee’, ‘cash’ or ‘single transaction guarantee’; and
- the trader number of the block guarantee holder if you are using another trader’s block guarantee.

If you are using another trader’s block guarantee you must ensure that your cross reference details are set up before you send us your application.

**Note: We will reject your application if the cross reference is not set up and you do not submit security in another format within the application period.**

**We will not accept any amendment to block guarantees after the application period has closed, including cross reference amendments.**

### **Licence Issue and Validity Period**

6. Licences will be valid for 30 days. However, this period will be limited to 31 October 2014.

Your licence will allow you to import at zero rate of import duty.

### **Transfer of rights**

The rights of a licence cannot be transferred.

### **Release of security**

You must return your paper licences within 45 days of the expiry date or you will forfeit your security.

### **Authority**
