Notice to Traders 10/14

IMPORT TARIFF QUOTA FOR POULTRYMEAT FROM UKRAINE

Introduction

1. This notice is to tell you about an Import Tariff Quota which will be opened to import poultrymeat products from Ukraine.

The Quota will be open until 31 October 2014.

The products and quantities available are detailed in Annex 1 attached.

The quota will be managed using rights applications and licence applications.

Import Rights Applications

2. Applications for rights must be lodged by 12 noon on Monday 9th May 2014.

Your application must be supported by a security of 35€/100 KGs

Import rights are not transferable.

Proof of Trade

3. You must provide evidence to show that you have imported products falling within the CN heading 0207, 0210 9939, 1602 31, 1602 32 or 1602 3921 during the 12 month period immediately prior to the time of your application. This will be your reference quantity.

You must supply the original import document (C88) form or a copy certified as a 'true copy' of the original stamped by Customs. We will not accept photocopies of the Customs stamp or scanned versions of these documents.

We do not require endorsed C88 documents for electronic licence attributions. Instead you need to provide:

- a schedule detailing the licence number
- the date of import
- weight of attribution; and
- the import entry number for each electronic attribution

To request endorsement of a declaration at the time of entry, you should enter the code 'CAP11' in box 44 of your declaration. You do not need to enter any additional text with this code.

You must fax a copy of the entry and any supporting documents, clearly marked as 'request for endorsement'. You should send it to the HMRC National Clearance Hub (NCH) at:

You should only ask HMRC to endorse the number of copy entries necessary for the relevant regulation. If you send more than is necessary it may delay the return of endorsed copy entries.

Note: We will reject any applications (including supporting documents), securities or proof of trade received after 12 noon on 9 May 2014.

Import rights will be valid until 31 October 2014 and they are not transferable.

Licence applications

4. Your application can only be lodged in the Member State where you have applied for and obtained import rights.

Your application cannot exceed your rights allocation quantity and refer to a single order number only.

In box 8, the country of origin, you must indicate "Ukraine" and put a cross in the box. This means your licence is only valid to import poultrymeat which originates in Ukraine.

In box 20, special particulars, you need to include the following statement:

Licence Security

5. Your application must be accompanied by 75€/100 KGs

In box 11, you should state:

- the amount of security expressed in the same unit of currency that your guarantee is lodged;
- the type of security, for example 'block guarantee', 'cash' or 'single transaction guarantee'; and
- the trader number of the block guarantee holder if you are using another trader's block guarantee.

If you are using another trader's block guarantee you must ensure that your cross reference details are set up before you send us your application.

Note: We will reject your application if the cross reference is not set up and you do not submit security in another format within the application period.

We will not accept any amendment to block guarantees after the application period has closed, including cross reference amendments.

Licence Issue and Validity Period

6. Licences will be valid for 30 days. However, this period will be limited to 31 October 2014.

Your licence will allow you to import at zero rate of import duty.

Transfer of rights

The rights of a licence cannot be transferred.

Release of security

You must return your paper licences within 45 days of the expiry date or you will forfeit your security.

Authority
