# Note of Community Energy Contact Group, 20 May 2014

CECG members highlighted their keen interest in fuel poverty proposals, working groups coming out of the Community Energy Strategy, FITs degression (especially community hydro) and FITs aggregation. They highlighted the importance of FITs tariff levels for community solar PV (on community, retail and industrial roofspace). They asked for CECG's input to be reflected clearly in its Terms of Reference e.g. 'providing input', 'reviewing policy' 'critical support'. They intend to invite consumer reps to CECG meetings on an ad hoc basis, as required. Michael Jampel updated CECG members that reps would be invited on an ad hoc basis to DECC's Community Energy Steering Group.

#### **Action Points:**

- Update CECG's Terms of Reference (Will Walker)
- CECG's input on finalised fuel poverty proposals (Will Walker)

#### Presentation by Smart Meter Team

Discussion focussed on:

- the fact that the smart meter roll-out is not geographical and the challenges this would present for engagement;
- how organisations would be able to obtain community-wide consumption data from smart meters (this could involve either becoming a "User" of the new Data & Communications Company's services, or else accessing data via a User's services). CECG members noted possible roles for DNOs in this;
- the need to press on with raising awareness among community organisations of the rollout and to develop a clearer sense of what communities will need to best support the roll out

#### Action points

- CECG members to liaise with Smart Metering team (Phil Nash) on raising awareness of the smart meter roll-out (CECG)
- Smart Metering team to develop clearer ideas as to how communities can engage with the roll out and what support communities may need to do so

#### Presentation on FITs consultation

DECC officials drew attention to the consultation on support for community energy projects under the Feed-in Tariffs scheme that were published by the Department on 13 May. The first part of the consultation explores the possibility of increasing the maximum capacity ceiling for community energy projects under the FITs scheme from 5MW to 10MW; the second part of the consultation considers under what circumstances, it might be possible for communities to combine grants from public bodies with FITs payments. DECC officials stressed that while the policy aim was to encourage more community energy by enabling a shift to occur in the ownership of renewable electricity to community ownership models, no new funding is available to support any additional net renewable electricity generation. CECG members raised significant concern about the proposed degression triggers for 5-10MW solar.

Affordability will therefore be a key consideration. DECC officials also highlighted the state aid position and stressed the importance of receiving new and robust deployment and cost evidence relating to community energy projects. There was an initial exchange of views with members of the CECG and agreement that further discussions should take place.

# Action points

- CECG members to engage in the consultation process and to submit formal responses (CECG)
- Officials to set up a preliminary discussion with CECG members to give an overview of the economic modelling in the consultation (DECC)
- CECG members to be invited to participate in stakeholder events related to FITs consultation (DECC)

# Presentation on Shared Ownership

Becky Willis (CECG and Taskforce) updated attendees on progress by the Shared Ownership Taskforce which is due to report to the Secretary of State in the summer. There were some concerns around the definition of 'ownership' and whether a community could potentially own a high enough stake to have a say in the running of a development. Becky Willis said it depended on the type of ownership model, that whilst communities are likely to be always minority partners within a Joint Venture, where a project is split, the community will have 100% control over that element of the project that they own. Julie Farrow (DECC) explained that the term being used is 'community shared ownership', whether this is split ownership, shared revenue, a joint venture, crowd funding etc and that this is one of the issues being taken forward by the Taskforce.
