A45/A46 TOLLBAR END IMPROVEMENT SCHEME

I am writing to confirm that we have now completed our search for the information, which you requested on 18 July 2014.

- 1) The Highways Agency have received 176 recorded complaints made by private individuals and businesses in relation to works and delays caused by the road works at Siskin Drive, Rowley Road and Toll Bar Island, Coventry from the date that work commenced by Galliford Try to 18 July 2014.
- 2) I have attached a copy of a table of that shows the number of road traffic collisions from 2008 to 2012 for the A45/A46 Tollbar Scheme. Unfortunately, we are not in a position to provide any additional data as this hasn't been made available to us yet. The data is released by the Government when it has been validated. The 2013 data should be available in late summer or early autumn and can be found at the web address below.

- 3) We have no record of any recommendations or concerns raised with the Highways Agency by any Police Authority in relation to the Toll bar Island Roadworks in Coventry.

The combination of through traffic and local traffic within the study area contributes to a poor safety record. The trend in the proportion of Fatal and Serious Injury collisions has been upwards from around 13% in 2005 to 18% in 2010. The proportion has fluctuated since 2010; 31% in 2011 and back down to 12% in 2012.
