**Introduction, Minutes & Actions**

1. CG opened the meeting noting apologies. CG advised the meeting that Rebecca Robert-Hughes had recently been appointed to the role of Senior Policy Manager at the Airport Operators Association (AOA) and that Clare Maltby would be replacing Michael Jampel at DECC. CG agreed to circulate Rebecca's contact details. The agenda was agreed and two AOBs were noted for discussion at the end of business.

**Action 38: CG to circulate Rebecca Robert Hughes contact details.**

2. The draft minutes from the 18 July AMB were approved subject to one amendment. CG ran through the outstanding actions. Actions 33 and 37 were discussed as substantive agenda items.

## **Aviation Plan Progress Report**

3. CG gave an overview of the dashboard report. The main highlights were the de-risking of the ATC technical demonstration as the project moves closer to publication. It was agreed that the workstream should be re-scoped to reflect the outcomes of the final report. CG also noted that Matt Clear is considering re-scoping the work of the Offshore Aviation Operations Group. The CAA is leading a review of offshore operations and KL agreed to investigate and report back to the AMB. CG agreed to reconsider Project RM RAG ratings.

### **Action 39: KL to consider linkages between OAOG and the CAA review of offshore operations.**

4. SH gave an update on the AIFCL's decision to co-fund the 'Stage 1' research in partnership with DECC, MOD and the Scottish Government. DBo provided an update on the policy review and reported the outcome of the 16 August meeting of the Eskdalemuir Working Group. DBo noted that all live planning inquiries were now sisted pending the outcome of the 'Stage 1' research. DBo also noted that both he and Tim French would be present at the RUK conference.

## **Safeguarding**

5. DBo confirmed that his team is now sufficiently resourced to re-introduce a pre-planning service within the next few weeks. MOD will disseminate this news to stakeholders. DBo agreed to provide usage statistics at future AMB meetings. Discussions between MOD, CAA and RUK had taken place to consider options for an online pre-application tool. It was agreed, that although a tool would be useful, it probably could not be delivered as it would be too resource intensive. KL noted that CAAI is looking at a small scale 'generic' tool but that there would be a cost to the user. DJ advised that commercial companies are already operating systems and that services could be improved through better access to data.
6. Concerns were voiced around security and maintaining the accuracy of operational data. No assessment has been made of the potential demand for such a system, although there is a presumption that it could reduce the administrative burden on MOD. MB reminded the Board of the DCLG Permitted Development tool and CG took an action to circulate a link to the tool.

## **NATS Update**

7. MB advised the Board that funding package to enable Project RM is expected to be agreed by the end of November. NATS expect to complete contracts with funders by the close of 2013 calendar year and commence project roll-out during fiscal quarter 1 2014, with completion during fiscal quarter 4 2014. NATS

and its partners are working to develop a fair and equitable charging scheme for downstream developers. Development contract discussions with Raytheon will open in November with the ambition to deliver the first radar upgrade within 15 months. NATS are unable to guarantee which radar will be upgraded first.

### **NATS Technical Review**

8. NATS airport customers (particularly in Ireland and Scotland) have asked NATS to assess the pitches provided by technology providers. In response, NATS have held discussions with a broad range of technology providers and has treated the exercise as a pre-cursor to a procurement or tender process. NATS is now sharing its findings with airport customers. En-route radar is more complicated than airport surveillance and the parameters of this work do not offer solutions for those projects that cannot be mitigated through Project RM. However, this may change as safety cases develop. MB agreed to share NATS findings with the CAA.

### **Voice Communications Research**

9. KL provided an update on the progress being made by NATS with its project to assess the impacts of wind turbines on cabin voice communications systems. 22 sites, mostly comprising single onshore turbines but also one offshore site, have been identified. Field trials have commenced, however, some slippage has occurred to ensure the maximum effectiveness of the trial. The project is still on track to complete in 2015 as planned.

### **Guidance on the Use and Integration of In-fill Radar for Wind Turbine Mitigation**

10. DJ was invited to attend the AMB to lead this item and opened by recapping the history of the document and the rationale for its development. DJ noted that NATS had expressed concerns that its comments were not fully reflected. The Board discussed the relationship of the document to CAP 764 and the disclaimers needed in the guidance to prevent any confusion between the two documents. KL offered to take an action to draft a form of words. The AMB agreed that, subject to a satisfactory form of words being agreed, the guidance document could be published on the GOV.UK AMB webpage.

**Action 44: KL to draft text for inclusion in the guidance.**

### **Evidence gathering**

11. It was agreed that RUK's 2013 evidence survey had been overly complex and this had impacted on the quality of data received. GG confirmed RUK's commitment to continuing with the survey but sought to co-operate with others to improve the process. SH thought that this was something the FMB could

support and the Board discussed whether a specialist consultant could be contracted to design the survey structure and develop a model that could be used from year to year. The benefit of this approach would be to give the AMB a management tool to identify trends or develop forecasts that could focus activity or resource prioritisation. GG took an action to determine the cost of consultancy services.

**Action 45: GG to develop a proposal for consultancy services to develop the 2014 survey.**

### **Any Other Business**

12. CG raised a proposal for a South West Scotland Aviation Group on behalf of Simon Coote. The AMB was concerned that a new group could duplicate existing work but concluded that a workstream along the lines of Eskdalemuir could consider issues specific to South West Scotland. The AMB also agreed that SC should present to a future meeting to explain the terms of reference for the group.

**Action 46: Simon Coote to present on the proposed terms of reference for the South West Scotland Group**

### **Guidance/CAP764**

13. The CAA consultation on amendments to CAP 764 has now closed. The consultation generated a large number of responses and these are being considered and will be discussed with the windfarm working group. CAP 764 will be updated and published by the end of December 2013.

### **Next Meeting/Dates of Future Meeting**

14. The next meeting will be held on 23 January 2014 at RWE's offices at 130 Wood Street, London EC2V 6DL.
15. The AMB will also meet on 24 April, 24 July and 23 October 2014.
