Health Inspection Initiative - One in six sites failed

Following the notification in last months briefing regarding the planned two-week blitz, a total of 560 construction sites were visited by HSE Inspectors. Of those sites 13 jobs had conditions so bad that work had to be stopped immediately, enforcement notices were also served on a further 85 sites and 107 Improvement Notices were also issued. A total of 239 health-related Notices of Contravention were served at 201 of the sites.

Inspectors concentrated on significant health risk issues, such as respiratory risks from dusts containing silica materials, exposure to other hazardous substances such as cement and lead paint, manual handling, noise and vibration.

HSE's Chief Inspector, Heather Bryant, said: "We recognise the construction sector's progress in reducing the number of people killed and injured by its activities. "But it is clear from these figures that there is an unacceptable toll of ill-health and fatal disease in the industry. "So, to encourage the industry to treat health issues in the same way as safety, HSE's inspectors will consolidate the efforts of this initiative throughout the rest of the year by looking at the prevention and control of health risks in construction, alongside their continued assessment of the management of safety risk issues. "We will make sure the construction industry 'Thinks health' as well as safety."

Safety failings at M25 construction site led to worker's death

A Slough construction firm and a bulldozer operator have been sentenced for serious safety failings after a worker was run over and killed while working on the Highways Agency's M25 widening project.

The construction firm J McArdle Contracts Ltd, now in liquidation, was handed a fine of $\pounds 2,000$ after being found guilty of breaching Section 3 (1) of the Health and Safety at Work etc Act 1974. The judge commented on sentencing that if the company had still been trading the fine would have been $\pounds 200,000$.

The bulldozer operator was also found guilty of breaching Regulation 37(3) (a) of the Construction (Design and Management) Regulations 2007. He was given a six month prison sentence, suspended for 12 months, and ordered to pay costs of £2,500 Full details can be found here

Consultation

The HSE are currently seeking views on the clarity of the proposed definitions relied upon in the draft regulations, 'The Health and Safety at Work etc Act 1974 (General duties of Self-Employed Persons) (Prescribed Undertakings) Regulations 2015' (date tbc). The proposed regulations include definitions of activities where selfemployed persons will continue to have duties under section 3(2) of the Health and Safety at Work etc Act 1974, all others being exempt from the duty. The change to section 3(2) to exempt certain self-employed persons from health and safety law is derived from a recommendation made by Professor Löfstedt in his report 'Reclaiming health and safety for all: an independent review of health and safety legislation.' M1 J28-31 safety stand down

Costain held a safety stand down day on 12 May, to provide a high impact safety message focusing on a theme of behavioural safety, to the entire 350 strong site team included representatives from the Highways Agency, designers Mouchel, supply chain partners as well as direct operatives, supervisors and engineers.

The day started with a series of

presentations from the Project Management team including feedback on the recent climate survey and information about current safety trends on the site. Costain's CBS team also presented some examples of how the behavioural approach to safety works including examples of some recent successes on the M1.

The event continued with a fictional scenario played out by actors illustrating the potential impact that a serious safety failure could have on the M1 Project – in this case an unqualified driver hitting an operative whilst driving an overladen dumper. The actors (in character) also faced questions and challenges from the floor, with some heated exchanges ensuing. The fictional scenario concluded with a courtroom scene featuring Gerard Forlin QC, a specialist Health and Safety barrister, who then went on to talk about current trends emerging from recent cases.

There was a sobering conclusion to the day as Paul Blanchard, a

construction worker paralysed from the chest down following a fall from height in 2010 spoke of his personal story and brought home the human cost that an accident at work can have.

Arun Sahni, the HA's representative on the project said "It's great to see Costain taking the initiative to promote behavioural safety on this scheme. The level of commitment and investment in the day has sent a clear message to everyone involved in the project that safety is our top priority"
